A Regular Meeting of the Highland Park Mayor and Council was held in Borough Hall, 221 South 5th Avenue, on Tuesday, December 19, 2017 and was called to order by Mayor Brill Mittler at 7:15 PM. Mayor Brill Mittler read the Open Public Meetings Statement.

Absent: None.

Mayor Brill Mittler read proclamations for retiring Library Board of Trustee Members Marc Mappen and Carl Wilson. She presented them with embossed copies of the proclamation.

Mayor Brill Mittler asked the Council members to present their reports.

Councilwoman Kim-Chohan reported that the Arts Commission has commissioned a Band Aid Sculpture bench for next year. They also voted last Thursday on a new member of the Commission and she welcomed Chris Young to the Commission. They are moving ahead with plans to collaborate with the New Brunswick Arts Council on the Windows of Understanding seen through hate window art projects with a municipal launch of January 15, 2018. They have been developing a digital art walk for the website and for mobile use so that residents can find out more information about the art walk in the windows of the businesses via their mobile devices or online from home. They are still in the planning stages of their series pop art panelists from famous pop artists from Highland Park. They are developing more workshops for all ages, including preschoolers, for 2018. The Youth Basketball teams have been practicing and games begin January 7th. All adult recreation programs begin in January. The theater performance is set for next month, Legally Blonde Jr. The engineering, art and chess classes begin next month and the winter indoor soccer program will run in January and February. The Community Holiday dinner will take place December 25th from 1:00 p.m. to 3:00 p.m. and all our invited. She thanked Pithari for hosting the seniors on December 11th for their annual holiday luncheon. She encouraged everyone to stop by the center or visit the website to see all the programs and activities they have scheduled for 2018. She mentioned that last night she and her husband got to attend Make Me Take Me Trial Pottery Class. She encouraged everyone to stop in and give it a try. She wished everyone Happy Holidays.

Councilman George reported that the Shade Tree Advisory Committee, the Environmental Commission and Sustainable Highland Park have submitted their budgets and have held them solidly. He had a long term meeting with the Department of Public Works last week and he asked them to look out 1, 2 and 3 years as to their needs. They also identified some services that the Borough can scale down and try and restrict the budget quite significantly.

Councilman Hersh reported that the Human Relations Commission held its first book club on December 7th at the Senior/Youth Center. There were about 10 residents, most of whom did not know each other, participating in a weighty discussion about race, racial identity and how we participate in racial stereotypes. The book they read was "Everything I Never Told You" by Celeste Ng. There was food and good discussion. On Sunday, February 11th at 1:30 p.m. at the Highland Park Public Library, Sonia Panigrahy will read her book, Nina the Neighborhood Ninja. He encouraged residents to join the Human Relations Commission on January 15th at 7:00 p.m. at the Highland Park High School for their annual Dr. Martin Luther King, Jr. Humanitarian Awards Program. This year's Humanitarian Award recipient is Harry Pangemann, an immigrant rights advocate and the minister of Facilities and Disaster Relief for Churches Accomplishing Long-term Recovery. The program will include entertainment by professional dancers, steppers, poets and more. Refreshments will follow the program and he encouraged residents to come and break bread with their neighbors as they celebrate the town's deep humanitarian spirt and tradition. The Human Relations Commission will meet tomorrow, December 20th at 7:00 p.m. HP Gives a Hoot will provide a lunch program at the Senior/Youth Center on Tuesday, December 26th through Friday, December 29th for all Highland Park school-aged children, K through 12. Lunch will be provided between 11:30 a.m. until 2:00 p.m. each day. No vouchers are need during Winter Break, but participants are asked to complete a short survey that can be found at www.hpboro.com and on the Facebook page, handle: www.facebook.com/hpgivesahoot. Yesterday, as Liaison to the Highland Park Housing Authority and the Highland Park Affordable Housing Corporation, he participated in a meeting that examined affordable housing strategies for New Brunswick and the region. The discussion was led by a great group of student-researchers from the Bloustein School at Rutgers. They discussed Healthy Housing, Homeownership, Vacant/Abandoned Properties, and Tenant-Landlord concerns. The Borough's Commission on Immigrant and Refugee Affairs met on December 13th and discussed 2018 goals, further development of the municipal ID program and the creation of a non-profit social services organization. He announced that the Commissioners unanimously elected Isabel Ruano and John Adler as Commission Chair and Vice Chair. The Highland Park Municipal ID officially launched on October 31st. He encouraged residents to obtain their ID and noted that applicants must be at least 14 years old and a resident of the Borough, and they must show proof of identity and residency. Office hours for applications are Tuesdays from 3:00 p.m. -5:30 p.m. and Thursdays from 8:00 a.m. - 11:00 a.m. Additional details and the application are available at www.hpboro.com. He noted that Dan Stern Cardinale will be appointed as an alternate to the Board of Health. Dan is civic-minded and cares greatly about public health policy in the Borough. Finally, it's the season for giving. He asked residents to support the Highland Park Community Food Pantry. Checks can be made payable to the Borough of Highland Park with "Food Pantry" indicated in the memo field. Donations can be mailed or dropped off to the Senior/Youth Center, c/o Highland Park Food Pantry, 220 South 6th Avenue, Highland Park, NJ 08904.

Councilwoman Foster-Dublin reported that the slab was poured a couple of weeks ago for the teen center. They are now in the 2^{nd} phase where they will put the electrical in and once that goes in, weather

permitting, they will work on plumbing. In the next few weeks you should be seeing a structure. She will post updates on the Facebook page and provide updates at future Council meetings. She reminded everyone to please clean snow off sidewalks after a snowfall. She encouraged the businesses on Raritan Avenue and Woodbridge Avenue to make sure that patrons have safe access to their businesses after a snowfall. She encouraged everyone to be safe during the holiday season as Police Departments across the State of New Jersey will be enforcing the "Stay Sober or Get Pulled Over" program. Lastly, she reported that there is a deer problem in town and the Borough is working hard and looking to see what they can do to solve or find a solution. She also reported on some fox sightings in town and urged residents to contact the Police Department should they see one. She wished everyone Happy Holidays.

Councilman Fine reported that over a year ago this Council adopted a Municipal ID Card ordinance and this year the program was finally implemented. Residents should be thankful for the work of Councilman Hersh for making this program come to fruition. He himself obtained a municipal ID card that also doubles as a library card. He urged all residents to come to Borough Hall and get an ID. Throughout the year, the Library Board of Trustees meets on the last Monday of each month. Due to the holidays, they met last night and made note of the dedicated volunteer service of two Highland Park residents, Carl Wilson and Marc Mappen. Mr. Wilson served on the Board for 16 years and Mr. Mappen served for over 20 years. Mr. Mappen served as Board President from 2011 until 2015 and was instrumental in creating the library's strategic plan for 2012-2015. The Borough owes a debt of gratitude to Mr. Wilson and Mr. Mappen for their service. On Thursday, December 21st he will be meeting with the Mayor, the Borough Administrator and former Mayor Steve Nolan, who has been serving as the Chair of the Borough's Shared Service Commission. The purpose of the Shared Services Commission is to make recommendations to the Mayor and Borough Council regarding potential revenue and savings opportunities for Highland Park to pursue. Chairman Nolan will share the Commission's recommendations for their consideration. He wished all Highland Park Residents Happy Holidays.

Councilwoman Welkovits thanked Marc Mappen and Carl Wilson on their dedication to the Library Board and to the community. She had the pleasure of serving with both of them for about four years and she wished them the best. She thanked Main Street, Mike Beiberman and Rabbi Green for another wonderful menorah lighting event last weekend. Special thanks to Chris Young and Arnie Weinberg for organizing the very popular Central Jersey Pop Up Flea Markets that were enjoyed this holiday shopping season. She thanked Main Street, the vendors, the food trucks, the local merchants and all the shoppers who keep our downtown lively and successful. She thanked the merchants for decorating their beautiful windows. She encouraged residents to join in the Kwanzaa celebration on December 26th, hosted by Kinetics. Lastly, on this last night of Hanukah she hoped that candles burn bright all year long. She wished everyone a Merry Christmas, Happy Kwanzaa, Feliz Navidad and a Happy and Healthy New Year.

Borough Administrator Jover reported that the New Jersey Department of Transportation has approved Highland Park for local design assistance for the Safe Routes to School Program. Highland Park was awarded a grant in 2016 to improve pedestrian accesses to the schools. This will save the borough money in designing the ramps and doing sidewalk improvements.

Borough Attorney Schmierer - No report.

Mayor Brill Mittler reported that next week Winter Time Stretch Yoga with the Mayor will begin at Kinetics. Information can be found on the Facebook page. They are working on schedule now. The Borough received notification from an organization called Zippia, which is an online research firm, that Highland Park was ranked #7 in terms of smartest towns in New Jersey. The Park Partners program has been underway and have received 12 submissions. The voting session will be held on February 25th. Last year hundreds of residents participated in voting for their favorite ideas in five categories. Councilman Hersh mentioned that HP Gives a Hoot will run a lunch program during the winter break. There is still time to donate to this group.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

No one appearing to be heard, the Mayor closed the public discussion.
