A Regular Meeting of the Highland Park Mayor and Council was held in Borough Hall, 221 South 5th Avenue, on Tuesday, February 7, 2017 and was called to order by Mayor Brill Mittler at 7:02 PM. Mayor Brill Mittler read the Open Public Meetings Statement.

Present: Mayor Brill Mittler; Councilpersons Fine, Foster-Dublin, George, Hersh, Walsh,

Welkovits; Borough Attorney Schmierer; Borough Administrator Kovach; Borough Clerk

Absent: None.

Mayor Brill Mittler noted that it is a pleasure to honor one of Highland Park's treasured jewels. She read proclamation honoring Diane Feldman for her service to the Borough as the Chairperson of the Commission for Universal Access. She noted that when she joined the Council in 2009, one of her first areas of responsibility was the Commission for Universal Access. She presented Ms. Feldman with a signed copy of the proclamation. Ms. Feldman thanked the Mayor and Council for this honor. She also thanked all the Commission for Universal Access members for their support. She thanked the Council

Liaisons she has worked with over the years and the Police Department for their assistance. She noted that it was a pleasure being the Chairperson and she looks forward to working with the Commission as a Regular Member.

On motion made by Councilwoman Welkovits and seconded by Councilman George, the minutes of the Regular and Conference Meetings held December 6, 2016 and December 20, 2016 were approved by affirmative voice vote of all Councilpersons present.

Mayor Brill Mittler asked the Council members to present their reports.

Councilwoman Foster-Dublin – No report.

Councilman Fine reported that the CDBG Committee held their public hearing and has recommended the following amounts be approved: Main Street Highland Park – Façade Improvement Program - \$5,000.00; Dept. of Recreation & Arts: Senior Transportation - \$6,636.00; Dept. of Recreation & Arts: Senior Medical Transportation - \$6,636.00; Dept. of Recreation & Arts: Summer Camp Program - \$9,765.00; Dept. of Recreation & Arts: Teen Youth Programming/Outreach - \$7,765.00; HP Gives a Hoot – Summer Camp Scholarships - \$4,000.00; Teen Center - \$7,000.00; and Food Pantry - \$2,000.00, for a total of \$58,567.00. Council will be voting on the adoption of a resolution approving these amounts.

Councilman Walsh reported that Sustainable Highland Park has entered the solar challenge to get residents and businesses to go solar. They are competing with other municipalities in the state to get more installations than they have. Solar prices are at record lows and the technology is increasing significantly. That means that if you were unable to afford solar or were told your home was not appropriate for solar, even two years ago, you might find that solar power is within your reach. They have set up hpsolar.org to allow residents and businesses to apply for free quotes for solar installation from pre-qualified companies and shows you how much you can save on your energy bills. They held a wellattended information session at the Library on January 10th where residents were able to learn more about the program and get questions answered. Sustainable Highland Park, at the request of Councilman Hersh, is providing assistance to the Housing Authority, which is interested in exploring solar on its properties. Highland Park is also exploring solar on borough buildings, including the senior center, which is in need of a new roof. They are planning on a further education campaign about the program with things like lawn signs, posters to put up in key locations, and handouts for events like the street fair, earth day and arts in the park. Folks can learn more and apply for an application at hpsolar.org. They are going to work to make the Sustainable Highland Park recertification an annual process, rather than every few years. They will hold a kick off meeting on February 16th at 7PM. At that meeting they plan to celebrate/report on 2016 silver certification, allow partner groups to talk about the actions they worked on and what they think they can do moving forward. They will also have time for break-out discussions and cross-collaboration. One of the barriers to people purchasing electric vehicles is fear about running out of a charge. By adding to the network of stations, Highland Park will be helping address this issue. There are grants from NJDEP and Sustainable Jersey to support the installation of electric charging stations in communities throughout the State. Sustainable Highland Park is looking into our ability to get funding for a charging station and researching appropriate locations in the Borough for such a station. The Recycle Coach app, which Councilwoman Welkovits worked hard to bring to fruition, is almost ready and should be available to residents by the end of February. They just need to finish compiling data for the app, and merge it with the app database. This important tool will send residents reminders on things like trash pickup, recycling and bulk collection days. Highland Park will be celebrating Earth Day on Sunday, April 23rd from 11AM until 3PM at the Environmental Education Center. Save the date and stay tuned for more information about groups and organizations who will be participating to make this celebration a tremendous success. For 180 years, before Highland Park High School was even built, two magnificent oak trees have shaded the front lawn. They have watched over every school day and graduation. Every memory of the high school was formed in the shade of these two trees. Sadly, they were diseased and began to pose a threat to public safety. As many people are aware, they were cut down on December 27th. The school as commissioned several works of art to be made from this sustainably repurposed wood. Even in death, these trees will continue to be part of the school. Nature's Fell is offering beautiful products hand crafted from the wood of these magnificent trees. By making a donation, you can receive a piece of art created from this part of Highland Park's long legacy of sustainability. Due to the need to dry and cure the wood properly, your orders will take about one year to be ready for pickup at Highland Park High School. Contact Scott Alexander at Nature's Fell (732-624-9011) or go to https://naturesfell.com to arrange for a custom order. Nature's Fell of Middlesex, New Jersey is a small tree salvage and woodcraft company borne of Hurricane Sandy. Rutgers is spearheading a bike share program called Knight Share. This program will have bikes stationed throughout New Brunswick,

Highland Park, Piscataway, Edison and other communities. Anyone will be able to check out a bike from a knight share station, ride it to another station, and pay a fee for the rental. They are planning to have informational sessions in March in Highland Park and will soon be circulating a survey to help Rutgers submit grants to help finance the project. The survey and the session will help us determine the best places for these stations in Highland Park.

Councilman George reported that the Highland Park Arts Commission is busy and held their first meeting on January 12th. They drafted a grant application to the County of Middlesex for the Donaldson Park Sculpture Project. They are hoping to put a sculpture on Raritan Avenue near Rite Aid on South 4th Avenue. He also noted that the basketball program is in mid-season and the participation is the largest yet. Packets for registration for spring sports will be out next week along with information for the summer camps.

Councilman Hersh reported that there is a food pantry distribution Thursday, February 9th from 9 a.m. to 10:45 a.m. The Food Pantry is open to anyone who lives or works in Highland Park and who needs food assistance. For additional information, please contact Nicole Huff at 732-819-0052. Mike from Public Works brought a book of paint colors on Wednesday for the Food Pantry to select from. Painting will be done according to Public Works' schedule. The Food Pantry received a \$2,000 CDBG grant and that there is a credit of \$500 from last year's grant. The Commission for Universal Access met on February 2nd and they have \$12,000 in revenue collected from handicapped parking violations. Commissioner Diane Feldman is seeking additional grant opportunities by attending a workshop hosted by the Cultural Access Network Project, which is an initiative of the New Jersey Theater Alliance, which works to make live theatre accessible to everyone and serving as a cultural access resource for the state's theatres and cultural community. Kim McGraw at the senior center is working with Mobility Works and we will be going out to bid for a new senior van in the next few weeks. The Highland Park Housing Authority will hold its next meeting on February 8th at 6:30 p.m. at the Samuel Kronman Building. The Board is currently in the midst of transitioning to a Rental Assistance Demonstration, where the Housing Authority would enter into a multi-year agreement with an investor in order to access capital for necessary capital funding. HUD no longer provides capital funding for public housing facilities. The stewardship of the property would remain public and the housing is still public. This affects the asset only. The Housing Authority is in talks with Sustainable Highland Park to see if solar panels can be installed on the roof of the Kronman apartments through the Borough's solar program. Last week, he met with Dianne Roman from the Office of Housing and Social Services in Perth Amboy. Her department issues their city's municipal ID program. She showed him the equipment they use and their marketing materials and it was very useful to hear about their program's implementation and how they interact with their business, immigrant, youth and senior communities. He's been working with Shayne SantaLucia, the Information Technology Coordinator, on familiarizing ourselves with the equipment. They are hoping for a "soft launch" by the end of the month, where municipal officials and employees will receive the card. The program will be open to the entire community this spring. The Board of Health met with Freeholder Narra with Dan Bianchini to discuss possibilities about mosquito and awareness initiatives. On January 31st, he and Mayor Brill Mittler attended a forum hosted by Congressman Frank Pallone that provided a discussion about the many concerns communities are feeling about Trump's recent executive actions. Also in attendance were representatives of the Reformed Church of Highland Park, Latino Action Network, NJ Working Families Alliance, PRAB, Manavi, SEIU, Citizen Action, NJ Catholic Conference, CAIF, Lutheran Episcopal Advocacy Ministry of NJ, Catholic Charities Diocese of Metuchen, Unitarian Universalist Legislative Ministry of NJ, New Labor, Immigration Voice, and the Piscataway Board of Education. On Saturday, February 4th, he and Councilwoman Foster-Dublin attended the first ever Pan African Flag Raising at the County Administration building in New Brunswick in recognition of Black History Month. The event was hosted by the Middlesex County Young Democrats Black Caucus and the Board of Chosen Freeholders. He congratulated the honorees: Freeholder Kenneth Armwood, Sheriff Mildred Scott, Matthew Vaughn, Reginald Johnson and the Rev. Dr. Ronald Owens. It's not every day you get to hear such inspiring speakers. The Middlesex County Chapter of the Brady Campaign held a gun safety and awareness event last night at the Senior Center. He thanked Chief Rizco and Detective McGraw for answering questions and providing advice. They discussed legislation, the overall political climate, and how we can take action as a community, particularly related to information for parents of young children on how to ask other parents about the presence of guns when making play dates. He thanked Karen Kanter for facilitating the meeting.

Councilwoman Welkovits reported that when she first joined council she chaired the Health and Human Services committee and worked very closely with Diane Feldman for 3 years and it was a great pleasure. She thanked Diane for her intelligence and commitment to Highland Park and for educating the community about accessibility for all. She commented that she is proud to see so many people in the audience tonight for the important issues that will be heard tonight. The Zoning Board has approved plans for a new learning center for Chinese students to open at 168 Woodbridge Avenue. The learning center will tutor Chinese speaking students in the area. The business owner currently runs a successful learning center in Metuchen and seeks to expand. The Borough is eager to see new thriving businesses open on Woodbridge Avenue. The Redevelopment Agency has been working diligently and tonight there will be a first reading on an ordinance to move ahead with the expansion of the building of the International Market on Raritan Avenue near 2nd Avenue. The proposal will expand with new office space below and additional apartments for rent upstairs. Tonight the Council will approve a main street façade and awning improvement contract. Main Street continues to offer grants of up to \$3,000 to new businesses for façade improvements, improving the look and feel of the downtown for the residents, shoppers and business owners. Main Street was recently awarded an additional \$5,000 from Community Development Block Grant funds to continue this program in future years. Spring is around the corner and residents should save the date, Sunday, May 7, for the 9th annual 5K race and also the Street Fair. There is no Planning Board meeting in February, but they will resume work in March. Lastly, the Council will be passing a resolution in support of the public schools to stop the expansion of charter schools.

Borough Attorney Schmierer - No report.

Mayor Brill Mittler commented that she is happy to see many residents in attendance tonight. She hopes to see them more than just one night as it is important to hear from residents. The Park Partners Program voting session will be held on February 12th at 4PM at the senior center. This is a give back program where residents submit grant proposals to help make Highland Park a better place to live. Residents get to vote for the top 5 projects in 5 categories. They had more grant submissions this year than ever before. She was honored to sit in on roundtable discussion in Perth Amboy with Congressman Pallone and Mayor Diaz where they discussed the many concerns communities are feeling regarding the President's executive orders. Last week, the Police Chief and two of his officers had an opportunity to meet with Pastor Kaper-Dale and some residents to talk about the refugee situation as it currently exists. Highland Park has passed an ordinance to get an ID program in place. Councilman Hersh will be chairing an immigration and refugee task force. The Borough will be discussing the adoption of a resolution about this matter in the near future.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

Diane Feldman, 409 No. 4th Avenue, commented that she is excited about the Park Partners Program and reminded the Governing Body to make sure there are enough voting forms.

Herb Gross, Adelaide Gardens, asked who was in charge of the buttons on Raritan Avenue that allow pedestrians to cross. He was specifically asking about the one by St. Paul's church. The button has not been working for about a month. The button on 1st Avenue is not functioning correctly either. Mayor Brill Mittler thanked him for reporting that information. The buttons belong to traffic lights which are maintained by the NJDOT. The Policed Department will get in touch with NJDOT in Trenton to report the problem. Chief Rizco asked that in the future that he should report the problem directly to the Police Department. Mr. Gross commented that New Brunswick has voice activated traffic features at George Street and Albany Street and Highland Park should look into getting some. Mayor Brill Mittler will add that to the list of items that they will discuss with NJDOT. She will ask Councilwoman Foster-Dublin to speak to that. Councilwoman Foster-Dublin noted that they have been meeting and are looking into traffic safety/street calming devices and they will keep him apprised of their progress.

Mr. Jimenez, Hillsborough, commented that his parents brought him here when he was 9 years old to live a better life. They never finished elementary school and grew up with dirt floors. They brought him over here and that he got the amazing education that this country has feels like he won the lotter and means a lot. He is 28 years old and has been volunteering with community organizations and he was featured on a Cheerios box for helping raise over \$1,000,000 to fight hunger. He loves helping the community, because the community helped him back. When he went to school everybody embraced him and helped him out. He quoted words on lady liberty; "give me your tired, your poor, your huddled masses yearning to breathe free". Making Highland Park a sanctuary town will double down on that message. They might not have lady liberty a block away, but these words need to be echoed in our country, in every town and every city. If they push with hate, we will push with love back. He offered his assistance to make this work.

Rev. Seth Kaper-Dale, Reformed Church of Highland Park, commented that he wanted to speak some words about sanctuary and encourage the Council to take it seriously. In May of 2006, he received an early morning phone call from a man named Harry who at the time was living in Avenel, NJ. He was hiding under the bed with his pregnant wife and ICE was surrounding their apartment complex. By the time he arrived at that apartment complex, 35 dads had been taken out of their apartments and taken to the Middlesex County jail where they spent a month and all 35 were deported. 60 children lost their parents in that one raid that was connected to Operation Return to Sender. That was President Bush's attempt to show a strong hand while he was trying to push through a loose, light immigration policy. What we have experienced since January 25th with Executive Order "Securing the Interior" is like Operation Return to Sender on steroids. It is not about showing a little muscle; it is about eradicating this country. 3 million people is the President's goal of the 11 million who are the lowest hanging fruit. This is not about going for criminals; it is about going for the good people in our communities who are in this country without proper papers due to the insistence by our Washington politicians to not actually come up with meaningful immigration reform. This town is and has always been a welcoming and beautiful town. It is encouraging to listen to the reports given by Council of all the things that are being done in town. We need a town that defends its people against our own government because our own government is not behaving for the will of the people anymore. We have someone in power who is saying loud and clear that he wants to hurt our community. He was impressed with Mayor Steven Fulop's take on Sanctuary in his executive order this past week. A creative town like Highland Park can become a leader in what that looks like. Appreciates the time Councilman Hersh has taken to meet with him about when a faith community provides sanctuary, similar to when Harry spent 11 months inside the Reformed Church building, and the town allowed them to do that. To get to the place where we as a town say that congregations of all faiths want to offer physical sanctuary, not only is it acceptable, but it is something that they stand for with them. That is the kind of thing that will let this President know that towns are on the side of those that are stuck in this mess. He thanked the Mayor and Council for taking this seriously. He is proud of Highland Park and the direction they are going in.

No one else appearing to be heard, the Mayor closed the public discussion.

Mayor Brill Mittler explained the program and that it was started 3 years ago.

No one else appearing to be heard, the Mayor closed public discussion.

There being no further business, on motion made by Councilwoman Welkovits, seconded by Councilman George, and carried by affirmative voice vote of all Councilpersons present, the meeting adjourned at 8:13 PM.
