Councilwoman Foster-Dublin left the meeting at 7:35 PM.

Mayor Brill Mittler asked the Council members to present their reports.

Councilman Fine - No report.

Councilman George reported that the sculpture project is moving forward.

Councilman Hersh reported that the Highland Park Housing Authority will meet tomorrow and they have found an investor for the 24 family units on South 6<sup>th</sup> Avenue to help with essential capital needs. They no longer get that type of funding from the Department of Housing and Urban Development. HUD encourages public Housing Authorities to work with outside investors to do necessary capital improvements. They have partnered with the Community Loan Fund of NJ, New Brunswick, New Jersey. They believe in the mission of providing safe, decent, affordable housing. The stewardship of the housing is still public, and still under the management of the Housing Authority. It is not an ideal situation, but they are thrilled to have partnered with this group that does meaningful neighborhood stabilization work around the state.

Councilwoman Welkovits reported that the new Safe Walking and Cycling Committee meets the first Wednesday of every month at 7PM in Borough Hall and will be meeting tomorrow. They will be discussing their partnership with Rutgers in a bicycle share program. They were awarded a \$1.1 million dollar grant from the NJ Department of Transportation and Jack Molinar, Rutgers Transportation, is very eager to have entire program in place by Spring of next year. The bike share program will include 350 bicycles and about 35 different hubs (bike racks). The neat thing about the program is that each bicycle will have a GPS built into it. You can drop a bicycle off anywhere you want as it has a built in lock. You might pay a little bit more if the bike is not returned to a hub. You can use a smartphone app to locate the nearest bicycle and a credit card swipe to pay. With the GPS on the bicycles, the Borough will be able to get some data as to where people are riding around town and use that to create some bicycle lanes. Working on this project for two years. Rutgers is working with the Borough to determine where to put them and they will hold some open public meetings in Highland Park to get resident input. They will also hold meetings at the Edison train station and in Piscataway to form a network. Tomorrow at 6PM two of Main Street's committees will meet, Organization and Promotions. They will be discussing the music on

the corner program which has been extremely successful the last couple of years. Any musicians who want to sign up can contact Main Street.

Borough Administrator Kovach – No report.

Borough Attorney Schmierer - No report.

Mayor Brill Mittler commented that there was a horrendous crime committed a few weeks ago. She thanked the Highland Park Police Department and the Middlesex County Prosecutor's Office for arresting the person in one weeks' time. She asked Lt. Hammill, in attendance at tonight's meeting, to share the thanks of the Governing Body with the members of the Police Department and the Prosecutor's Office. She noted that there was a public safety meeting held on Sunday and representatives from Women Aware gave a presentation about how to report concerns for sexual assault or abuse primarily with an intimate partner. Officer Curbelo shared safety tips. Freeholder Nara was in attendance and there was a nice turnout. They plan to hold additional meetings in the future. There are street signs missing along Vickie White Way and Rosa Parks Way and they have been reordered and will be replaced. This is women's history month and she wants to introduce everyone to historic women in Highland Park who contributed to growth in Highland Park and in the country. She noted that Joan Snyder was born in Highland Park and is a painter and her paintings can be found in museums and collections all across the country. She founded the Mary H. Dana Women Artist Series in 1971, which is the oldest continuous running exhibition space in the United States dedicated to making visible the work of emerging and established contemporary women artists. She is a MacArthur Fellow, a Guggenheim Fellow and a National Endowment of the Arts Fellow.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

Craig Hannoch, 237 Montgomery Street, appeared to read letter to the Governing Body from Rabbi Ronald Schwarzberg, Rabbi Emeritus of Congregation Ahavas Achim, relating to the issue of immigration and refugee policies being discussed by the Governing Body. It was noted that the Governing Body is going to be hosting a forum on immigration and refugee policies on March 14<sup>th</sup> at 7:00 PM.

Herb Gross, Adelaide Gardens, commented that the traffic light button on Raritan Avenue and 5<sup>th</sup> Avenue has been fixed. The Borough Council should pursue voice activated lights for pedestrians and is needed in Highland Park. The Mayor should pursue this with the State. Mayor Brill Mittler noted the Borough is talking to NJDOT about safety features.

No one else appearing to be heard, the Mayor closed the public discussion.
