A Regular Meeting of the Highland Park Mayor and Council was held in Borough Hall, 221 South 5th Avenue, on Wednesday, November 8, 2017 and was called to order by Mayor Brill Mittler at 7:06 PM. Mayor Brill Mittler read the Open Public Meetings Statement.

Present: Mayor Brill Mittler; Councilpersons Fine, Foster-Dublin, George, Hersh, Kim, Welkovits;

Borough Attorney Schmierer; Borough Administrator Jover; Borough Clerk Hullings.

Absent: None.

Pancreatic Cancer Proclamation

Mayor Brill Mittler asked the Council members to present their reports.

Councilwoman Foster-Dublin reported that the Volunteer Fire Department is seeking volunteers. The Fire Department conducted fire safety assemblies in the schools during October for Fire Prevention Month. She encouraged residents to change the batteries in their smoke detectors and carbon monoxide detectors. The Police Department participated in National Prescription Drug Take Back Day on October 28<sup>th</sup> and 29<sup>th</sup>. They collected 63 pounds of surrendered pharmaceuticals for destruction. Residents can take unused medication to Saiff Drugs on Raritan Avenue or to the Edison Police Department. You should not flush unwanted medication. The St. Paul's Knights of Columbus honors a member of the Police, Fire and First Aid Squad as a way of thank first responders. On October 23, 2017, they honored Police Department Sgt. Theodore Haas, Volunteer Fire Department Member Michael Gershen and First Aid Squad Member Robin Loewenstein. They hope to break ground soon for the construction of the teen center with an anticipated completion date of August, 2018. Lastly, she reported that Highland Park had the lowest violent crime rate in the State of New Jersey, ranking 3<sup>rd</sup>.

Councilman Fine - No report.

Councilwoman Kim reported that the Book Art Workshop took place on November 2<sup>nd</sup>. The registration for this event was good, with some being placed on a waiting list. This is the 2<sup>nd</sup> year that the Arts Commission has hosted this workshop. On November 18<sup>th</sup> at 7:30 p.m. at the Senior/Youth Recreation Center there will be a Highland Swing Concert. It is a new Highland Park based jazz ensemble. The annual Thanksgiving Senior Luncheon will be held on November 20<sup>th</sup> at the Senior Center at noon. Kosher meals are available upon request. On Saturday, November 11<sup>th</sup> will be the Veteran's Day Parade beginning at 11:00 a.m. at the doughboy monument. The parade will proceed up Raritan Avenue and conclude in New Brunswick. She thanked all Veteran's for their service.

Councilman George reported that he held his monthly meeting with the Department of Public Works. One of the concerns they had was that due to the warm weather we have had that the leaves will be dropping later this year. It is anticipated that residents will still be cleaning up leaves in December and the Department of Public Works is planning for that. He reminded everyone that the Borough provides recyclable leaf bags for collection, approximately 20 per address, and they are available at the Department of Public Works for pickup. There are bulk trash pickup dates coming up in December. They will also try to do some last minute pothole repairs, however, most of the asphalt plants stop producing the material at this time of year. Sustainable Highland Park met at the end of last month and the bags program is doing well and the signs are appearing in more stores. The Environmental Commission has been working on designing a new website that is a lot more informative. They also discussed creating a lot more linkages to the Borough, Board of Education, and County websites. They are hoping to roll out the new website in December. They will be featuring the photography of local photographers on their website. The Shade Tree Advisory Committee will meet this evening and they are planning for tree planting project for next year. Anyone interested in having a tree planted in the verge in front of their house should fill out a request form. The Shade Tree Advisory Committee is planning on planting 31 trees next year. If you get a newly planted tree, residents are responsible for watering the newly planted tree. The Highland Park trail volunteers continued their work at the meadows. They were able to get some native species to put in the meadows area. They worked last month on the wisteria clean up with some volunteers.

Councilman Hersh reported that the Highland Park Municipal ID program officially launched on October 31st. ID's can be obtained at Borough Hall, and this ID entitles residents to any municipal services in the Borough, such as the Library. Applicants must be at least 14 years of age or older and a resident of the Borough of Highland Park. Applicants must show proof of identity and residency. Details are available on <a href="https://www.hpboro.com">www.hpboro.com</a>. Office hours for applications are Tuesdays, 3:00 p.m. until 5:30 p.m. and Thursdays from 8:30 a.m. until 11:00 a.m. ID cards are valid for 2 years from time of issuance. ID cards are intended to assist in the identification of the valid card holder for the purposes of obtaining services from the Borough of Highland Park and at the discretion of businesses within the Borough of Highland Park. This program will develop over time and they have received commitments and anticipate further cooperation from our stores and Main Street Highland Park. The cost is \$15 for adults, \$7 for seniors, youth and veterans. Applicants can request a hardship waiver with no questions asked. The Board of Health will meet on Thursday, November 9th at 7:00 p.m. The Housing Authority meeting tonight was cancelled due to tonight's Council meeting and has been rescheduled for November 15th at 6:30 p.m. at the Kronman Building at 242 South 6th Avenue. The Human Relations Commission Meeting will be held on November 15th at 7:00 p.m. in the lower level conference room in borough hall. The Commission for Universal Access will meet on Monday, November 20th at 7:30 p.m. in the Berman Conference Room.

Councilwoman Welkovits reported that she is excited that tonight the Governing Body is having the first reading of a new development agreement with Mr. Anton Popov of the International Market on Raritan Avenue and North 2<sup>nd</sup> Avenue. This is the first redevelopment project that has been shepherded through the new area in need of rehabilitation screening committee that was formed in January. They have been working with Mr. Popov during the course of the year and his plan has now been approved by both the Redevelopment Agency and the Planning Board. This creation of the Screening Committee has not only streamlined the process, but they have the ability to ask for more things for the Borough from developers and they are approving final plans that are much more aligned to the kind of redevelopment we truly want and need in Highland Park. The redevelopment agreement, once signed by the redeveloper, binds him into beginning the project within 9 months and completing the build within 2 years. It's been a long time since we've seen a new building on the Avenue and she is confident that this sends the right message out to other developers, that Highland Park is open for business. She thanked the Screening Committee, which is made up of volunteers from the Redevelopment Agency, the Planning Board, the Board of Adjustment and Main Street. Great weather, ghoulish spirits and the need for sweets drew out a record crowd at the Halloween on the Avenue event last week. She thanked Main Street, the volunteers, musicians and all the participating businesses who made it a big success and continued this Highland Park tradition. She reminded residents that the Farmer's Market harvest season is still going strong throughout November and into December. They are open Fridays from 11:00 a.m. until 5:30 p.m. On Saturday, November 11th and Sunday, November 12<sup>th</sup>, from 12:00 p.m. until 6:00 p.m., there will be a Pop-up Flea Market at 431 Raritan Avenue. Pop-up markets are a great way to bring unusual items to residents looking for antiques, vintage, home décor, art work and more. On Friday, November 10th, the Borough's newest business, Chamber 43, located at 320 Raritan Avenue, will host a wine, cheese and snacks gathering courtesy of New Athens Corner. Immediately following this event, there will be a night of music at Pino's beginning at 7:00 p.m. She invited residents to join the National Writing Month organizers on Sunday, November 12th from 8:00 a.m. until 4:00 p.m. for an all-day write-off at Blank Space. Participants can guess the number of words written by the host and he'll write them into his new novel. She thanked Christine Laputka for organizing this great event. On Tuesday, November 14th at 7:00 p.m. she invited residents to enjoy delicious coffee drinks and snacks at OQ Coffee while participating in an important discussion on sustainable solutions to disaster relief organized by Raices Cultural Center. Volunteers are need for Main Street's Winter Interest Planting Day on November 19th. The special annual Small Business Saturday and Tree Lighting will be held on November 25th. She invited residents to join them for holiday shopping at the small businesses in town. Keeping it local is better for tax dollars and to maintain the vibrant downtown. The Menorah Lighting will take place on December 12th and the Kwanzaa Celebration will be held on December 26th.

Borough Administrator Jover noted that the Borough will be submitting an application for the BPU for a Local Government Energy Audit. If the application is accepted, they will provide for free a fairly detailed energy audit of the Borough's buildings in town with the goal towards doing upgrades over time to make the buildings more efficient and save money.

Borough Attorney Schmierer - No report.

Mayor Brill Mittler reported that she met with Assemblywoman Pinkin, Councilman Hersh and members of the Board of Health to talk about the opioid epidemic in New Jersey. Of particular concern to Highland Park, was the effect of this epidemic on the children of those who are addicted. Chief Rizco was also present at the meeting and he informed them about some of the programs already in the works with the Police Department. Last week she held the first Paint with the Mayor event at the senior center. There were 3 tables filled with painters. She is very proud of her painting and it is displayed in her office. They had a great time and she was able to talk with residents about their concerns and everyone left with their own masterpiece. Civics for the Community has put together civics lessons for the residents. The 1st presentation was on State Government. The event was well attended and was worthwhile. The 2nd installment will be "How does Local Government Work" and the speaker will be Marc Pfeiffer, Assistant Director of Bloustein Local Government Research Center. The event will be held on Tuesday, November 28th from 7:00 p.m. to 8:30 p.m. at the Highland Park Senior Center and is open to the public, with light refreshments being served. She encouraged residents to come and learn about local government.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

Kaleigh Wharton, 119 Johnson Street and Emily Berman, 442 South 2<sup>nd</sup> Avenue, appeared and noted that they are part of the Women's Issues Club at the Highland Park High School. They are working on the "Period Project" which is a project to collect feminine hygiene products which are then donated to women's shelters and food pantries. Last year they collected over 300 donations and donated to Women Aware, Catholic Charities, Elijah's Promise, and the Highland Park Food Pantry. They are doing the project again this year and residents can donate through a link on their Facebook page (period project-highland park high school women's issues club). They have a wish list on their page and any of those items can be purchased and donated. There are boxes around town where donations can be dropped off. Local businesses that have the bright pink donation boxes are Saiff Drugs, Unite Pharmacy, the Reformed Church and the center hall at the high school. Suggestion to submit information about the program to Stacy Kaplan in the Communications Department. The project will run until December 31, 2017.

Herb Gross, Adelaide Gardens, thanked Councilwoman Kim for mentioning the Veteran's Day parade. The parade begins at 11:00 a.m. in Highland Park.

No one else appearing to be heard, the Mayor closed the public discussion.
