BOROUGH OF HIGHLAND PARK REGULAR MAYOR & COUNCIL MEETING DECEMBER 6, 2016, - 7:00 PM

A Regular Meeting of the Highland Park Mayor and Council was held in Borough Hall, 221 South 5th Avenue, on Tuesday December 6, 2016 and was called to order by Mayor Brill Mittler at 7:07 PM. Mayor Brill Mittler read the Open Public Meetings Statement.

Mayor Brill Mittler welcomed the Public Safety Staff and all their visitors. She also welcomed Sheriff Millie Scott.

Chief Rizco noted that this is one of two meetings held each year to recognize first responders. He thanked the Mayor and Council for sharing their meeting and he thanked the first responders (Police, Fire, 1st Aid and CERT team) for all that they do. The Borough of Highland Park recently hired three new Police Officers and they recently graduated from the Morris County Police Academy. Two of the candidates hired are from Highland Park and the other candidate is from Piscataway. He noted that the Police Department received 500 applications for the three positions. They narrowed the candidates down to five finalists and then did extensive background check on the three who were chosen, who then went through a medical and psych exam. He looks forward to big things in the future from these three candidates.

Chief Rizco introduced Sade Edens. She is 30 years old and from the Township of Piscataway. She graduated in 2005 from Piscataway Township High School. She attended Old Dominion University, graduating Summa Cum Laude in 2009, earning a Bachelor of Science Degree in Early Childhood Education. She graduated Summa Cum Laude in 2010, earning a Master's of Science Degree in Early Childhood Education. She graduated from the Morris County Police Academy on November 23, 2016 and was ranked 5th in the class. Upon graduation from college, she was employed as an Instructor of Early Care & Education at Old Dominion University before accepting a teacher position in Plainfield Public Schools, where she taught for 4 years. Sade is an active Emergency Medical Technician of 9 years and the former 2nd Lieutenant of the Dunellen Rescue Squad. In her spare time, she enjoys spending time with her family and friends, watching sporting events, and playing co-ed soccer.

Mayor Brill Mittler administered the Oath of Office to Sade Edens.

Chief Rizco introduced Joseph Olarra, Jr. He is 27 years old and from Highland Park. He is a 2007 Highland Park High School graduate. He graduated from the Juvenile Justice Commission Academy in July of 2011. He graduated from the Morris County Police Academy on November 23, 2016. He is a lifelong resident of Highland Park, but most recently resides in Somerset. He is an alumnus of Highland Park High School. In September of 2009, he became a Juvenile Detention Officer at the Middlesex County Juvenile Detention Center in North Brunswick. He is the proud father of a 4-year-old son, Joseph. He is also a second generation police officer, following in the steps of his father, Joseph Olarra, Sr., who recently retired from the Highland Park Police Department.

Mayor Brill Mittler administered the Oath of Office to Joseph Olarra, Jr.

Chief Rizco introduced Bryant Fitzgerald. He is 25 years old and from Highland Park. He graduated from Highland Park High School in 2009. Following high school, Bryant attended a year of prep school in Meriden, New Hampshire, and afterwards accepted a football scholarship to American International College. He graduated in 2015 with a degree in Political Science. He graduated from the Morris County Police Academy on November 23, 2016. He is following in his grandmother's footsteps as she is a retired Highland Park Police Officer. Bryant enjoys spending time with family, loves sports and enjoys fishing in his free time.

Mayor Brill Mittler administered the Oath of Office to Bryant Fitzgerald.

Chief Rizco noted that there are no formal departmental ribbons to give out tonight, but he called up Detective Sean McGraw. The Chief received a letter from a person who Detective McGraw had arrested a number of years ago that had an issue with narcotics. The person wrote to thank Detective McGraw for assisting him in getting help and that he is 2 years clean.

Chief Rizco noted that Captain Scott Golden will be retiring effective December 31, 2016. He noted that in attendance this evening are his parents, his sister, his brother-in-law and his son, Bradley.

Police Chaplain Rabbi Kaminetsky delivered the invocation. He thanked Captain Golden for his service to the Borough and wished him well on his retirement.

Mayor Brill Mittler commented that Captain Golden has been on the police force for as long as she has been on the Governing Body. Whenever she needed to reach out to someone to help her to reach out to the community or the press, or any other organization, he always had the right words. She will miss him and will look for him in Aruba. Mayor Brill Mittler read and presented Captain Scott Golden with a proclamation in recognition of his retirement.

Councilwoman Foster-Dublin commented that she has had the pleasure of working with Captain Golden for the last 16 years. She thanked him for his years of service and wished him well on his retirement.

Chief Rizco commented that he and Captain Golden were hired together in 1986. Scott was 21 at the time and the Chief was 32. They have worked together for many years, but have worked very closely for the last eight years. Outside of his wife, he knows the Chief better than anyone else. He likened him to Radar from Mash. He has never had any doubts about his abilities and even though they didn't always agree, he valued his opinion and advice. He will certainly miss him, but will miss his friendship more. Scott is an accomplished pilot and plans to get his instructor's license when he relocates to Florida. He tried to convince him to stay for 29 more months, but he is happy for him, but his leaving is bittersweet. He unveiled a before and after picture of the Captain (hire/retire) and presented him with a plaque from the Highland Park Police Department.

Fire Chief Jay Littman noted that he has known Captain Golden since he has been a member of the Highland Park Volunteer Fire Department for the last 27 years. He wished him well on his retirement and thanked him for his years of service.

Capt. Micah White of the Highland Park First Aid Squad wished Captain Golden well on his retirement and thanked him for his years of service.

Hatzolah Volunteer EMS of Middlesex County, launched in 2014, has had many dealings with Captain Golden. He has tremendous integrity and a good moral fiber. It was an honor to know him and work with him. They presented him with a plaque and wished him well on his retirement.

Captain Golden commented that it has been a great ride and a great career. He tried to teach fellow officers the best that he could; be safe and go home at night. He thanked the Governing Body, past and present. He thanked the Police Department and will think about them when he is in sunny Florida. He thanked the Fire Department, the 1st Aid Squad and Hatzolah for their well wishes. He has worked with Eveleen Fitzgerald and Joseph Olarra and now members of their family have been sworn in to serve Highland Park. He encouraged the three new recruits to be true to themselves. It has been a lot of fun to work with Chief Rizco. They rose through the ranks together and for the last 8 years they provided each other with opposite sides of opinions. To his family; he thanked them for their support and for putting up with him. He especially thanked his son Brad. He wished everyone success.

On motion made by Councilwoman Welkovits, seconded by Councilman George, and carried by affirmative voice vote of all Councilpersons present, meeting was adjourned for a fifteen-minute recess.

Meeting Reconvened at 8:02 pm with all those previously in attendance still present.

Mayor Brill Mittler asked the Council members to present their reports.

Councilwoman Foster-Dublin - no report.

Councilman Fine reported that the Governing Body would be introducing an ordinance for the Municipal ID program and would be adopting a resolution to purchase the equipment for said program.

Councilman Walsh reported that the Highland Park Arts Commission won a grant from the Middlesex County Cultural and Heritage Commission for a solo show workshop to be held at the senior center this February to April. They are also currently running an Improv Class at the Senior Center which is gaining in attendance and popularity. The Artists and Arts Supporter Survey has gone out and is up to about 50 respondents. They are looking forward to sharing the data with the Planning Board about the arts needs in and around Highland Park. The Senior Medical Driver, Lawrence Paterson, recently obtained his CDL license and will now be taking the seniors on out of town trips each month. Information on upcoming trips can be found on the borough's website. The Annual Senior Holiday Party will be held on Saturday, December 17th at 11:30 AM at the Senior/Youth Recreation Center. Entertainment will be provided by the local Lion's Club Chapter. The Senior Luncheon will be held on Tuesday, December 20th at Pithari Taverna in Highland Park from 11:30 AM to 1:30 PM. Entertainment to be provided by Gordon James. The Winter Concert by Highland Park Schools Master Chorale will be held on Wednesday, December 21st at 10:00 AM. Lastly, the Annual Holiday Dinner will be held on Christmas Day, December 25th from 1:00 PM to 3:00 PM at the Senior/Youth Center. For holiday dinner reservations, donation information and volunteer opportunities, call the Department of Community Services at 732-819-0052.

Councilman George reported that the Planning Board passed a resolution recommending the area in need or rehabilitation ordinance that is on the agenda for first reading, which is a major step in redevelopment in Highland Park. He urged residents to come out to the Planning Board, Board of Adjustment and Redevelopment Agency meetings to see what they are working on. All matters involving redevelopment are discussed at public meetings. The Board of Adjustment is hearing an application for a property on Woodbridge Avenue for a Chinese language and learning center. The Planning Board is also hearing some development applications on Woodbridge Avenue. Main Street Highland Park had their monthly meeting and Christmas Party on December 1st. Lastly, as a result of a walk that he and the Mayor took on Route 27 with concerned citizens in the summer along the Edison side of Route 27, they talked with the property owners and businesses in that area to see what could be done to make things better. With the cooperation of the land owners, Chief Rizco and Lt. Panichella, they made some minor changes that made a major difference. They striped the sidewalks in that area because those old areas have curb cuts that are 30'-40' long and there was no delineation of where the sidewalk was because they paved right to Route 27. They changed Lexington Avenue to be a one-way street coming off of Route 27. They changed the parking plan to put in diagonal parking spaces and made an entrance and exit to the parking lot and they installed a planter on the corner. He thanked Councilwoman Foster-Dublin for taking this matter up with the Police Department and he thanked the Police Chief for taking action.

Councilman Hersh reported that the Digital Data Task Force was formed earlier this year and is chaired by Matt Hale. Shayne SantaLucia, Joan Hullings, Chaim Cohen, Mike Schoeffler, Jennifer Senick, Daniel Bianchini and Keith Peckman also serve on the Task Force. The purpose of this task force is to look at technological aspects and make recommendations. Their main focus is working on digitizing records and looking at ways to better handle and manage OPRA requests. They will meet again later this month and will eventually work with the Public Information Committee.

Councilwoman Welkovits reported that over 200 parents participated in the Bartle School Breakfast After the Bell Survey. The program aims to offer a healthful breakfast to all students, including free and reduced lunch. The results of the survey revealed overwhelming support for this vital program that is expected to begin in January, 2017. She thanked the leadership of the school district for this responsiveness to this program. She also thanked Assemblywoman

Borough Administrator Kovach - no report.

Borough Attorney Schmierer – no report.

Mayor Brill Mittler reported that residents will find the current issue of the HP News in their mailboxes. The HP News contains a lot of important news, past and present. There is a section that highlights all the information for holiday shopping. She is almost finished with her holiday shopping and she did it all in Highland Park. There are shops to buy clothing, jewelry, household goods and wine. She announced that the League of Municipalities Conference, the National League of Cities presented Highland Park with an award for their HP Gives a Hoot initiative.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

Tina Weishauss, 143 North 5th Avenue, commented that she is here in support of Sanctuary City and the Municipal ID program. She was involved in a conversation last evening about a young woman being attacked on the subway and nobody came to her aid. She suggested that the Borough have the Human Relations Commission look into providing education for interested Highland Park residents, similar to what Franklin Township has done. Mayor Brill Mittler noted that Councilman Fine is the liaison to the Human Relations Commission and he will pass the information on to them. She also asked that Chief Rizco be involved in any discussions. Councilwoman Foster-Dublin noted that she did see a video about that incident circulating on Facebook and she will get that information to the Human Relations Commission.

Joanna Cadia, Hackensack, NJ Alliance for Immigrant Justice, commended the Governing Body for the work they did on the Municipal ID program. Highland Park is the 2nd town in Middlesex County to establish this program and the 6th town in the State. She offered her assistance as the Borough moves forward with the implementation of this program. Mayor Brill Mittler asked Councilman Hersh to chair a Task Force to address immigrant issues and to reach out to her group for guidance.

Judy Petsock, 149 North 5th Avenue, commented that she is concerned beyond Highland Park being a sanctuary city. She asked that the Governing Body talk to the Governing Bodies of other municipalities in New Jersey. She will be posting a pledge that she hopes everyone will sign.

David Hughes, 330 South 3rd Avenue, commented about Highland Park being a sanctuary city and hopes that it's not controversial. This is necessary to protect Highland Park's citizens and to provide services so that people will come out of the shadows. You will find undocumented people being hesitant to call the Police for help. He applauded the Borough for implementing a municipal ID program. He encouraged everyone to apply for the ID whether they are undocumented or not. He asked if records will be kept for those that apply. Councilman Fine advised that as part of the program, no documents will be kept on file. He also commented about the wage theft allegation against Tete Restaurant. Borough Attorney Schmierer advised that the Borough has an ordinance about wage theft and he was instructed earlier this evening to contact the business in question and to monitor the matter when business license renewal comes up in March. The information will be provided to the Department of Labor.

Isabel, 9 Redcliffe Avenue, commented about sanctuary city and asked if someone was detained by the Police Department would they contact ICE. Mayor Brill Mittler commented that there is no real definition about sanctuary city. They are putting together a task force to research the pros and cons of Highland Park becoming a sanctuary city. The Highland Park Police Department follows the guidelines of the Prosecutor's Office. Chief Rizco noted that in 2007, the Attorney General passed legislation, adopted by the County Prosecutor's Office. If someone is detained for an indictable crime, they are obligated to contact ICE. For minor violations, they do not get involved.

Jason Rowe, 74 Raritan Avenue, commented that he is the Assistant Director of Social Justice for Catholic Charities. He thanked Highland Park for taking the lead on Municipal ID Program. He offered their support for implementation of the program. He and his colleague contacted Highland Park about wage theft issue at 247 Raritan Avenue. This matter is certainly a problem and has been documented with the Department of Labor and Legal Services of New Jersey.

Lucy Millerand, 130 North 10th Avenue, spoke about wage theft issue and the fact that the restauranteur who is not paying their workers legal wages.

No one else appearing to be heard, the Mayor closed the public discussion session.

The Clerk reported advertising an ordinance entitled, AN ORDINANCE BY THE BOROUGH OF HIGHLAND PARK REGULATING CLOTHING BINS AND AMENDING THE "CODE OF THE BOROUGH OF HIGHLAND PARK, 2010", for consideration of passage on final reading by title and that affidavits of publication thereto are on file. Councilman George commented that this morning he attended a meeting where he represents one of the largest school boards in the State. The meeting was about the early Childhood program and its funding. An issue came up that enrollment is down and the reason was that this large city has a large population of undocumented citizens and they are afraid to take their children to childcare, which means childcare doesn't get funded and the kids don't get an education. The biggest reason was that to enroll their children parents needed to show some form of identification. A suggestion was made to create a municipal ID program and he emailed them a copy of the Borough's ordinance.

Councilman Hersh echoed Councilman George's comments. This is a very exciting day for the Borough. This is a point of access for a lot of residents and it is very important.
