BOROUGH OF HIGHLAND PARK REGULAR MAYOR & COUNCIL MEETING OCTOBER 18, 2016 - 8:00 PM

A Regular Meeting of the Highland Park Mayor and Council was held in Borough Hall, 221 South 5th Avenue, on Tuesday October 18, 2016 and was called to order by Mayor Brill Mittler at 8:02 PM. Mayor Brill Mittler read the Open Public Meetings Statement.

Present: Mayor Brill Mittler; Councilpersons Foster-Dublin (8:12 PM), George, Walsh, Welkovits; Borough Attorney Schmierer; Borough Administrator Kovach; Borough Clerk Hullings.

Absent: Councilman Fine.

Mayor Brill Mittler asked the Council members to present their reports.

Councilman Walsh reported that registration for youth basketball (K-8th grade) is ongoing and teams will be forming with games on Sundays and a mid-week practice. The Halloween costume parade and festival will be held on Sunday, October 30th from 2:00 PM to 5:00 PM in the Highland Park High School gym for children in pre-k through grade 6. Join them for spooky and fun music by DJ John, the Wizard's Castle Bounce House, activities, crafts and refreshments. Prizes and giveaways will be awarded following the costume parade. The event is sponsored by the Borough of Highland Park, Over the Moon Toys, Ziran Martial Arts, Yellow Brick Road Preschool, Stop & Shop and a grant from the Middlesex County Development Block Grant. The Veteran's Day Parade will be held on November 11th beginning at 11:00 AM at the Doughboy Statue. There will be a short ceremony and then the parade will proceed down Raritan Avenue towards New Brunswick. Residents are encouraged to come out and support the veterans. Operation Take Back will take place on Saturday, October 22nd and Sunday, October 23rd from 10:00 AM – 2:00 PM at the Highland Park Senior/Youth Center for those who wish to turn in unused prescriptions safely. The senior fall luncheon will be held on Tuesday, October 25th at 12:00 PM and will feature a mind reading game show by Flavian. The next Atlantic City bus trip to the Tropicana Casino will take place on Tuesday, November 1st. Bus departs from the Highland Park Senior/Youth Center at 8:30 AM and will return by 6:30 PM. Cost is \$40 per person and you get \$25 back in slot cash. Trip is open to all residents. He met with the Mayor, Councilwoman Welkovits and the County of Middlesex to discuss a bike path, but the Mayor also brought up the idea of putting sculptures in Donaldson Park. They need specific plans (what materials sculptures will be made of, how deep they'll be embedded in the ground, etc.). The Commission agreed that sculptures in Donaldson Park would be great and they would like to help make that happen. As to the particular materials and depth of the sculptures into the ground, it was agreed that it depends on the permanence of the sculptures, the proximity to the bike path and the intention of the artist(s). The Improv workshop is set to happen at the Senior Center on Tuesday evenings from 4:00 PM - 5:00 PM starting November 22nd. He invited residents to come tell their stories of "How I Got to Highland Park" at the Highland Park Public Library on Thursday, October 27th at 7:00 PM. Mayor Brill Mittler commented that she is excited and happy about the new Arts Commission and it is a pleasure to read about new programs. She thanked Pandora Scooter and John Marron for their efforts.

Councilman George dedicated his report tonight to Jon Erickson. His reports were always very succinct. The Borough, in conjunction with Planner Jim Constantine, held a presentation several weeks ago for the public to share their thoughts about the area in need of rehabilitation. It was a successful meeting with approximately 45-50 people in attendance. They broke out into sessions after a short demonstration. It was good to meet the public and actually sit down and discuss the issues. Main Street Highland Park held an event last Sunday called "A Taste of Highland Park". It was an event for the restaurant owners to come out and demonstrate their wares. They blocked off a small section of North 4th Avenue in front of Pino's. He attended the event and was struck by the varied demographic of the group in attendance. This is the new face of Highland Park. He thanked Main Street Highland Park for organizing this event and they plan to do it again next year. The Planning Board met last week and approved the area in need of rehabilitation recommendation that will be before Council in the coming months. They made some recommendations for some guidelines and he was happy to see that. The Board of Adjustment meeting was cancelled yesterday in Jon's memory. They have an interesting application for an arts studio on Woodbridge Avenue. The Redevelopment Agency met and briefly discussed the area in need of rehabilitation.

Councilwoman Foster-Dublin reported that Operation Take Back will take place on Saturday, October 22^{nd} and Sunday, October 23^{rd} from 10:00 AM -2:00 PM at the Highland Park Senior/Youth Center for those who wish to turn in unused prescriptions safely. With a grant from the State, the Highland Park Police Department was able to purchase body cameras. All Police Officers will be equipped with these cameras.

Councilwoman Welkovits reminded any homeowner that is interested in having solar panels installed to please take a look at Highland Park's new solar program. They have partnered with EnergySage, a longtime advocate and source of knowledge and education in solar power and installations. They are available to answer your questions and they also provide a website/marketplace where you can list your home and have contractors bid on your business, creating competition and best pricing. She thanked Sustainable Highland Park and Sustainable Jersey for customizing the program for Highland Park.

Borough Administrator Kovach – no report.

Borough Attorney Schmierer – no report.

Mayor Brill Mittler mentioned the empty seat to her right next to Councilman George. It was a very difficult day for many of us in Highland Park as we attended a memorial service for Councilman Jon Erickson, who served this community for the last 14+ years. She had the pleasure of first meeting Jon in 2000 and working very closely with him. Jon was the man she went to for advice on municipal governance. He was a brilliant, although quiet in public, gentleman and we will surely miss him every day here in Highland Park. She asked for a moment of silence to remember Jon. Lastly, she reminded everyone that November 8th is Election Day. We live in the greatest country on the face of this earth and in a democracy and it is our obligation to go to the polls and exercise our right to vote.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

Herb Gross, Adelaide Gardens, commented about affordable housing that will be built at the Roosevelt Care Center and that he will be meeting with veteran's administration officials next week.

No one else appearing to be heard, the Mayor closed the public discussion session.
