REGULAR MEETING - APRIL 14, 2015

A regular meeting of the Highland Park Mayor and Council was held in Borough Hall, 221 South 5th Avenue, on Tuesday, April 14, 2015 and was called to order by Mayor Gayle Brill Mittler at 7:06 p.m. Mayor Brill Mittler read the Open Public Meetings Statement.

Mayor Brill Mittler read and presented a proclamation in recognition of Sexual Assault Awareness Month. Mayor Brill Mittler encouraged everyone to wear denim on the 28th of April.

Main Street Minute - No one appeared to present Main Street Minute.

Council Reports:

<u>Councilwoman Foster-Dublin</u> reported that with the weather getting warmer bicyclists will be out and about. She encouraged bicyclists to wear helmets and for those that travel along Raritan Avenue they should utilize the newly painted sharrows. She warned residents to beware of scam telephone calls from people pretending to be from the IRS. The Internal Revenue Service does not make telephone calls. The Police Department is aware of this activity.

Councilman Fine - No report.

Councilman Potts reported that the next senior luncheon would be held on April 17th from 11AM till 2PM. Vision screenings will be offered at the Senior/Youth Recreation Center and is open to the public. On April 20th, the seniors will have a game show/luncheon. The Senior Prom will be held on June 18th. The Youth Theater Company will be performing Annie Jr. at the Highland Park High School on May 14th. There are two adult vacancies and 2 youth vacancies on the Recreation Advisory Committee. Interested residents should contact the Borough Clerk's Office for an application. The Memorial Day parade will be held on May 25th and will begin in New Brunswick. Summer camp registration forms are available and they are accepting applications for camp counselors. Applications are due by April 30th. Counselors in Training (CIT's) 14 years old; Jr. Counselors 16 -17 years old; Counselors 18 years and older

<u>Councilman George</u> reported that his committee has been working on changes to the Zoning Ordinance. A draft has been prepared for distribution to the group for review and comment and he anticipates presenting to the Borough Attorney for discussion at future meeting.

Councilman Erickson - No report.

Councilwoman Welkovits reported that there is a resolution on the agenda for the Environmental Commission for \$6,500 for improvements to the Meadows Trail and Bike Rack. There is also a resolution on the agenda to select a firm for the Home Energy Audits. Additional information will be forthcoming when they are ready to roll out the program. She thanked Jonathan Horowitz, Artist, for completing the vibrant mural at the Environmental Education Center. Earth Day festivities will be held on April 19th from 11 AM till 3 PM. The event will feature food, music and hands on demonstrations. Earlier that day at 10 AM trees will be planted at the Native Plant Reserve. She thanked Mary Denver and Belinda Beetham for getting the plants from the Native Plant Society. April 24th will be the annual Walk your child to School Day. Peter Bilton, Chairperson of Complete Streets, will host the event. Participants will meet in the Stop & Shop Parking lot and walk to either Irving or Bartle Schools. Lastly, she reported that as of April 1st, the Department of Public Works has filled 1,015 potholes, using nearly 24 tons of asphalt.

Borough Administrator Kovach - No report.

Borough Attorney Schmierer - No report.

Mayor Brill Mittler reported that the Capital Improvements Task Force will report back to the Council at the end of April or beginning of May. The Governing Body has a great appreciation for the many volunteers in town and this year they will celebrate them at a Volunteer Event to be held on April 22 nd at the Senior/Youth Center. Many different types of foods to be donated by downtown restaurants and the Highland Park orchestra will perform. Certificates of honor will be presented and the Volunteer of the Year will be revealed. The event will be held from 7 PM till 9 PM. She is planning a fundraiser for the Roots Program to raise funds for high school students to attend a camp to learn how to mentor other young students. The fundraiser is planned for May 20th and more information will be released shortly. The Highland Park Education Foundation is running a fundraiser on May 30th and the Elijah's Promise, who run a Better World Café are having a fundraiser on June 8th. She will be joining three other Mayors from Middlesex County at a Middlesex County Chamber of Commerce event to talk about issues important to the economy and our municipalities.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

It is hereby certified that the within budget is a true copy of the budget finally adopted by resolution of the Governing Body on the 14th day of April, 2015. It is further certified that each item of revenue and appropriation is set forth in the same amount and by the same title as appeared in the CY 2015 approved budget and all amendments thereto, if any, which have been previously approved by the Director of Local Government Services.

Prior to casting his vote, Councilman Fine made the following comments - "I just began a three year term on the Borough Council less than four months ago, and I understand that the 4.61% tax increase in municipal taxes, which represents about 26% of property taxes in Highland Park, is considered necessary due to prior commitments made by past administrations and due to the fact that we have not received some \$800,000 due to the Borough by the State of New Jersey in energy tax rebates. Although I am voting yes for the 4.61% tax hike, I must say that I am opposed to seemingly frequent, significant tax hikes. In addition to being against tax hikes, I'm also not in favor of service cuts. So, the question remains how may Highland Park taxes be stabilized? I believe there are ways for us to stabilize out taxes. One of those ways is to pursue more shared services and cooperative purchasing agreements. To date, this Governing Body continues to save taxpayers money by sharing a Fire Official, a Health Officer, and Animal Control with Middlesex County, and a Housing Director with Woodbridge. I know our Governing Body remains committed to engaging local entities, such as the Board of Education, the Library, the Housing Authority, other surrounding municipalities and Middlesex County to engage in discussions to pursue more of these types of agreements. I also believe that we need to continue to explore additional ways to stabilize our taxes. So, while I voted yes for the proposed 4.61% tax increase tonight, please know that I am committed to finding ways to put a stop to the seemingly frequent, significant tax hikes that our citizens are experiencing.

Mayor Brill Mittler thanked Councilman Fine for his comments.

The Clerk reported advertising an ordinance entitled, AN ORDINANCE AMENDING THE "CODE OF THE BOROUGH OF HIGHLAND PARK, 2010", CHAPTER 165 BY ADDING THERETO ARTICLE III CONCERNING RETAIL SALE OF TOBACCO AND ELECTRONIC SMOKING DEVICES for consideration of passage on final reading by title and that affidavits of publication thereto are on file. She also reported that the ordinance had been posted and made available to the public, as required by law.

On motion made by Councilman Fine, seconded by Councilwoman Welkovits, and carried by unanimous affirmative voice vote, the above entitled ordinance was taken up on final reading by title.

Mayor Brill Mittler declared the public hearing on the ordinance open to all officials and persons present and called upon all those wishing to speak for or against the ordinance to do so.

Eric Silverman, 30 South Adelaide Avenue, commented that he is in favor of the ordinance because of the addictive nature of tobacco. Minimum age is 19 and raising the age makes it less likely for younger people to start smoking. Cigarette smoking is the leading preventable cause of death.

Resident, 110 Montgomery Street, noted that she is an intern at NJ Global Advisors on Smokefree Policy and a Rutgers University Senior. She commented that she is in favor of this ordinance and admired that Highland Park is going forward with this ordinance. New York City has also adopted this ordinance.

No one else appearing to be heard and no objections having been received in writing, the Mayor closed the public hearing.

On motion made by Councilman Fine, seconded by Councilwoman Welkovits, the ordinance entitled as above, being Ordinance No. 15-1884, was duly adopted by the following roll call vote, to wit:

Councilman George reported that he has been smoking on and off for 50+ years and has done so since the age of 19. He recognizes and feels the physicality of addiction and this is a different type of addiction. The State regulates this at 19 years old. He has spoken to merchants and others about this ordinance. Some of the merchants voiced their support of it and they sell cigarettes.

Councilwoman Welkovits commended Councilman Fine for bringing this to the Council. Highland Park has done many things as it relates to smoking, with smoke free buildings/area, etc.

Mayor Brill Mittler commented that this Governing Body deliberated this issue long and hard, with much debate.

WHEREAS, the implementation of Assembly Bill A-1109 (also called "Stephen Komninos' Law") would improve protections for individuals with developmental disabilities by providing increased transparency of investigations conducted in connection with an allegation of abuse, neglect or exploitation of individuals with developmental disabilities; and

WHEREAS, Assembly Bill A-1109 was created to honor the memory of Stephen Komninos, an individual with developmental disabilities who died at the age of 22 while under the care of a private licensed facility for persons with developmental disabilities in Haddonfield, New Jersey; and

WHEREAS, the adoption of Assembly Bill A-1109 provides for six bi-monthly unannounced site visits to be conducted at any facility that houses individuals with developmental disabilities, including but not limited to any public or private agency, organization, or institution providing care to the developmentally disabled; and

WHEREAS, upon adoption of Assembly Bill A-1109, the Commission of Human Services or the commissioner's designee is required to designate members of the public to serve as advocates for individuals with developmental disabilities, and staff members from the Special Response Unit in the Department of Human Services to participate in the bi-monthly unannounced visits. A member of a law enforcement agency would also participate in the visits, which would be conducted to determine if the patients/residents of said organization are being subject to abuse, neglect or exploitation by a caregiver; and

WHEREAS, this Bill also requires the Commissioner or his/her designee to provide written notification to the guardian or an authorized family member of an individual with a developmental disability receiving services from the Division of Developmental Disabilities, of any injury to the individual with a development disability, as soon as possible, but no later than one hour after the occurrence of the injury; and

WHEREAS, a State developmental center and any private licensed facility for individuals with developmental disabilities are to bi-annually host an event in order to provide an opportunity for parents and guardians to share experiences about their family members and wards; and

WHEREAS, Assembly Bill A-1109 also amends Public Law 2010, c.5 (C.30:6D-73, et seq.) which established the Central Registry of Offenders Against Individuals with Developmental Disabilities (Central Registry) in DHS to prevent those caregivers who are identified as offenders against individuals with developmental disabilities from working with such individuals in the future; and

WHEREAS, this Bill further amends the current law to change from a disorderly persons offense to a fourth degree crime the failure of a case manager or supervisor to report an incident and makes it a third degree, rather than a fourth degree crime, if the unreported incident results in death; and

WHEREAS, the confidentiality provisions of the Central Registry law would further be amended to permit records and reports of any investigation to be provided to a guardian or other person responsible for the welfare of the individual with a developmental disability; and

WHEREAS, the adoption of Assembly Bill A-1109 is in the best interests of the Borough of Highland Park, its residents and their families.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Highland Park that the Borough supports the adoption of A-1109, which would implement stricter rules and regulations for organizations that house and care for individuals with developmental disabilities; and

BE IT FURTHER RESOLVED, that we urge our State Senator and our representatives in the General Assembly to join as co-sponsors of A-1109; and

BE IT FURTHER RESOLVED, that copies of this Resolution be forwarded to the Honorable Governor Chris Christie, our District Representatives and the New Jersey State League of Municipalities.
