REGULAR MEETING - JULY 7, 2015

A regular meeting of the Highland Park Mayor and Council was held in Borough Hall, 221 South 5th Avenue, on Tuesday, July 7, 2015 and was called to order by Mayor Gayle Brill Mittler at 7:04 p.m. Mayor Brill Mittler read the Open Public Meetings Statement.

Present: Mayor Brill Mittler; Councilpersons Erickson, Fine, Foster-Dublin, George, Potts,

Welkovits; Borough Attorney Schmierer; Borough Administrator Kovach and Borough

Clerk Hullings.

Absent: None.

Main Street Minute – Rebecca Hersh appeared and noted that on July 22nd from 9AM to 4PM they will be holding a Downtown Design and Place Making Workshop at the Reformed Church. The workshop is free to Highland Park residents and information is posted on their website. On July 18th, the Outdoor Movie Theater begins. They are recruiting artists for the Arts in the Park Event to be held on September 20th. The Farmer's Market is open on Fridays and will continue until December. On July 31st, there will be a tomato festival, with cooking demonstrations and a mobile health unit. Main Street Highland Park will be featuring music on Friday nights at various corners throughout the downtown. Kinetics has relocated to the corner of North 4th and Raritan. There are a couple of food establishments interested in spaces in town, specifically the space3 near the former Main Street office and the corner of North 2nd Avenue.

On motion made by Councilwoman Welkovits seconded by Councilman Potts, the minutes of the Regular and Conference Meetings held on April 14, 2015, May 5, 2015, May 19, 2015 and June 9, 2015, were approved as distributed by the following roll call vote, to wit:

Mayor Brill Mittler noted that seven (7) high school students were selected to attend Camp Learn to become mentors as part of the Youth Roots Initiative. They will go to camp and bring back what they learned to the high school to mentor other students. She introduced the high school recipients: Piney Arp, Dylan Boynton, Kyle Hagin, Ogemdi Nwadke, Patricia McDaniel, Olivia Ruiz and Amiri Tulloch.

Chief Rizco noted that the Patrick Keogh started as a Volunteer Firefighter with the Highland Park Fire Department in 2006. He also worked as a Police Dispatcher and as a Paid Part-Time Firefighter. He graduated from Edison High School and attended Middlesex County College. He got married in January and resides in North Arlington, NJ. He will begin six months of training on Monday at the Morris County Police Academy and will graduate December 13th.

Mayor Brill Mittler administered the Oath of Office to new Police Officer Patrick Keogh.

Mayor Brill Mittler asked the Council members to present their reports.

<u>Councilman George</u> reported that the Redevelopment Agency is working on a developer's agreement. Main Street Highland Park is working on some great events. The Design Committee Meeting tomorrow night will focus on wayfinding signs. The Planning Board is considering ordinance for residential reconstruction at their next meeting on Thursday.

Councilman Erickson reported that the property tax bills will be mailed out next week.

Councilwoman Foster-Dublin asked PBA President Brian O'Mara to talk about a new initiative that they are involved in. Office O'Mara noted that they have begun a senior registry for information/emergency contacts. They are also compiling a special needs registry (ex: child w/autism, senior citizen with dementia, oxygen users, etc.) for use in emergencies. The information is collected through the borough's website and Facebook page. Kim Perkins at the senior center has been very helpful in compiling this information. Need to reach out to those citizens that do not electronic media. Councilwoman Foster-Dublin noted that last Tuesday, the motorcycle patrol unit was put in place with Officer Sachau. They hope to have the bicycle patrol up and running shortly so that more police are visible and having more contact with the residents. The 4th of July celebration was a wonderful event. The CERT team was in full uniform and deployed after their graduation on June 22nd. National Night Out will be held on August 4th from 5-9 PM and she encouraged everyone to participate. It is a chance to meet the Police Department, get safety tips, view equipment on display, have food, refreshments, relax and have a chance to win prizes.

Councilman Fine reported that the Council will be voting on a resolution regarding the 25th anniversary of ADA being held on July 26, 2015.

Councilman Potts reported that the Senior Prom was held on June 17th and he thanked Kim Perkins and all the volunteers. He gave a special thanks to Chief Rizco and Lt. Panichella from the Police Department for attending and being dance partners for the seniors. This was the 11th annual prom and attendance has gone from 24 people to 130 people. The 4th of July celebration was great and they lucked out with the weather. He thanked all the volunteers and the sponsors. Summer camp begins on July 6th and runs through August 21st. Summer hours will continue for Borough Hall and the Senior Center through Labor Day. He congratulated the PBA on their fundraising event that he attended, where Freeholder Polos was the Master of Ceremonies. The PBA paid special tribute to fallen NJ State Trooper Anthony Raspa.

<u>Councilwoman Welkovits</u> reported that the pilot program for the new automated garbage truck will begin on Monday. Residents in the Triangle section of town were provided with garbage containers and instructions for placement. Sustainable Jersey for Schools Grants of \$2,000.00 were awarded to Bartle School and Irving School. She thanked Pam from Rutgers Forestry for the survey her and a group of volunteers were doing in town for Emerald Ash Trees. There are dangerous pests infesting these trees and this survey is helping check on the health of the trees in town.

Borough Administrator Kovach - no report.

Borough Attorney Schmierer – no report.

Councilwoman Foster-Dublin reported that they received a Public Safety Grant in the amount of \$12,600.00 for enforcement education and awareness. They also received a grant from AAA of 60 helmets that will be distributed for free to residents.

Mayor Brill Mittler thanked Mary Denver and Belinda Beetham for being the guides at the Wednesday walks at the Native Plant Reserve during the month of June. She learned a lot about native plants.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

Herb Gross, Adelaide Garden Apartments, indicated that there is a dangerous situation and nothing has been done to his knowledge. On 1st Avenue by the bank there are 12 sidewalks uprooted with branches and shrubbery on the side. He spoke with officials at the bank and they indicated it is not their responsibility. Mayor Brill Mittler instructed Borough Administrator to have Code Enforcement Department inspect the area. Mr. Gross wanted to know who is responsible. Mayor Brill Mittler indicated that the property owner is responsible. Ms. Kovach indicated she will have Code Enforcement check the area and they will notify the property owners if repairs are necessary. Mr. Gross indicated that he has seen people cross the street to avoid this area.

WHEREAS, Highland Park values the contributions of all residents, including immigrants, to the economic health, cultural diversity, and public safety of the Borough of Highland Park, Middlesex County; and

WHEREAS, Highland Park recognizes the fundamental importance of all of our residents' ability to participate in civic life, ensure the health and safety of their families, and to move freely across this State; and

WHEREAS, New Jersey law currently prohibits undocumented residents from obtaining a driver's license; and

WHEREAS, other states, including California, Colorado, Connecticut, Illinois, Maryland, Nevada, New Mexico, Vermont, Washington, and Utah, as well as Washington, D.C. and Puerto Rico do not prohibit access to driver's licenses based on immigration status; and

WHEREAS, the safety of Highland Park's roads would be enhanced if all residents of appropriate driving age were tested, trained, licensed, and insured, regardless of immigration status; and

WHEREAS, The AAA Foundation for Traffic Safety has documented that car crashes rank among the leading causes of death in the United States and that approximately one in five fatal crashes in the United States involve an unlicensed or invalidly licensed driver; and

WHEREAS, New Jersey would become safety with fewer uninsured and unlicensed drivers on the road, resulting in a predicted decrease in fatal traffic accidents and fewer hit-and-run crimes; and

WHEREAS, the public safety of Highland Park would be enhanced by helping bring immigrant communities out of the shadows to par4ticipate more fully in civic life, building trust and cooperation between immigrant communities and law enforcement and strengthening the ability of police to investigate and solve crimes; and

WHEREAS, New Jersey Policy Perspective (NJPP) estimates that if New Jersey law were changed to expand access to driver's licenses to undocumented residents, between 153,000 and

278,000 New Jersey residents would apply for a driver's license within the first three years of eligibility; and

WHEREAS, expanding access to driver's licenses would enhance New Jersey's and Highland Park's economy; and

WHEREAS, undocumented immigrants pay and estimated \$476 million in state and local taxes in New Jersey each year; and

WHEREAS, NJPP estimates that New Jersey insurance companies would take in over \$200 million in additional premiums per year, saving money for existing policyholders by expanding the pool of policyholders and reducing the number of claims against uninsured drivers; and

WHEREAS, the State of New Jersey would take in millions in new revenue from fees paid by new driver's license applicants and license renewals; and

WHEREAS, Highland Park's local economy would be bolstered by strengthening the mobility of its workforce and enhancing economic participation in undocumented communities;

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the Borough of Highland Park, that Highland Park supports expanding access to driver's licenses to undocumented New Jersey residents; and

BE IT FURTHER RESOLVED that Highland Park urges the New Jersey State Legislature to pass legislation and urges the Governor to sign legislation expanding access to driver's licenses to undocumented New Jersey residents; and

BE IT FURTHER RESOLVED that a copy of this resolution shall be forwarded by the Municipal Clerk to the offices of Senator Peter Barnes, III, Assemblyman Patrick Diegnan, Jr., Assemblywoman Nancy Pinkin and Governor Chris Christie.

WHEREAS, the Borough of Highland Park, with the adoption of Ordinance No. 1630 has created a Department of Code Enforcement; and

WHEREAS, due to the complexity of their duties, limited staff, and the multiple demands on staff members' time, the Department of Code Enforcement cannot always provide borough residents and organizations who seek to work with the department with a personalized orientation to the language, paperwork, work-flow, expectations, and requirements of code enforcement concerns; and

WHEREAS, the limitation described above applies to other borough departments that work with the public on matters related to borough ordinances, state and county laws, and other concerns; and

WHEREAS, borough residents and organizations may experience frustration in trying to work with borough departments whose language, paperwork, work-flow, expectations, and requirements, are unclear to them, potentially discouraging those borough residents and organizations from addressing important concerns in a timely fashion; and

WHEREAS, the borough has an impressive cadre of well-educated, skilled, and personable retirees, some of whom may have prior professional experience that is directly related to the work of the Department of Code Enforcement and other borough departments;
