REGULAR MEETING - SEPTEMBER 1, 2015

A regular meeting of the Highland Park Mayor and Council was held in Borough Hall, 221 South 5th Avenue, on Tuesday, September 1, 2015 and was called to order by Mayor Gayle Brill Mittler at 7:04 p.m. Mayor Brill Mittler read the Open Public Meetings Statement.

Present: Mayor Brill Mittler; Councilpersons Fine, George, Potts, Welkovits; Borough Attorney Schmierer; Borough Administrator Kovach and Borough Clerk Hullings.

Absent: Councilpersons Erickson and Foster-Dublin.

Main Street Minute – Rebecca Hersh presented the Main Street Minute by noting that the Arts in the Park event would take place on September 20th from 11:30 AM until 4:30 PM. They have more vendors signed up for the event this year than ever before. They have forwarded a copy of their audit report from last year to the Borough. The Farmer's Market will run through December. The town wide garage sale will take place on October 10th and 11th and they will host another Halloween on the Avenue event. A new business featuring "hamburgers" will have a soft opening at the old Shawarma site on September 20th. Kinetics hosted their grand opening party at their new site last week, which expanded and doubled their size. Main Street is planning things to engage community participation and they will partner with Pino's to do more block parties. The Street Fair next year will be held on the first Sunday in May (5/1/16).

Mayor Brill Mittler read a proclamation in recognition of Fibrodysplasia Ossificans Progressive.

Mayor Brill Mittler asked the Council members to present their reports.

<u>Councilman George</u> reported that the Redevelopment Agency will be meeting on Thursday at 7:30 PM to discuss a new proposal. The public is invited and encouraged to attend.

<u>Councilman Fine</u> reported that the Human Relations Commission is working on two items. At the last meeting in August, they voted to establish a task force for a National 9/11 remembrance to be chaired by Greg Trevor. On October 14th they will host a forum at the Senior/Youth Recreation Center where residents can ask questions of the Highland Park Police Department. They hope that this will enhance communications between the residents and the Police Department.

Councilman Potts reported that the summer camp program had an 18% increase in the number of participants. Fall sports registration is ongoing. They are in need of youth soccer coaches and training is provided. Anyone interested in coaching should contact the Recreation Program Coordinator. The Arts in the Park event will take place on September 20th from 11:30 AM until 4:30 PM.

<u>Council President Welkovits</u> reported that Phase I of the Valentine Street improvements is complete. The Borough had a great working experience with JADS Construction. Phase II is forthcoming and will complete Valentine Street up to South 5th Avenue. She thanked the Department of Public Works for repainting the crosswalks by the schools. She noted that the Borough Offices would be closed on Monday, September 7th for Labor Day and that there is a different scheduled for garbage collection. The town wide garage sale will be held on October 10th and 11th. She congratulated the Middle School and High School that were each awarded \$2,000 for water filling stations. She thanked Sara Lebau and Hailey Conrad for their efforts.

Borough Administrator reported that summer hours for borough hall and the senior center end after this week and we return to regular schedule on September 8th with hours being Monday through Friday, 8:00 AM to 4:00 PM.

Borough Attorney - No report.

Mayor Gayle Brill Mittler reported that the Borough received official approval from the New Jersey Department of Transportation to paint the mural on the wall near the Albany Street Bridge. This is a joint effort with the Main Street Highland Park Design Team and the Architect from the developer of the former Y site. The painter has been contacted and they will begin once everything has been finalized. Lastly, she wished the Borough Clerk a Happy Birthday.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

Greg Trevor, 66 Grant Avenue, thanked the Mayor and Council for considering the idea he and his wife came up with. He is a survivor of 9/11. He is troubled about the declining public events commemorating that day. He wrote a column about this last year. He has a proposal to make 9/11 an annual day of discussion. The Human Relations Commission has endorsed an initiative and formed a task force to begin with the 15th anniversary. Create effort through Human Relations Commission to encourage community to come up with ideas.

Herb Gross, Adelaide Gardens, asked about the situation on South 1st Avenue. He has seen no progress. Mayor Brill Mittler noted that the Code Enforcement Director tried to contact him. A citation was issued to a property owner who has been to Code Enforcement Office to obtain permits to fix sidewalks. Mr. Gross asked when they would be fixed. Mayor Brill Mittler asked that he contact the Code Enforcement Department for more details.

The Clerk reported advertising and notification of Main Street Highland Park 2015 Budget for consideration of passage on final reading by title.

On motion made by Councilman George, seconded by Councilwomen Welkovits, and carried by unanimous affirmative voice vote, the above entitled resolution was taken up on final reading by title.

The following resolution, introduced by the Public Works and Public Utilities Committee, was duly adopted as above:

BE IT RESOLVED by the Borough Council of the Borough of Highland Park that the Mayor shall be and is hereby authorized to execute and attest the NJDEP Treatment Works Application attached to this

Mayor Brill Mittler appointed Candace Feinberg as a Regular Member on the Board of Health for a term expiring January 1, 2018.

The above appointment was confirmed on motion made by Councilman Fine, seconded by Councilwoman Welkovits, and carried by the following roll call vote, to wit:

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

Ruth Bickhardt, 307 Magnolia Street, asked about cancellation of sidewalk assessment on consent agenda. Borough Administrator Kovach explained that the resident fixed their sidewalk privately and should not have been billed. Ms. Bickhardt asked that the Borough pass a resolution to get people to fix their sidewalks. She also commented about bulk pickup and the fact that people put items out whenever they want. There has been a toilet lying on the sidewalk in her neighborhood for a month. People just don't seem to care. Mayor Brill Mittler commented that the Borough cares and they will notify the Department of Public Works. She was encouraged to notify the Department of Public Works when she sees things. Lastly, Ms. Bickhardt noted that the sidewalks at 2nd and Raritan Avenue are in horrible condition. Mayor Brill Mittler asked the Borough Administrator to have Code Enforcement handle the matter.

The following resolution, introduced by the Council as a Whole, was duly adopted as above:
