<u>Main Street Minute</u> – Rebecca Hersh reported that the Arts in the Park Event will be celebrating its 10th Anniversary. The Saturday night movies will continue through September every other weekend. Main Street Highland Park is working with Century 21 to promote the Townwide Garage Sale and also working with the merchants to set up that day for a sidewalk sale. There will be a meet and greet at Pino's on August 7th. They are wrapping up the townwide survey with over 500 responses received to date. Tomorrow is the last day and they will then compile the findings.

<u>Councilwoman Foster-Dublin</u> reported that the Highland Park Police Department has hired another Police Officer. Alaina Giles, a former Police Officer with Middlesex County College will begin heremployment with the Borough on August 18th. The Police Department received a \$5,000.00 grant for the Drive Sober or Get Pulled Over Campaign which will take place Labor Day weekend. The National Night Out event will take place on August 6th from 5:00 PM to 9:00 PM.

<u>Councilman Potts</u> reported that the summer camp has over 300 participants this year and a lot of the participants registered for multiple weeks this year. The camp will be ending the next couple of weeks. Registration for fall sports has begun. The senior center is a place to go if residents need to cool off during extreme heat days. Currently the senior center is observing summer hours and is open Monday through Wednesday, 8:00 AM to 5:30 PM, Thursday 8:00 AM to 4:30 PM and is closed Friday, Saturday and Sunday. On August 13th from 8:00 AM to 4:30 PM Life Health Screenings will be conducted at the Senior Center. On August 21st there will be a Hawaiian luau. Nicole Huff has been hired as a part-time Social Worker and is available at the senior center between 8:30 AM and 2:00 PM. Residents needing assistance should contact her to schedule an appointment. She is also available to make home visits. Lastly, he reported that Shirley Shapiro donated a sculpture to the Borough that was created by her husband Jack Shapiro. The sculpture is on display in Borough Hall. There are also other sculptures at the senior center and the library.

<u>Councilwoman Welkovits</u> reported that the Highland Park Housing Authority held their 2nd Annual barbeque for their tenants. There was great food and great music and fun was had by all in attendance, including Mayor Brill Mittler. She acknowledged a generous donation received from Devon Clement to the Food Pantry. She also acknowledged that at the end of July Rutgers Against Hunger gave a generous donation of \$2,000 to the Food Pantry. Last month the Governing Body passed a resolution about antibiotics and she reported that she received a letter from Congresswoman Slaughter of Rochester, NY acknowledging receipt of the resolution. In her letter, Congresswoman Slaughter noted that she appreciated the support from Highland Park for this bill for the national ban on antibiotic use on livestock. Councilwoman Welkovits thanked all the great volunteers in Highland Park.

<u>Councilman George</u> thanked his Governing Body colleagues and the Democratic Committee for their confidence in him to be on Council. He hopes to use his skills and experience as liaison for economic development.

The committee will be comprised of members of the Board of Education, Main Street Highland Park, employees and people who have a stake in community growth.

There being no further business, on motion made by Councilman Potts, seconded by Councilman Welkovits, and carried by affirmative voice vote of all Councilpersons present, the meeting adjourned at 7:47 PM.
