NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Highland Park, that Alain Giles be hired for the position of Police Officer in the Highland Park Police Department, effective August 18, 2014 at a base salary of \$56,428.00.

There was a brief recess taken at 7:05 PM.

The meeting reconvened at 7:19 PM with all those previously in attendance still present.

Presentation – Summary of Remediation Reports – Honeywell Properties was given by Allan Williams of the Environmental Commission. There are two major reports of the Honeywell properties in Highland Park. There are two sites - the Waldron property, which will be the site of Pulte's "The Crossings at Highland Park", and is located behind Cleveland Avenue from River Road to Janeway Avenue. The second site is the former Illuminating Experience on Cleveland Avenue north of Janeway Avenue. The Waldron property had previously received a RAO (Response Action Outcome) in 2013 that indicated the soil contamination had been remediated to meet NJDEP standards for residential use. During removal and crushing of concrete slabs and foundations on the property in preparation for building condominiums, one site with black soil was discovered, which suggested contamination from oil. This site was designated an Area of Concern 21, and is located in the central portion of the site. A 425-gallon underground gas tank was also discovered in the southern portion of the site and was designated as Area of Concern 22. remediation work is complete on the Waldron site and meets the DEP standards for residential development. One of the conditions of approval from the Planning Board for this site is that the Licensed Site Remediation Professional (LSRP) certify that the site meets residential standards prior to occupancy. For the Illuminating Experience property a Receptor Evaluation report was issued. The site is known to be contaminated and has been partially remediated. The primary contaminant is trichloroethylene (TCE). There are multiple monitoring wells on the site and the majority of the wells have no detectable contamination. There are numerous concrete slabs on the site, which will have to be removed before further remediation can occur. Two of the monitoring wells had samples with TCE significantly above allowed limits. In order to further evaluate the contamination additional testing was required within 200 feet of the wells and these properties are along Cleveland Avenue - Menlo Engineering, Control Layout, Mid Atlantic Industrial Service Corporation and the Garlatti Professional Building. Samples were taken from the subsoil beneath the first three buildings as well as air samples from these buildings. No TCE was detected from the three properties which supports the idea that the TCE is not leaving the Illuminating Experience site and no further action is required for those three properties. Honeywell is currently pursuing access to the Garlatti property. As part of the Receptor evaluation, a water well search has been performed with a radius of 0.5 miles. Two wells were found within this radius. Neither well has been used for many years. All residences and buildings in Highland Park receive water from Middlesex Water Company. TCE contamination of the Illuminating Experience site is NOT contaminating adjacent properties. There is significant remediation work that must be completed prior to redevelopment of the site for residential use.

Lou Pichinson, 200 Jackson Avenue, asked if the LSRP would be the same person at the rear site. Mr. Williams responded that he was not 100% sure, but believes it would be the same person as they work for Honeywell International. Mr. Pichinson commented that he believes it would be advantageous to have the same person who is familiar with the front site do the analysis on the rear site. He asked about Illuminating Experiences site cleanup in 2015 and whether it pertains to both soil and groundwater. Mr. Williams noted that when they pull up the slabs they will do more testing to see what contamination is under there. Mr. Pichinson asked whether the responsibility for the various cleanups on this property been

resolved among the three parties. Borough Attorney Schmierer noted that as far as the Borough knows the responsibility for the cleanup is Honeywell's.

Larry Perfetti, 214 Cleveland Avenue, commented that the Illuminating Experience site represents the highest point in Highland Park. He wondered about the barrels that were on the site and he wanted to know if there would be borings done near the residential neighborhood. Mr. Williams commented that if and when the property is developed, those are questions that will need to be addressed. The Environmental Commission has a good relationship with Honeywell and they can make those requests.

Councilwoman Welkovits thanked Mr. Williams for reviewing the report and asked about the wells that are located within ½ mile of public drinking water. Mr. Williams commented that wells in New Jersey have to be documented by NJDEP. There are no wells currently used for potable water.

Mayor Brill Mittler thanked Mr. Williams for taking on this report and explaining it to the Council and the public. Mr. Williams indicated that he will post the summary on the Environmental Commission Website which is accessible from the Borough's website.l

<u>Councilman George</u> reported that he has been meeting with his various boards. He sat in on the Redevelopment Agency meeting with their new attorney. He attended his first meeting with Main Street Highland Park and the meet and greet at Pino's. He also met with the Design Committee of Main Street and attended a presentation.

Councilman Erickson - No report.

Councilman Millet reported the Council will be awarding the bid for Shade Tree Planting Project and he thanked the committee for their hard work. The Sidewalk Improvement Program is 75% complete. The Council is always interested in feedback about the program and they plan to implement another program. The Borough plans to seek proposals for energy aggregation and hope to be able to pick the right consultant to get lower prices on energy costs.

<u>Councilwoman Foster-Dublin</u> reported that September is hurricane season and information on emergency preparedness is available on the borough's website under Emergency Management. The Police Department will be enforcing the Drive Sober or get Pulled Over initiative this month. Lastly, she reported on the passing of Life Volunteer Fire Department member Vince Murphy.

<u>Councilman Potts</u> reported that registration for fall sports programs is still open. Coaches are needed and interested parties should contact Andrea Baay. The next senior lunch is scheduled for September 12<sup>th</sup>.

Councilwoman Welkovits reported that she would like to thank Rich Lear of the Middlesex County Parks Department for switching out the swing seats. The Highland Park Housing Authority will be holding a large indoor/outdoor yard sale on September 18<sup>th</sup> and 19<sup>th</sup> from 9AM-5PM. The Library is conducting lots of programs and recently was awarded two grants. A listing of all programs is available on the library website. The Complete Streets group is working on a National Parking Day event to bring attention to the amount of blacktop space that is used. It will be held on September 19<sup>th</sup> from 12-7PM in 2 parking spots on South 3<sup>rd</sup> Avenue. Sustainable Highland Park is planning to do a count of pedestrians and bicyclists that utilize Raritan Avenue and that will take place on September 17<sup>th</sup> and October 1<sup>st</sup> and they are looking for volunteers.

Borough Administrator Kovach - No report.

Borough Attorney Schmierer - No report.

Mayor Brill Mittler reported on the passing of former Volunteer Firefighter Vince Murphy. She also reported the loss of former Mayor Herb Tanzman. She asked for a moment of silence for both. There will be changes along Raritan Avenue in the next few months. She signed an agreement with PSE&G to switch out the light heads and to add pedestrian lights to increase the light in the area. The DOT has approved sharrows for Raritan Avenue, which are shared lanes for cars and bicyclists, and they will be painted in the near future. This is a big step forward for Complete Streets and for the safety of all residents. Educational materials will be made available. On September 20<sup>th</sup> Main Street Highland Park will hold their annual Arts in the Park Event.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

Resident, 69 Lincoln Avenue, asked if the redevelopment plan will be revisited. Councilman George reported that the Redevelopment Agency is taking a look at it along with their attorney. The plan was done in 2005.

Matt Hersh, 333 Felton Avenue, reminded everyone that the town-wide garage sale will take place on September 13<sup>th</sup> and 14<sup>th</sup>. He asked for an overview of what is happening with the properties on Cleveland Avenue. Councilman Millet noted that those properties are the subject of litigation. One case has been resolved and one is still being litigated. Councilwoman Foster-Dublin asked that Allan Williams put his report on the borough's website.

Lou Pichinson, 200 Jackson Avenue, asked about the current status of the American Properties lawsuit. Borough Attorney Schmierer reported that the settlement discussions are ongoing. They last met August 15<sup>th</sup> and the Judge and Master are kept informed. Do not have a new court date yet.

Ted Weaver, 289 Crowells Road, asked about new garbage can program. Councilman Millet noted that the Borough will be getting a new garbage truck that will allow a single operator to pick up trash. They will be implementing a pilot program in a select target area and the Borough will purchase the appropriate containers. This will free up DPW personnel to do other things.
