A Regular Meeting of the Highland Park Mayor and Council was held in Borough Hall, 221 South 5th Avenue, on Tuesday, May 21, 2013 and was called to order by Mayor Minkoff at 7:04 PM. Mayor Minkoff read the Open Public Meetings Statement.

Mayor Minkoff asked for a moment of silence in memory of former Mayor Polos' sister, Georgette Polos, who passed away recently.

Mayor Minkoff presented a Length of Service Award to Councilman Erickson for his 10 years of service to the Borough. Mayor Minkoff thanked him for his dedication and service to the Borough.

Main Street Minute - The Shop Highland Park Rewards Loyalty card program is ready to roll out with 15+ signed up and cards ready to hand out in the next 3-4 weeks. Unity Bank is the principal sponsor of the program and we are continuing to sign up more merchants. We continue to move forward with the re-design of the Main Street Highland Park website. We have partnered with Alane Poirer, a photography instructor from Middlesex County College who is aiding in the re-design with the help of her students partnered with some local merchants. This past weekend was a very busy weekend here in Highland Park. The Highland Park 5k run was a great success. We had 40-50 more runners than last year, which is roughly a 10% increase, for a total of 460 runners. More than 40 volunteers helped out doing various duties. We would like to thank everyone particularly Andrea Baay, Jay Weinberg, Ann Betterton, Amanda Thomas, the volunteer Fire Department, First Aid Squad, Department of Public Works and the Highland Park Police Department. They all did a wonderful job. The Street Fair was a bit dampened, but it was impressive how many people did show up. The Farmers Market will open on Friday, June 7th. And will continue through Friday, December 20th. The Artisan Market will be set up in the parking lot next to the Farmers Market and will run the same dates and times. There are now only 2 vacancies downtown with the addition of BBQ Café & Sports Bar and Simmuel's Closet and the new pharmacy at 75 Raritan. Finally, the downtown is looking better than ever, Volunteers planted more than 150 downtown planters with special thanks to Ira Grasgreen and Meredith Carmen who coordinated the planting and do such a fantastic job year after year.

Mayor Minkoff asked the Council members to present their reports.

Councilwoman Foster-Dublin reported that the Click it or Ticket initiative has begun with the Highland Park Police Department. This is part of a grant program and she urges everyone to please wear their seatbelts for your safety or you will receive a ticket. Seatbelts save lives. Also, the Gun Safety Taskforce has been meeting for some time now and we are happy to announce that we will be doing a Highland Park Gun Safety public service announcement called "How to Ask". It will be a series of vignettes about gun safety and how to ask people if they have a gun in the home, similar to if your child has a peanut allergy where you would ask the other parent if they will be serving anything with peanuts. Gary Leslie has graciously agreed to produce it and they will be hiring actors and actresses to film it. During the Street Fair, we had an incident command post set up by the Office of Emergency Management (OEM) and it was manned by Freeholder Polos, the entire Public Safety and Public Works teams. This was just an example of how OEM is working to keep us safe in the event of an emergency and their help is needed. Monday May 27th is Memorial Day and we would like everyone to come out to lend your support to our veterans who have worked hard to keep us safe. Our events start as early as 8:30 am at the Fire House and we go to about 8 different locations to lay wreaths in remembrance. This year we will be going over by the Center School to rename a street "Fallen Heroes Way". That will be at about 12:30, and again we are encouraging everyone to come out and support our veterans. Last but not least, it is on a sad note that we announce that Sarah Castellano passed away. Sarah was a crossing guard in Highland Park for over 40 years and served our children well. She asked for a Moment of Silence in her memory.

<u>Councilman Potts</u> reported that May 24<sup>th</sup> is Kite Day at Donaldson Park. Festivities start at 2 pm. Ages for this event are from 4-12 years old. All children must be accompanied by an adult. This event is free of charge and if you are interested in a kite kit, they are available at community services. The second annual L.I.V.E. Mentorship Kickball game will be held on Sunday, May 26<sup>th</sup>, from 2-6 pm in Donaldson Park in Grove #1. This project is spear headed by young adult resident Ashton Burell. There will be face painting, refreshments and a live DJ. Also as a reminder, beginning May 28<sup>th</sup>, Borough Hall goes to summer hours, Monday-Wednesday 8:00 am to 5:30 pm and Thursday 8:00 am to 4:30 pm. Borough Hall will be closed on Fridays until Labor Day.

<u>Councilwoman Welkovits</u> – reported that the Library held another successful Book Sale and brought in close to \$7000.00. We would like to thank all of the volunteers who worked so hard for the entire week before in preparation for the sale. Also, there will be an awards dinner this week by the American Conference of Diversity of Central New Jersey where a long time Highland Park resident, Lola Camp is being honored. Congratulations Lola for all of your hard work and volunteerism. Maureen Vogel-Horowitz is being appointed to the Board of Health as an Alternate member tonight. She will be a welcome addition to the board. Lastly, this is just a reminder that our Home Improvement Program is still active. There are forms and information available at the Borough Clerk's office.

Councilwoman Brill Mittler - reported that Gary Leslie and his volunteer staff of HPTV are having a meeting on May 23rd at 7 pm here in Borough Hall. He is looking for some new volunteers to help execute some great ideas that he has. Our new Public Information Committee is working on the new enews that is released every other Tuesday. Big thank you to our new communications employee, Stacy Kaplan and our excellent team of Monica Jackson and Matt Hersh (committee chair) who work hard to make sure that this goes out on a timely basis and includes some very important information. If you have not signed up to receive the e-new, you can do that by visiting our website, www.hpboro.com and sign up to receive it. There is a very exciting new column being included in the e-news called Highland Marks where we feature some people who have received some outstanding acknowledgements or made some outstanding contributions to the borough. We have someone featured this week and our hope is to have someone featured in this column every two weeks. Had a chance to view Main Street Highland Park's new website and it is beautiful! Has some great photography and features and it is being presented to the council in conference tonight. In an effort to continue to make our downtown vibrant walkable and safe we have been working on formulating a resolution so that we can become a complete streets community and we hope to have information on that very soon. Tomorrow will be attending a meeting with Councilwoman Welkovits at Keep Middlesex Moving to try and help figure out how to keep people commuting without using their cars.

This causes him to, yet again, thank the people of Highland Park for their endless supply of enthusiasm and commitment, not only those up on the dais, but the dedicated volunteers who make these things possible. Would also like to thank the county and Freeholder Polos for his support of everything we do here in Highland Park. We have received \$360,000.00 from the State of New Jersey Department of Transportation for infrastructure and road improvements. Although we did ask for more, we are grateful for what we did receive.

Mayor Minkoff opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

Matt Hersh, 333 Felton Avenue, stated that they have a follow up submission on the Highland Marks column. The submission is for an 8<sup>th</sup> grader in the middle school. NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Highland Park, that it hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget for the year 2013 in the sum of \$23,544.21, which item is now available as revenue from State and Federal programs pursuant to the provisions of statute; and

BE IT FURTHER RESOLVED that a like sum of \$23,544.21 be and the same is hereby appropriated under the caption of:

2013 Clean Communities

\$23,544.21

BE IT FURTHER RESOLVED that the above is the result of a grant for Fiscal Year 2013; and

BE IT FURTHER RESOLVED that two (2) certified copies of the certification of adoption of this resolution shall be forwarded to the Director of the Division of Local Government Services for approval.

Mayor Minkoff opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

No one appearing to be heard, the Mayor closed the public discussion.
