<u>Councilwoman Foster-Dublin</u> noted that she was going to defer her report this evening. She asked Tara Canavera, Vice President of the Irving School PTO to speak. Ms. Canavera noted that Firefighter Peggy Brookes helped advertise the food drive and operation snowflake. She even took the remaining angels from the tree and purchased gifts. Councilwoman Foster-Dublin wished Councilwoman Brill Mittler Happy Birthday!

<u>Councilman Potts</u> reported that the Teen Advisory Committee will meet on Thursday at 7:30 PM in the Council Chambers. The Senior Holiday Party will be held on December 16, 2013 at the Italian Bistro from 11:30 AM till 2:30 PM. The Annual Christmas Dinner will be held at the Senior Center from 1:00 PM till 3:00 PM. Interested residents are asked to make reservations. They are seeking donations and volunteers for this event.

<u>Councilwoman Welkovits</u> reported that Congressman Pallone will be attending the Affordable Care Act Event on December 9th at 7:00 PM in the Council Chambers along with representatives from Enroll America and Centers for Medicaid and Medicare. On December 10<sup>th</sup> at 5:30 PM at the Senior Center there will be representatives from all three insurance carriers and counselors available to help enroll individuals. This event is sponsored by the Board of Health. On December 26<sup>th</sup> at 6:00 PM the Human Relations Commission will celebrate Kwanzaa with a candle lighting at 6:00 PM. The Martin Luther King Event will be held on January 20, 2014 at 7:00 PM at the Senior Center. The Guest Speaker for the event will be Freeholder Ken Armwood and the award recipient will be Deborah Morgan. Mayor Minkoff opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

No one appearing to be heard, the Mayor closed the public discussion.

Mayor Minkoff welcomed back Chief Rizco from Medical Leave. He thanked the public and the first responders for their patience during this meeting.

Chief Rizco acknowledged Captain Golden for the exceptional job he did while he was out on medical leave. It is comforting to know that the second in charge is a capable individual and it is nice to come back to work with a clean desk and very few problems. The Borough and the Police Department are very lucky to have a Captain like Scott Golden.

Chief Rizco explained that they are going to honor Police Officers and Dispatchers for their high level of dedication and team work shown during an extensive search for two burglary suspects on September 30<sup>th</sup>. One will receive an exceptional duty award, the rest will receive honorable service awards, and the Dispatchers will receive proclamations from the Borough. Chief Rizco called all the honorees up to the front of the room. Chief Rizco noted that this one of two meetings each year where we recognize the first responders for outstanding performances.

Capt. Golden noted that this incident was a burglary that had occurred in neighboring North Brunswick. Suspects fled area in stolen black Acura. Sgt. Wenskoski observed the stolen vehicle in BB Big parking lot and suspects fled on foot. Officers set up a perimeter search which resulted in the arrestof one of the suspects. Officers continued to search for additional suspect who was later apprehended. Sgt. Wenskoski was presented with an exceptional duty award by Chief Rizco.

Councilwoman Foster-Dublin commended the Highland Park Police Department for always being aware of what's going on in the community, even while we sleep, and keeping our residents safe.

Mayor Minkoff commented that they are giving fifteen awards for this incident. It is not only a testament to your teamwork, it shows and it should demonstrate tangibly to everyone in Highland Park, and anyone who comes to Highland Park to do us harm, that we will spare no effort, that we have a truly remarkable team of public safety professionals and volunteers who will do anything and everything they possibly can to keep us safe at any and all times. This happens day in and day out without fanfare and without awards. Mayor Minkoff read the proclamation and Councilwoman Foster-Dublin presented a duly embossed copy to Lt. Panichella, Lt. Hammill, Sgt. Olarra, Sgt. Culver, Sgt. Wenskoski, Sgt. Lancry, Office Karon, Det. Young, Det. Newton, Officer Pardo, Officer Garrity, Officer Soden, Officer Seigal, Disptacher Marcik and Dispatcher Archibald. Chief Rizco and Capt. Golden presented the Police Officers with pins.

Chief Rizco stated that Captain Golden was the officer in charge and actively took part in the search for the individual. Chief Rizco honored Captain Golden with a service award. Mayor Minkoff read proclamation and it was presented to him by Councilwoman Foster-Dublin.

Chief Rizco called up Captain David Loewensten of the Highland Park First Aid Squad to present awards to his volunteers.

Capt. Loewenstein commented that the great part of their job is that 90% of the time the men in blue are there to assist. He thanked them for their help. There are two calls for which they will honor their volunteers. Capt. Loewenstein explained that the first incident on October 14<sup>th</sup> was a call for assistance for a resident in cardiac arrest. Upon their arrival they took over CPR efforts from the Highland Park Police Department. There were seven volunteers who responded to this call. The elderly gentlemen did begin to breathe on his own and lived for an additional week, enabling his family to spend time with him. Capt. Loewenstein called up Rebecca Lauer, Andy Brown, Patrick Boulanger, Micah White, Robin Loewenstein, Yair White, and Josh Loewenstein to be recognized.

Councilwoman Foster-Dublin commented that one thing that is said about Highland Park is how safe the town is. This is not only demonstrated in public safety but with the 1<sup>st</sup> Aid Squad and keeping residents alive. This is a shining example of who the 1<sup>st</sup> Aid Squad is and the kind of service that they offer.

Mayor Minkoff commented that the Borough is extraordinarily grateful for what they do. Even if they don't say it as often as they would like, please know that you have the gratitude of the Mayor, the Governing Body, the Administration, your peers in Public Safety, as well as the entire Borough of Highland Park. Thank you for volunteering your time to save lives and it is an extraordinary commitment and contribution that you make and we are extremely grateful for it.

Mayor Minkoff read the proclamation and Councilwoman Foster-Dublin presented a duly embossed copy to each of the honorees.

Beccy Lauer explained that this incident involved a call for assistance for a resident, Zev Rosenberg, who had fallen down his basement stairs. When the squad arrived the patient had loss of feeling in his limbs. The squad members, David Loewenstein, Patrick Boulanger and Bruce Nadler, acted quickly and carefully moved the patient onto a backboard and rushed him to the hospital. Their quick response and action resulted in the patient making a full recovery and he recently competed in the Philadelphia marathon. Ms. Lauer called up the honorees to be recognized. This is one of their big saves and they enjoy seeing him around town.

Councilwoman Foster-Dublin commented that words cannot express how thankful the Borough is for the 1<sup>st</sup> Aid Squad that keeps us all safe and this is another great demonstration.

Mayor Minkoff recognized Capt. Loewenstein for his leadership. The 1<sup>st</sup> Aid Squad in Highland Park has truly become a family business. There are parents, children, and siblings that serve on the squad. This is something that has been passed down through the generations and it is truly remarkable.

Mayor Minkoff read proclamation and Councilwoman Foster-Dublin presented a duly embossed copy to the three honorees.

Mayor Minkoff commented that he saved the most meaningful recognition for last. He asked the audience to indulge him as he read the following speech.

"To paraphrase a quote from John F. Kennedy: A nation reveals itself not only by the people it produces, but also by the people it honors, the people it remembers.

"Today, Highland Park, reveals itself with the bittersweet taste of honor and remembrance. Bitter, because it was a little less than a year ago that we lost a true friend and hero, Barry Criss.

"But it's my hope that there is some sweetness, in our choice to honor and remember Barry today, and in so doing, perhaps we can be both uplifted and inspired.

"Many of you may know that this is not the first time the community has honored Barry. He was honored as a Volunteer of the Year in Highland Park, and twice commended with resolutions for his heroism as a member of the Highland Park First Aid Squad. Just under a year ago, we gathered as a community in a moving tribute to Barry, albeit under the most trying of circumstances, but at least we were again able to show him how much we loved and cherished him for the kind person he was, the kind of volunteer he was, the kind of father and husband he was, and the kind of friend he was.

"So, what kind of person was Barry? Numbers can help tell a small piece of the story. 7,000 calls, First Aid Squad Captain for 4 terms, Assistant Captain for 10 terms, Trustee for 10 years, a total of 42 years in all, of selfless devotion and commitment to the community that he treated like his family; a man whose family shared him so selflessly with us. But, those numbers don't tell you that Barry was always a calm, reassuring and expert presence in responding to those in need, whether for us locally, or during a time of national tragedy in the aftermath of September 11, 2001.

"Above all, Barry valued the precious gift of life and he devoted much of his life to saving and protecting the lives of others. It was a horrible irony that he was taken from us way too soon, but through countless acts of bravery, he sought to rescue victims of fires, floods, accidents, acute health episodes like heart attacks and strokes, and a litany of other such emergencies. He stopped counting the number of lives he literally saved after the number passed several dozen. But for all of that and much more, weall owe him our gratitude because his nobility in his pursuit to save others added something to all of our lives.

"And just as he sought to save lives, he sought to help in the giving of life. On 7 different occasions he transformed the anxiety, fear and uncertainty of women in labor who were stranded at home into the joy of the birth of a healthy child. His kindness didn't stop with people. During and after Hurricane Floyd, Barry spent an entire night in Bound Brook in the First Aid Squad's boat rescuing not just people, but pets in distress.

"When Barry wasn't actually saving lives he was doing all he could to advance the cause of public safety. He spent much spare time maintaining the squad's vehicles and boat. He served as part of the Borough's Office of Emergency Management; he starred in a local documentary, prepared for Highland Park High School students to educate them about the dangers of drunk driving. Barry trained Highland Park Middle School students in CPR and first aid.

"One can't help hear those details and be impressed; but today I'd like to talk about the broader, and I hope enduring impact of Barry's legacy, and legacy was extremely important to him. But I don't mean legacy in the usual sense. Barry's motto was "allow people to teach you so you can teach those that come next". As a mentor, instructor and friend, Barry trained and advised countless members of the squad. Barry literally took his work very personally. He was the son, brother and father of First Aid Squad members. You might even say that for Barry, the Highland Park First Aid Squad was the "family business" and he saw it as his responsibility to ensure its continuity, professionalism and vitality.

"I'd suggest though, that for all of this, it's just possible that there was something very subtle about Barry that endeared him so much to us. His courage was inspiring, his bravery was unquestionable, and his personification of the CPR code "Never Give Up" was without peer. But in a time when people seek headlines, recognition and the fleeting futility through television, movies and social media, Barry worked not for recognition or reward, he served because it was the right thing to do. He served because he loved his community and he felt his service would be the most tangible and valuable expression of his love and devotion.

"Barry Criss left us a legacy of what public service truly means because Barry was a role model of what a public servant must be; devoted, ready to answer the call, a willingness to go above and beyond under virtually any set of circumstances, to be part of a team, and when the situation warrants, to be a leader. Barry understood that you serve the public because you want to live in and be a part of a community, to leave it better off than when you arrived, rather than simply take for granted that public service is a job for somebody else. The myriad things great and small that have transformed Highland Park from a wonderful community into an extended family to make it the special place that we all cherish didn't just happen by themselves. Barry understood this and he gave selflessly and tirelessly for decades. He didn't wait around to be asked or to hope that somehow our community might become better; he didall he could, in his own way, to make sure it did happen.

"Which leads me to what impressed me most and what I will always remember about Barry, his humility. If you met Barry you would not have known of his prolific achievements as a member of this squad unless somebody else told you, and Barry would not have encouraged, in fact he would likely have been embarrassed by that. He was gracious and considerate, a genuine and kind person with a heart the size of Highand Park.

"So today, even though Barry would probably blush, it's time for us to thank him and his family for his heroism, bravery, and dedication to service. We reveal ourselves today by honoring and remembering him by dedicating Barry Criss Way so that the legacy he left us and the inspiration that legacy should provide us can be properly preserved, perpetuated and promoted.

"To the Criss Family, on behalf of the Borough of Highland Park it is my honor and proud duty to say thank you. We are revealed today as we should be by thanking you for sharing Barry with us and by allowing us to remember and honor him by dedicating Barry Criss Way, to add his name permanently to the lexicon and geography of Highland Park. It is our hope that this is a suitable tribute to a wonderful person of refinement, generosity, commitment to community, and our humble and devote hero, Barry Criss. He has been and always will be missed, but he will always be loved, honored and remembered."

Mayor Minkoff asked the Criss family to come forward.

Councilwoman Foster-Dublin commented that when she first came on Council, the first committee she served on was Public Safety. One of the first people she met was Barry. He was always so calm no matter what was going on. He always reminded her of that movie "Cool Hand Luke". It was a pleasure to be with Barry, learn from Barry and have him as a mentor. When they were planning to name a street after him, they considered street, circle, but finally decided on "way" as it had to be Barry Criss' Way. Barry is truly one of Highland Park's treasures. She thanked his family for giving him to the Borough for so many years, we are truly grateful.

Mayor Minkoff read the proclamation and presented them with an embossed copy of the proclamation and the key to the Borough.

MaryLou Criss thanked Mayor Minkoff for honoring Barry.

There being no further business, on motion made by Councilman Millet, seconded by Councilwoman Brill Mittler, and carried by affirmative voice vote of all Councilpersons present, the meeting adjourned to the Conference Meeting at 8:11 PM.
