### Borough of Highland Park Identification Card Application Instructions

#### **OVERVIEW:**

- Applicants must be at least 14 years old and a resident of the Borough of Highland Park.
- Parents/guardians must show proof of relationship for any minor applying for an ID card.
- Identification Cards are valid for two years from time of issuance.
- Cost of ID cards are \$15 for adults; \$7 for seniors, veterans, and children (ages 14-17).
   Hardship waivers are available.
- Identification Cards are intended to assist in the identification of the valid cardholder for the purposes
  of obtaining services from the Borough of Highland Park and at the discretion of Highland Park businesses.

#### **HOW TO APPLY:**

Complete the Identification Card Application Form; collect documentation for both proof of identity (4 points) and residency (2 points) from the categories listed below; and present application, documentation, and payment to the **Highland Park Library** (31 North Fifth Avenue). Appointments to issue IDs must be made by calling the library at 732-572-2750.

#### SIX POINT VERIFICATION SYSTEM

Applicants must have at least four (4) points proving identity and two (2) points proving residency.

Applicants must provide at least one unique form of documentation for identity and for residency.

All documents must be originals. If expired, expiration must be two (2) years or less from the date of presentation.

#### **PROOF OF IDENTITY (4 POINTS)**

#### Four (4) Point Documents

- U.S. State Driver's License or Learner's Permit Photo ID U.S. State Identification Card
- Proof of a minor enrolled in Highland Park public or private school (minors ONLY)

#### Three (3) Point Documents

- Consular ID Card with photograph
- Current VISA U.S. Work Permit National Identification Card (must have photo, name, address, date of birth, expiration date)
- U.S. Birth Certificate
- U.S. Permanent resident (Green Card)
- U.S. Citizenship and Naturalization Certificate
- State Veterans ID with photo
- U.S. Military Identification Card
- U.S. or Foreign Passport

#### Two (2) Point Documents

- Foreign Driver's License
- Foreign Military Identification Card with photo
- Foreign Birth Certificate
- Vali NJ Auto Registration

#### One (1) Point Documents

- ITIN Card (must be accompanied by photo ID)
- Social Security Card
- Electronic Benefit Transfer (EBT) Card
- High School or College Diploma Voter Registration Card

#### **TERMS AND CONDITIONS**

The cardholder is responsible for paying any replacement fee when an Identification Card is lost, stolen, confiscated, or intentionally damaged, or when any information is changed at cardholder's request.

Identification Cards are non-transferrable.

Altering or intentionally damaging the Identification Card, using another person's Identification Card, or allowing the cardholder's Identification Card to be used by another person may result in confiscation of the card and violation of N.J.S.A. 2C:28.7.
