BOROUGH OF HIGHLAND PARK ORDINANCE NO. 20-1996

AN ORDINANCE TO AMEND AND SUPPLEMENT THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF HIGHLAND PARK, CHAPTER 247, "LICENSING"

BE IT ORDAINED by the Borough Council of the Borough of Highland Park, County of Middlesex, State of New Jersey, as follows:

SECTION I. Chapter 247, "Licensing", Article I, General Provisions, §247-4 "Application for license", is hereby amended to read as follows with the [bracketed] material to be deleted, and the underlined material to be added:

ARTICLE I General Provisions (§247-4. Application for License)

- A. Application for license hereunder, both new and renewal, shall be made to the Borough Clerk and shall contain the following information:
 - (1) Name and residence of applicant.
 - (2) Location at which business will be conducted.
 - (3) Name under which business will be conducted.
 - (4) Nature of business.
 - (5) [Names and addresses of three business references or Middlesex County residents who will certify to the applicant's good character and business responsibility.]
 - (6) If applicant has been arrested for any crime or disorderly offense, the dates, location and nature of such offenses and ultimate disposition thereof.
 - (7) If the applicant has been found guilty of or liable for wage theft, the dates, location, and nature of such wage theft and ultimate disposition thereof.
 - (8) Such additional pertinent information which the Borough Clerk deems appropriate.
- B. No license shall be issued until the approval of the [Chief of Police] <u>Zoning Officer</u> of the Borough of Highland Park shall have been endorsed thereon.
- C. [Where the Chief of Police shall require, due to experience with a particular kind of business, fingerprints of the applicant shall be submitted as a part of the application.]
- D. No license shall be issued to an applicant or business entity that has committed a wage theft violation which has not been cured by compliance with the order or decision of the governmental entity determining the same.

SECTION II. If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid by a court of competent jurisdiction, such invalidity shall not affect other provisions of the Ordinance and to this end the provisions of this Ordinance are declared to be severable.

SECTION III. This Ordinance shall take effect immediately upon final passage and publication in accordance with law.

BOROUGH OF HIGHLAND PARK ORDINANCE NO. 20-1997

AN ORDINANCE TO AMEND § 407-12 OF THE "CODE OF THE BOROUGH OF HIGHLAND PARK, 2010" ESTABLISHING A FEE SCHEDULE FOR BASIC TOWING SERVICE AND STORAGE FEES.

BE IT ORDAINED by the Highland Park Borough Council, Middlesex County as follows:

§ 407-12 of the "Code of the Borough of Highland Park, 2010" concerning the establishment of basic towing service and storage fees is amended to read as follows:

§407-12. Fee schedule.

A. No person shall be liable to any tow operator who tows or stores an automobile for any fees in excess of the following:

[The above fees are set by the Commissioner of Insurance pursuant to N.J.A.C. 11:3-38.1 et seq., and shall be superseded by any fee changes implemented by the Commissioner. It shall be the responsibility of the tow operators to comply with all applicable Department of Insurance rules and fee regulations.]

- (1) All tow operators or storage facilities shall comply with the requirements of N.J.S.A. 56:13-7 et seq. and any and all regulations promulgated by the New Jersey Department of Law, Division of Consumer Affairs. As required by N.J.S.A. 40:48-2.54.b. all complaints and disputes arising from the towing and storage of motor vehicles without the consent of the owner shall be called to the attention of the Chief of Police in writing to be investigated and resolved.
 - (2) Applicability of rates.
 - (a) When towing services are required at the scene of an automobile accident, the day rate shall apply when the time of the accident is between 8:00 a.m. and 4:30 p.m., Monday through Friday, except New Jersey State holidays. The night, weekend and holiday rate shall otherwise apply.



- (b) When towing services are otherwise required, the day rate shall apply when the vehicle is transported (pickup to delivery) entirely between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday, except New Jersey State holidays. The night, weekend and holiday rate shall otherwise apply.
- (3) Storage fees are for each twenty-four-hour period or fraction thereof. A new twenty-four-hour period begins at 12:01 a.m.
- (4) For the storage of motor vehicles at all times other than those instances involving theft or accident the fee shall be \$20 per diem.
- B. No person shall be liable to any tow operator for any other towing or storage services for any fee in excess of the licensee's approved fee schedule. Current fee schedules shall be submitted for approval of an annual basis at the time of application for license renewal.
- C. When basic towing services are rendered, there shall be no additional charges other than those provided for in Subsection A above, including but not limited to flatbedding, waiting time, winching, cleanup costs and additional labor.
- D. Towing rates shall be calculated based on the total distance traveled from the tow vehicle's base of operations to the job site and return, by way of the shortest available route. Fractions shall be rounded to the nearest whole.
- E. Tow vehicles transporting multiple vehicles at one time may charge the applicable fee for each vehicle transported.
- F. Prior to hookup or flatbedding of a motor vehicle, the tow operator shall present a copy of its fee schedule to the owner or operator of the vehicle. The fee schedule shall also contain the name, address and telephone number of the two operator and a statement of the hours when the motor vehicle may be claimed.

This ordinance will take effect upon its passage and publication as provided for by law.

WHEREAS, under § 230-23 of the "Code of the Borough of Highland Park, 2010" Terms of the Class IV of the Borough of Highland Park Planning Board run from September 1, of the year in which the appointments are made; and

WHEREAS, the Council of the Borough of Highland Park wishes to have the terms of the Class IV members commence on January 1 of the year in which the appointments are made; and

WHEREAS, § 230-35 of the said Code provides for the appointment of members of the Borough of Highland Park Zoning Board of Adjustment to run from July 1 of the year in which the appointments are made; and

WHEREAS, the Council of the Borough of Highland Park wishes to have the terms of the members of the Board commence on January 1 of the year in which the appointments are made; and

WHEREAS, the Council does not wish to affect any current standing members of either the Borough of Highland Park Planning Board or the Borough of Highland Park Zoning Board of Adjustment while the appointment dates and commencement of term dates are changed to January 1 of the year in which the appointments are made.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Highland Park, Middlesex County as follows:

1. § 230-23.F. of the "Code of the Borough of Highland Park, 2010" which sets forth the commencement of terms of Class IV Members of the Borough of the Highland Park Planning Board is amended to read as follows:

§ 230-23. F. All terms shall run from [September 1] <u>January 1</u> of the year in which the appointment is made, except as otherwise specified herein. In transitioning from terms of Class IV Members running from September 1 of the year in which the appointment is made to January 1 of the year in which the appointment is made, this Code amendment shall not be construed to effect any standing member of the Borough of Highland Park Planning Board. If a current Class IV member of Borough of Highland Park Planning Board's term shall expire on September 1, 2020, said Class IV member may be appointed for an interim term from September 1, 2020 to December 31, 2020. Thereafter, said member may be considered for a new term commencing January 1, 2021.

2. § 230-35 of said Code concerning appointments to the Borough of Highland Park Zoning Board of Adjustment is amended to read as follows:

§Section 230-35A. A Zoning Board of Adjustment is hereby established pursuant to *N.J.S.A.* 40:55D-69 *et seq.*, consisting of seven residents of the Borough appointed by the Mayor with the advice and consent of Council to serve for a term of four years from [July 1] <u>January 1</u> of the year of their appointment. The terms of the members first appointed shall be so determined that, to the greatest practicable extent, the expiration of such term shall be distributed evenly over the first four years after their appointment, provided that the initial term of no member shall exceed four years. Thereafter, the term of each member shall be for four years. [Nothing in this Chapter shall, however, be construed to affect the term of any present member of the Zoning Board of Adjustment, all of whom shall continue in office until the completion of the term for which they were appointed.]

In transitioning from terms of office for members running from September 1 of the year in which the appointment is made to January 1 of the year in which the appointment, this Code amendment shall not be construed to affect any standing member of the Borough of Highland Park Zoning Board of Adjustment. If

a current member of the Borough of Highland Park Zoning Board of Adjustment term shall expire on July 1, 2020, said member may be appointed for an interim term from July 1, 2020 to December 31, 2020. Thereafter, said member may be considered for a new term commencing January 1, 2021.

3. This Ordinance shall take effect upon its passage and publication as provided for by law.

("Taxpayer"), the owner of 1018 Raritan Avenue, Block 89, Lot 2 on the Borough of Highland Park Tax Assessment Maps (the "Property"), filed appeals of its 2016, 2018 and 2019 tax assessments in the Tax Court of New Jersey, Docket Nos. 010208-2016, 010687-2018 and 009403-2019; and
