A Regular Meeting of the Highland Park Mayor and Council was held in Borough Hall, 221 South 5th Avenue, on Tuesday, December 17, 2019, and was called to order by Mayor Brill Mittler at 7:00 PM. Mayor Brill Mittler read the Open Public Meetings Statement.

Present: Mayor Brill Mittler, Councilpersons Fine, Foster-Dublin, George, Hale, Welkovits; Borough Attorney Schmierer; Borough Administrator Jover; Deputy Clerk Santiago.

Absent: Councilperson Kim-Chohan; Borough Clerk Hullings.

On motion made by Councilman George, seconded by Councilman Fine, the minutes of the Regular and Conference Meetings held on July 2, 2019, August 6, 2019 and September 3, 2019, were approved as distributed by the following roll call vote, to wit:

Ayes: Councilpersons Fine, George, Hale, Welkovits.

Opposed: None. Absent: Councilperson Kim-Chohan. Abstain: Councilperson Foster-Dublin,

Mayor Brill Mittler asked the Council members to present their reports.

Councilman Hale reported that the Main Street Highland Park building is now accessible with the installation of a wheelchair ramp. There will be a presentation on December 18<sup>th</sup> at 8:00 p.m. at the Conservative Temple on the results of a study done on anti-Semitism. Interested residents must register to attend. The Borough's new website is just about up and ready. It is user friendly, has quick links and is easier to navigate. Residents will be able to track what is going on with the Borough Council and the Boards and Commissions. It has been a long process and he thanked the Public Information Commission, Monica Jackson and Emma Missey for their efforts.

Councilwoman Welkovits reported that last Thursday, the Planning Board approved a yearlong project, the Master Plan. She thanked Jim Constantine and Chris Cosenza for their efforts and for the new zoning map. There will be a menorah lighting on December 22<sup>nd</sup> at 4:30 p.m. at the new pavilion, which was made possible by a matching grant from the DCA for downtown. The idea is to create a small area to mark downtown and the pavilion has been used several times this week. On December 26<sup>th</sup> there will be a Kwanzaa celebration at Kinetics.

Councilwoman Foster Dublin reported that due to the inclement weather, Highland Park has a Code Blue at the Community Center. Anyone who needs information should contact the Highland Park Police Department. The community center will open at 7:00 p.m., with a cutoff of 9:00 p.m. and attendees must be out by 7:00 a.m. the next morning so that the Community Center can prepare for the day's activities. Highland Park has been experiencing a number of break ins. Residents are urged to lock their homes and their cars. She encouraged residents to utilize the sidewalks when walking as it is getting darker earlier and the sidewalks are covered with leaves, ice, etc. On Friday at 4:30 p.m., the Teen Center will be celebrating Christmas and Santa will be making an appearance.

Councilman Fine reported that he attended the Library Board meeting last night and the children and teen book sale raised \$2,000. He wished everyone a Happy Holiday.

Councilman George wished everyone a Happy Holiday and reported that volunteers were out working in the Meadows Trail in the inclement weather. He thanked them for their dedication. On the agenda tonight they will be voting on a grant submission for a roots for rivers reforestation grant and a grant submission for a clean fleet electric vehicle incentive program. He played a scam phone message from his cell phone and warned residents, especially seniors, that social security does not contact you via phone.

Borough Administrator Jover reported that she received a report from the drone survey for the counting of the deer in town. She sent the report to the Division of Fish and Wildlife. The Borough will hold a community meeting with representatives from the Division to go over next steps. Highland Park was recertified at silver level at the League of Municipalities Conference. They will continue to work on getting Highland Park to the next level.

# Borough Attorney Schmierer- No report.

Mayor Brill Mittler reported that this is year 5 of the Park Partners Program. They will hold a public display in late February where residents can view the various submissions and cast their votes in the five different categories. Submissions are due by January 10<sup>th</sup>. Last week, there was a horrible act of anti-Semitism in Jersey City, which is a very diverse community with a lot of rentals like Highland Park. There was a vigil held last week for the victims and she thanked those who attended to share in the grief. Four lives were lost as a result of this senseless violence. Chief Abrams and members of his department attended the funeral for the Jersey City Police Officer that was killed.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

Herb Gross, Adelaide Gardens, commented that he wanted to take a moment to extend an invitation to everyone to visit the Veteran's home in Edison, New Jersey. It is a beautiful facility and if anyone is uneasy, he will go with them. The veterans would appreciate people stopping by to say hello. Councilman George asked for a contact number. Mr. Gross provided the phone number for Commander William Young, 732-995-7501.

No one else appearing to be heard, the Mayor closed the public discussion.

The Clerk reported advertising an ordinance entitled, AN ORDINANCE TO AMEND AND SUPPLEMENT THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF HIGHLAND PARK, CHAPTER 328, "SEWER AND WATER", for consideration of passage on final reading by title and that affidavits of publication thereto are on file. <u>Water and Sewer RFP Update</u> – Borough Administrator Jover reminded everyone that she and Greg Fehrenbach have been working with McManimon and Scotland to draft the RFP and contract to go out to bid for operations and maintenance of the water and sewer system in the Borough. They have a strong draft developed and have shifted to a State Comptroller and have shared it with the Public Works and Public Utilities Committee. There is still time to make changes. The State Comptroller has 30 days to send back comments. They need to present plan to the DPW union as members of that union are directly impacted. The union is aware of the RFP and the plan is to have those employees to be put in the Public Works Department. The time line is fairly aggressive and the need to publish the notice by January 21<sup>st</sup>. Proposals are due February 21<sup>st</sup> and they plan to have a pre-proposal meeting in early February. They are looking to award the contract and start in June, 2020. The municipal budget will reflect this change.

<u>Final Review of Goals</u> - Councilman Fine noted that they are pursuing shared services for the Municipal Court. They had a meeting with representatives from New Brunswick, North Brunswick and Piscataway. The Court Administrator collected information to see if there would be a savings. More details to follow as they explore this possible option further.

<u>Reorganization Reports</u> – Mayor Brill Mittler wanted to confirm that she will be giving a Mayor's report only at the Reorganization Meeting to save time. The Council Members all concurred that there will only be a Mayor's report.
