REGULAR MEETING - JANUARY 21, 2020

A Regular Meeting of the Highland Park Mayor and Council was held in Borough Hall, 221 South 5th Avenue, on Tuesday, January 21, 2020, and was called to order by Mayor Brill Mittler at 7:02 PM. Mayor Brill Mittler read the Open Public Meetings Statement.

Present: Mayor Brill Mittler; Councilpersons Foster-Dublin, Hale, Kim-Chohan, Welkovits;

Borough Attorney Schmierer; Borough Administrator Jover; Borough Clerk Hullings.

Absent: Councilpersons Fine, George.

Mayor Brill Mittler asked the Council members to present their reports.

Councilwoman Foster Dublin reported that the Teen Center last month provided meals for 31 families. They also had a teen Christmas party that was well attended. They had free photos for 25 families for Christmas portraits. On Saturday, from 4:00 p.m. to 10:00 p.m. they will hold a dance off with other community centers. They will be able to include all teens in Highland Park as the event will be held after sundown. There is also a discussion group that will be put together and the teen center has received a NASA grant that they will be working on. The retaining walls are up at the Teen Center and the pavers are being put in. Come spring, all the construction work will be done and the next phase will be the plantings. They are looking at where they can do some murals and they are also looking for artists.

Councilwoman Kim-Chohan wished everyone a Happy New Year. Some Council Committee Chairs have changed. She enjoyed her time working with the Arts and Recreation Committee, but she is looking forward to joining the Board of Health, the Commission for Universal Access, Community Food Pantry, Housing Authority, HP Gives a Hoot, Human Relations Commission and the Mayor's Wellness Campaign. She has not yet attended all the meetings yet, but stay tuned next month for a full update. If you are interested in volunteering on any of those committees, you can stop at the Clerk's Office for an application. She addressed the anti-Semitic attacks that have been happening in the Orthodox community. Since the last heated meeting where she voted to table the anti-Semitic resolution, she has learned a lot from educational seminars and research on her own. Sadly, she didn't have to go far with attacks happening just 30 minutes away from here. When you know better, you do better. She is asking her fellow Council colleagues that were torn last year, just like herself, let's do better and pass the anti-Semitic resolution. Yesterday was MLK day and this quote from him seems so fitting – "in the end we will remember not the words of our enemies, but the silence of our friends".

Councilman Hale thanked Councilwoman Kim-Chohan for her strong words. He noted that the Art Academy of Highland Park is one of the businesses that might be interested in working on the mural. They have done murals in the past and both of his kids have gone through their process and they are a great resource for young artists. He is now the Economic Development and Planning Chairperson and is very excited to be a part of the Planning Board and Zoning Board and Main Street Highland Park. He wanted to let everyone know that the ramp to Main Street Highland Park has finally been installed. He thanked Scott Brescher and Teri Jover for all of their hard work in making that happen. He also thanked the Commission for Universal Access for pushing this work. He wished a very special happy birthday to former Council Member Matt Hersh.

Councilwoman Welkovits reported that it was a pleasure to serve on the Economic Development and Planning Committee for about three years and they made a lot of progress. The old international market (Popov Project) is nearly finished and that was one of the first new buildings on the avenue in about 20 years. They have also worked on the redevelopment agreement for 31 River Road and they amended the redevelopment agreement for the property across from the Popov unit and they met their COAH obligation for the first time in 20 years. Goodbye to 20 years of litigation with low income housing and with the cynical developers that try to come in and build high density housing instead. The Planning Board did a great job in reviewing the master plan and they met that goal in December. It was approved and the bike pedestrian plan that they were awarded through the NJ Department of Transportation was also adopted as part of that plan. They had another \$220,000 award from the Department of Transportation for the Safe Walking and Cycling Committee. The Main Street pavilion looks beautiful and they have been using it, even before it was finished and they are thrilled with it. It creates a sense of space and a sense of borough square, center of town, and they are thrilled with that and Main Street has more things planned for next year. She thanked them for keeping the residents engaged and involved by having activities every weekend throughout the year. She will now be chairing the Finance Committee. She thanked several people and departments for something personal that happened to her the day before Christmas. At 3:30 AM she was awakened by the sound of a truck idling. She got up and looked out and saw that her neighbors house behind her was in flames. She quickly got dressed and went outside. The first people she stumbled upon was the First Aid Squad, David and Robin Loewentstein. Nobody was in the house as the resident was away. She then saw the Police Department (Officers Garrity and Edens) and the Fire Department with about a dozen of them in the backyard. She thanked the Fire Department, Police Department, First Aid Squad, Code Enforcement, County Fire Marshall and the Department of Public Works. She also thanked those fire departments that responded in mutual aid. Thank you for keeping us safe and Happy New Year!

Borough Administrator Jover reported that she has received a lot of inquiries about the work being done by PSE&G in town. They have an aggressive gas main replacement program going on in 2020. These are improvements to make us safer in the long run, but we have to endure the disruptions while they are here. If your home is impacted, you should have received a door hanger and you should get reverse 9-1-1 calls before they are on your street and we are working with them with doing a better job on parking signage being posted a couple of days in advance and not just 24 hours prior. When they are done with the replacement, they will come back in the spring to do road restoration. They will post on the website a link to PSE&G's website which gives the complete list of roads that are impacted by the program. In addition to doing the roadways, they are also doing service connections and must deal with individual homeowners and make arrangements to do that. The bulk of the work should be done in the next month.

Borough Attorney Schmierer- No report.

Mayor Brill Mittler reported on things that have happened over the last couple of weeks in Highland Park. Many of us who have been watching the rise of hate in, not only our community, but in the country, have been walking around in disbelief of what this country and the people who live here are capable of. Councilman Kim-Chohan touched on some of that before. Over the last of couple of weeks after two events that she was fortunate enough to attend, she has hope again. Last week, the Sisterhood of Salaam Shalom had one of their vigils against hate and anti-Semitism, which was held in the Highland Park High School cafeteria. There were over 300 people in attendance from every walk and every faith in our community and beyond. That entire evening and the things that were said, prayers shared by the people of faith, the words that were shared by those that same up to speak gave her hope for this country. The, just last night, picking up on that theme of unity, the Human Relations Commission had their annual Dr. King event. It was a beautiful event and there were speakers from both the Rutgers NAACP Chapter and Rutgers Hillel. The point that was being made was that we cannot continue to work in our individual silos, we must support each other against the hate that has been unleashed in this country and the only chance that we have of standing up against that and moving forward and moving this country back to the type of civilization that it was meant to be, is for us to support one another. When you see someone at our farmers market being told to stop speaking Spanish and start speaking English in America, when you see an observant Jewish person walking down the street on Raritan Avenue being harassed, step up and say something. When you see someone throwing something at a member of the LGBTQ community, don't just stand there, do something. We must stand up for one another and that became clearer than ever over these last couple of weeks. She thanked everyone in Highland Park who came out to those two events and she hopes that that hope that she was given and many other people she has spoken with can stay with us and change and move into action.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

John Valeri, 106 South 6th Avenue, commented about the Karsey Street Park that used to have a basketball court, but in 1994, the rims were removed. The park was being abused with littering and the basketball court eventually got removed. There used to be a family that lived next door to the park that constantly filed complaints about noise, etc. He asked if there is a way to get the basketball court reinstalled. Mayor Brill Mittler noted that Councilman Fine is the Council Liaison to the Recreation Commission and she will have him take it up with his committee. Mr. Valeri further commented that he was harassed by the Police Department back in the day and experienced hate. He was continuously followed by that Police Officer. He is glad that the Council is taking a stand against hate.

Herb Gross, Adelaide Gardens, commented about the commemoration of the Battle of Iwo Jim 75 years ago. The greatest Mayor of all time who served in Iwo Jima as a Marine, was Harold Berman. He took care of the residents and the veterans. He saluted former Mayor Berman and former Mayor Tanzman. Councilwoman Foster-Dublin noted that yesterday, a naval officer, Doris Miller, who was at Pearl Harbor during attack and manned a gun and attended to wounded, will have an aircraft carrier named after him.

Abby Stern Cardinale, Harper Street, asked about an update on the discussions the Council has been having about the structure of the meetings and when public comment is allowed and what the topic of the comment is and also making sure that every open public meeting has a public comment section. Mayor Brill Mittler noted that the format that they have been following last time and today, is pretty much where they are going to be going forward. The Borough Attorney is actually working on and relooking at all of our Rules of Order because there were other things as well that needed to be updated based on new laws passed regarding OPRA and OPMA and lots of other updates. Once he has completed going through everything, then the format will be part of that. There are two public discussions. They begin at 6:30 p.m. with the agenda meeting, which is where Council Members can ask questions about agenda items. At the Regular Council Meeting there are 2 sessions for public comment. The first session is limited to 15 minutes, 3 minutes per speaker. The second session is limited to 3 minutes per speaker on any item and is subject to 9:00 p.m. conclusion. The reason for the 9:00 p.m. conclusion is in the rules of order. They are supposed to be completed with their work session by 10:00 p.m. Ms. Stern Cardinale noted that the first public comment session is supposed to be limited to items on the agenda and the second session is open. She asked if the work session is a separate meeting or part of the regular meeting. Mayor Brill Mittler noted that they take a five-minute break and move to the table below the dais and discuss items on the work session. Ms. Stern Cardinale wanted to clarify which meetings are supposed to be videotaped as they are done by volunteers. Mayor Brill Mittler noted that traditionally the regular meeting has always taped. They have not spoken to HPTV volunteer about their quit time and whether he would stay for the work session. Ms. Stern Cardinale commented that she knows everyone is a volunteer, but she feels they should solicit additional volunteers and encourage all of those meetings if they are open.

No one else appearing to be heard, the Mayor closed the public discussion.

WHEREAS, the United States Congress authorized the Defense Logistics Agency (DLA) Law Enforcement Support Office (LESO) 1033 Program to make use of excess Department of Defense personal property by making that personal property available to municipal, county and State law enforcement agencies (LEAs); and

WHEREAS, DLA rules mandate that all equipment acquired through the 1033 Program remain under the control of the requesting LEA; and

WHEREAS, participation in the 1033 Program allows municipal and county LEAs to obtain property they might not otherwise be able to afford in order to enhance community preparedness, response, and resiliency; and

WHEREAS, although property is provided through the 1033 Program at no cost to municipal and county LEAs, these entities are responsible for the costs associated with delivery, maintenance, fueling, and upkeep of the property, and for specialized training on the operation of any acquired property; and

WHEREAS, N.J.S.A. 40A:5-30.2 requires that the governing body of the municipality or county approve, by a majority of the full membership, both enrollment in, and the acquisition of any property through, the 1033 Program; and

BE IT FURTHER RESOLVED that the Highland Park Police Department shall provide a quarterly accounting of all property obtained through the 1033 Program which shall be available to the public upon request; and

BE IT FURTHER RESOLVED that this resolution shall take effect immediately and shall be valid to authorize requests to acquire "DEMIL A" property and "DEMIL B through Q" property that may be made available through the 1033 Program during the period of time for which this resolution authorizes; with Program participation and all property request authorization terminating on December 31st of the current calendar year from January 1, 2020 to December 31, 2020.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

John Valeri, South 6^{th} Avenue, commented about the condition of his street and it is really dangerous with snow and ice. His street has been in this condition for $2\frac{1}{2}$ years and he has filed complaints. Borough Administrator Jover noted that the road is being engineered to be resurfaced in 2020. She will have the Department of Public Works take a look at it and have them do interim patching. The project to repave the road needs to be put out to bid.

No one else appearing to be heard, the Mayor closed the public discussion.

A five minutes recess was taken at 7:42 p.m.

Meeting reconvened at 7:48 p.m.

Work Session:

<u>Census 2020 Count Initiative</u> – June Burton, Partnership Specialist with the US Census Bureau, appeared to give a presentation on behalf of Udi Shorr. The 2020 Census will determine congressional representation, inform hundreds of billions in federal funding every year, and provide data that will impact communities for the next decade. Highland Park has three census tracts. Last census Highland Park was undercounted by approximately 3,188. There are three ways to respond to the census: online, phone and paper. The census will be available in 12 languages. There are 9 basic questions and citizenship is not on there. There are no questions relating to gender. Questions 1 through 4 are about the household. Questions 5 through 9 are about individual residents. Online responses close on April 27th. The door to door campaign will begin in May.

Resolution to Purchase three (3) new police vehicles – Borough Administrator Jover noted that the money was authorized for the purchases as part of the MCIA Lease Program. The program was not used in the last couple of years, so we are playing catch up. They plan to get 2 vehicles for Public Works and 2 vehicles for Code Enforcement. They are waiting on a charging station grant and hoping to have resolutions to purchase through state contract.

STAC Mailing — Borough Administrator Jover noted that last May the Shade Tree Advisory Committee did something different. They want to take a zoned approach this time and identified a zone on the South Side. A mailing was sent from STAC to homeowners in the zone and providing an option to opt out. The bid to approve the tree planting is on the consent agenda. Looking at planting 117 trees at residences who want them and others in the target zone. They have ideas for better success for watering the newly planted trees. Councilman Hale asked about the PSE&G work and trees being planted in the work areas. Borough Administrator Jover noted that the Governing Body endorsed this five-year plan. The trees to be planted are 3" in caliper. A lot of planting was done on Lincoln Avenue and Madison Avenue and it brightened up the streetscape. Need to be positive and encourage it. Before a tree is planted, there is a second mailing that would be sent out. Mayor Brill Mittler noted that the Borough Administrator should have Communications publicize this project. Borough Administrator Jover noted that there are 117 trees to be planted at 113 households. Can do social media and other announcements. STAC worked very hard on the tree species and identified trees that would work well with sidewalks.

Board of Health Condom Proposal — Councilman Hale explained that the Board of Health bought 3,500 condoms (24 cases). The intention was to distribute them at the schools. The School Board Liaison for the Board of Health is beside themselves and the Board of Health is mad. They want to do social action to hand them out. He promised to share their concerns. Councilman Kim-Chohan noted that the School Board changed their liaison. He will try to go back to the Board. She sent Councilwoman Foster-Dublin an email for the Teen Center. Councilwoman Foster-Dublin noted that she would prefer to give them to the Social Worker at the Community Center. Councilman Hale noted that his sense is that his topic never went to the Board of Education. Mayor Brill Mittler noted that they should look into another channel. There is a high rate of STD's in nursing homes. It was suggested to find another group in town. Councilwoman Welkovits suggested leaving supply with school nurse. Mayor Brill Mittler noted than when a Board/Commission wants to spend money on something that might be controversial, it needs to be discussed prior to approval. Councilwoman Foster-Dublin suggested contacting the Peer to Peer Group.

<u>Re-Writing and Improvement Disabled Parking Ordinances</u> – Councilman Hale noted that the Commission for Universal Access would like the wording in the Borough's ordinances changed from handicapped to accessible. Diane Feldman has volunteered to help. Borough Clerk to search Code Book for chapters that need updating.

<u>Changes to Tree Ordinance</u> – Public Works Committee Recommendation – Councilman George noted that Borough Staff met with representatives of the Shade Tree Advisory Committee to discuss the ordinance. Key changes made were that for a lot of the trees, the calipers were too small, and were weed trees. All the groups are jointly recommending to increase trees that are counted from 3" to 8", and to change fee for permit to \$25 from \$100. The goal is to make it more clear for what the rules are. The ordinance will also clarify what STAC's role will be. When you get a permit, you can put in another tree or pay into the tree fund. The ordinance will increase the way it is enforced. They are trying to be fairer to residents. Councilwoman Welkovits noted that residents in town don't realize you need a permit.

<u>Deer Survey – Next Steps</u> – Borough Administrator Jover noted that she distributed the report via email that was done by Raritan Valley Community College. There are a lot of deer in Highland Park. The majority of the deer are on the South Side near the Park. There are also a lot of deer near and in the Rutgers Ecological Preserve and Johnson Park. She shared the report with the Division of Fish and Wildlife Services. They suggested she get all parties in the room to see how they can contribute with the deer issue in Highland Park. She will work on putting that meeting together. The public was promised access to the report and that the Division of Fish and Wildlife would come back to Highland Park for a meeting. The bulk of the deer are on properties that the Borough does not control. Councilman Hale suggested getting tat

meeting together soon so as not to miss another season. Mayor Brill Mittler suggested that they mobilize the residents to write to the Freeholders. Borough Administrator Jover noted that she will work on scheduling meeting with Fish and Wildlife and invite the other agencies. She would like to post the report on the Borough's website.

NJLM Light Up Public Spaces for Suffrage – Mayor Brill Mittler would like the Borough Council to consider passing resolution that would light up public squares for suffrage and to remind people about celebrating the 100th year of women's right to vote. Resolution to be considered on the February 4, 2020 meeting for action.

<u>Water Filling Station – Raritan Avenue</u> – Councilman George noted that the Borough approved a resolution for a grant for Sustainable Jersey and Sustainable Highland Park wants to install a water filling station, water fountain, and dog filling bowl on Raritan Avenue. Project would be subject to money being available in the budget. This would be in line with the placemaking events held last year. Borough may have to contribute matching funds and this project could be expensive. Idea is to install on Borough owned property.

The following resolution, introduced by the Council as a Whole, was duly adopted on motion made by Councilwoman Welkovits, seconded by Councilwoman Foster-Dublin, and carried by the following roll call vote, to wit:
