Ms. Jover said there are no comments; this was a hold over from the prior meeting.

### **Public Comment**

Mayor Brill Mittler open the floor to the public.

Dean Adi, owner of Block 173, Lots 44 & 45 said that no one has reached to him to make a reasonable deal, he read the meeting minutes of the last meeting and the Town Planner said that you had tried to reach out to make a deal and make a generous offer and I refused and wanted it to be clear that that is totally bogus and false. The law firm that the Borough hired to do the condemnation reached out and offered \$50,000 for his property, which he feels, is absolutely offensively ridiculous, there was no attempt to engage in any good faith negotiations what so every. He has been coming to the meetings in hopes that there would be some sort of good faith effort to buy his property but there has not been. Whatever this passing of this resolution about securing the property and engaging in negotiations, how does he see, the whole process has been happening behind the scenes in the dark and he is patiently waiting for someone to reach out to him and begin to negotiate to buy his property. Mayor Brill Mittler indicated that they would take that under advisement and indicated that both the Planner and Attorney were on the line tonight and asked if they had anything to add.

Mr. Baumann indicated that his office had reached out to Mr. Adi a few months back and would be happy to speak with him again. Mr. Adi said yes and there was a \$50,000 offer and if that is reasonable please condemn but that is not market value. He said that he would much rather fight in court if the town's intention is to devalue his property and give him some bogus number like that. There is no property in Highland Park that would sell for \$50,000 and he has two. Mayor Brill Mittler said tat they would take that under advisement.

There being no one further, public comment was closed.
