CALENDAR YEAR ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A:4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 1% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Mayor and Borough Council of the Borough of Highland Park in the County of Middlesex finds it advisable and necessary to increase its CY 2021 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Mayor and Borough Council hereby determines that a 3.5% increase in the budget for said year amounting to \$339,170.98 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Mayor and Borough Council of the Borough of Highland Park hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Highland Park, in the County of Middlesex, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2021 budget year, the final appropriations of the Borough of Highland Park shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5% amounting to \$474,839.37 and that the CY 2021 municipal budget for the Borough of Highland Park be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED that a certified copy of this ordinance, upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

MEMORANDUM OF UNDERSTANDING

by and between the

owned and maintained by the County of Middlesex and the Middlesex County Prosecutors Office for the period of January 1, 2021 to December 31, 2021

PREAMBLE

WHEREAS, the Middlesex County Prosecutor, by statute serves as the Chief Law Enforcement Officer for the County of Middlesex, and as such is charged with, inter alia, the responsibility of providing for the safety and welfare of the citizens of Middlesex County and does so by ensuring that the law enforcement professionals that serve said citizens are provided with state of the art equipment in support of homeland security; and

WHEREAS, the United States Department of Homeland Security has heretofore established the Urban Area Security Initiative, hereinafter referred to as "UASI", which is a homeland security designation and is based upon the nature of the infrastructure located within the designated Counties and Municipalities in the State of New Jersey as well as the potential risks that exists within those designated Counties and Municipalities in the State of New Jersey; and

WHEREAS, Middlesex County is one of seven (7) counties in the State of New Jersey, which includes two (2) core cities, that qualifies as a *UASI* jurisdiction, and

WHEREAS, the Law Enforcement Subcommittee of the *UASI* has funded the purchase of specialized investigative equipment for each county and core city in the *UASI* region to be utilized and deployed on an "as-needed, priority" basis to support homeland security initiatives; and

WHEREAS, the Middlesex County Prosecutor's Office, herein after referred to as "MCPO", may have other specialized investigative law enforcement equipment purchased via other funding sources in its inventory; and

WHEREAS, the specialized investigative equipment issued to, owned and/or maintained by the *MCPO* may, at the discretion of the Prosecutor, be made available for use by other law enforcement agencies in the County of Middlesex or the UASI region to deter and detect crime;

WHEREAS the Prosecutor reserves the right to re-direct the assignment of specialized investigative equipment previously committed for use by one law enforcement agency for a particular event to a different law enforcement agency based upon priority, such as the nature of the one event over another, events that pose a greater risk to public safety, etc.;

WHEREAS law enforcement agencies that wish to be considered to have this specialized investigative equipment made available for use within their respective entity are hereby required to enter into this Memorandum of Understanding (MOU);

WHEREAS said law enforcement agencies that voluntarily enter into this *MOU* with Middlesex County are herein after referred to as "participating law enforcement agencies";

WHEREAS, the County of Middlesex and the *MCPO* have established a partnership for collaborative efforts with *participating law enforcement agencies*, the State of New Jersey Office of Homeland Security and Preparedness, and the United States Department of Homeland Security to provide for the safety and welfare of the citizens of Middlesex County by participating in the use and/or deployment of such specialized investigative law enforcement equipment;

NOW, THEREFORE, BE IT RESOLVED that the parties of this *MOU* agree that the PREAMBLE above is included herein and shall have full force and binding effect and that the specialized investigative law enforcement equipment will be made available for use on as as-needed, priority basis, subject to the following provisions:

A. **EQUIPMENT AND TRAINING**

 Specialized investigative law enforcement equipment shall, at the discretion of the MCPO, be made available to and utilized solely and exclusively by participating law enforcement agencies. Criteria for receiving the designation as participating law enforcement agencies

- includes, but is not limited to, execution of this *MOU* and the providing of all requisite documentation prior to the equipment being loaned to said agencies.
- Specialized investigative law enforcement equipment shall be operated and utilized solely by authorized personnel employed by participating law enforcement agencies. Said personnel must successfully complete the established training requirements for the use/operation of said equipment. The training shall be administered by a staff member of the MCPO.
- 3. The participating law enforcement agencies shall assume full responsibility for the care, maintenance and/or damages to the specialized investigative law enforcement equipment during its use and/or while said equipment is in their custody.

To the extent that the intended use of the specialized investigative law enforcement equipment is anticipated to cause more than normal wear and tear such that there will be a material decrease in the anticipated useful life of the specialized investigative law enforcement equipment, the MCPO reserves the right to impose a reasonable fee upon the participating law enforcement agencies for the use of said equipment. The MCPO also reserves the right to impose a late fee in case specialized investigative law enforcement equipment that is in high demand by other law enforcement agencies is not returned prior to the agreed upon date of return (as set forth in B.(2) below), and the MCPO has not agreed to any extensions of time. The amount of the late fee shall be agreed to prior to the lease of said equipment.

B. **DEPLOYMENT**

- Specialized investigative law enforcement equipment will be stored at a MCPO facility and will be made available to participating law enforcement agencies for use on an "as-needed, priority basis", subject to availability and requisite approval.
- 2. The participating law enforcement agencies hereby agree to provide individual formal written requests to the MCPO for each event in which the use of specialized investigative law enforcement equipment is sought. The request shall contain a detailed explanation describing the equipment being requested, the event in which it is to be employed, the reason it is needed and the intended duration (dates/times) that it will be needed.
- 3. The participating law enforcement agency agrees to provide proof of an insurance rider with either each request submitted, or for a calendar year if the rider is applicable to the type of equipment the agency is seeking to utilize. The Certificate of Insurance shall always carry and

maintain during period of use the following insurance coverage with an insurance company or companies acceptable to the County, with limits not less than those shown below. A Certificate of Insurance shall be filed with the County prior to commencement of use.

- a. Commercial General Liability (CGL): Coverage for all operations including, but not limited to, contractual, products and completed operations, and personal injury with limits no less than \$1,000,000 per occurrence/\$2,000,000 aggregate. The County of Middlesex, its officers, officials, employees, and volunteers shall be included as an additional insured.
- Automobile Liability: Coverage for all owned, non-owned and hired vehicles with limits not less than \$1,000,000 per occurrence, combined single limits (CSL) or its equivalent.
- c. Workers Compensation: As required by the State of New Jersey and Employers
 Liability with limits not less than \$1,000,000 per accident for bodily injury or disease.
- d. Property Insurance (equipment): Against all risk of loss to real and personal property of County while in User's care, custody, and control.

Additional Insurance Provisions

- Any combination of primary and umbrella/ excess may be used to satisfy the Limits.
- Waiver of Subrogation: The insurances shall contain Waiver of Subrogation provisions, as allowed by law, in favor of the County.
- Primary Coverage: The Certificate of Insurance should indicate that all insurance coverage's will be provided on a primary, non-contributory basis as respects to the County of Middlesex, its officers, officials, employees and volunteers.
- Notice of Cancellation: Each Insurance Policy required above shall provide that coverage shall not be cancelled, except with notice to the Entity, which in this case is the MCPO.
- Special Risks: The County reserves the right to modify these requirements, including limits, based on the nature of the risk, prior experience, insurer, coverage, or other special circumstances.
- 4. The participating law enforcement agency is responsible for conducting a visual and operational inspection of the specialized investigative law enforcement equipment at the time of the pickup. The participating law enforcement agency agrees to document/report

- any damage or non-operational equipment directly to the *MCPO* representative prior to taking custody of said equipment.
- 5. The participating law enforcement agency agrees to report directly to the MCPO representative any damage incurred to the specialized investigative law enforcement equipment, as well as non-functional equipment, while said equipment was in their custody and control.
- 6. The participating law enforcement agency agrees to assume responsibility for reimbursing the County for the full costs for the repairs for any damages that occur to the specialized investigative law enforcement equipment while said equipment is in their custody, or that was not reported at the time of pickup. This clause will be waived if it is determined by the MCPO that the damage/equipment failure was not the fault of the participating law enforcement agency or its personnel.
- 7. The participating law enforcement agency agrees to return specialized investigative law enforcement equipment that is equipped with a fuel tank with a full tank of fuel. In the event the participating law enforcement agency fails to do so, the participating law enforcement agency shall be required to reimburse the County for cost of the fuel to fill the tank (at the rate per gallon in which the County pays for fuel) as well as an additional service fee of \$25.00.
- 8. The participating law enforcement agency agrees to immediately report any non-functioning or malfunctioning components of the specialized investigative law enforcement equipment directly to the designee of the MCPO.
- 9. The participating law enforcement agency agrees to provide the proper means to transport the specialized investigative law enforcement equipment to and from the MCPO storage facility.

C. INDEMNIFICATION

The participating municipality or entity of the participating agency shall save, protect, indemnify and save harmless the County of Middlesex, County Prosecutor, their elected officials, officers and employees from any and all damages or claims for damages to persons or property which may result or arise from the use, deployment and/or maintenance of such specialized investigative law enforcement equipment.

D. <u>SUPERSEDE</u>

This *MOU* supersedes any prior executed *MOU's* in respect to specialized investigative law enforcement equipment.
