REGULAR MEETING - APRIL 19, 2022

A Regular Meeting of the Highland Park Mayor and Council was held via Zoom, on Tuesday, April 19, 2022, and was called to order by Mayor Brill Mittler at 7:00 PM. Annual Notice of this meeting was provided to The Home News Tribune, the Star Ledger and the Highland Park Planet on January 5, 2022. In addition, notice of this meeting via zoom was faxed to The Home News Tribune and emailed to The Star Ledger and the Highland Park Planet on April 12, 2022 and was posted on the Borough website at www.hpboro.com and on the bulletin board at Borough Hall, 221 South Fifth Avenue, Highland Park, NJ on April 12, 2022, and has remained continuously posted as required by law.

Present: Mayor Brill Mittler, Councilpersons Foster, Hersh, Kim-Chohan; Borough Attorney Schmierer; Assistant to Borough Administrator Von Thun; Borough Clerk Santiago.

Absent: Councilpersons Canavera, George, Hale; Borough Administrator Jover.

Mayor Brill Mittler read a proclamation declaring April 2022 as National Arab American Heritage Month. She also issued a proclamation in honor of the retirement of long-time volunteer Sheila Highsmith.

Mayor Brill Mittler asked the Council members to present their reports.

Councilman Hersh reported that he is Chair of the Recreation and Arts Committee. He encouraged residents to visit www.highlandparkrec.com to check out the abundance of programming. July 3rd is the fireworks event with New Brunswick. The Arts Commission has put together a new program in partnership with the Recreation Department entitled the HP 250/24 writing contest that is open to any resident regardless of age. The purpose is to write a story that is 250 words or less and be given only 24 hours to submit the story after receiving your assignment. He thanked Nikki Gonzalez for the creativity of this initiative and for working with Kimberly McGraw at the Recreation Department. Once you register to participate, you will receive an email on Saturday April 30th at midnight with a writing assignment in a particular genre. You then have 24 hours to complete your story and email it back. The Arts Commission will read through the assignments and select a winner.

Councilwoman Kim-Chohan - No Report.

Councilwoman Foster reported on the installation of the traffic light on North Fourth Avenue that was installed by the D.O.T. The Borough would like to have some adjustments made to it, make it bigger so that it is more visible. Emails have been sent to the D.O.T. and the Borough is awaiting a response. She and Councilman Hersh have been working with the Safe Walking and Cycling Committee on getting the pedestrian safety awareness campaign going at the end of May. The Police Department is participating in the Click it or Ticket Campaign as well as a campaign to not use cell phones while driving. She reported that the Borough did a traffic challenge and she indicated that they would share it on the Borough website so that people can see how well they do with distracted driving. The challenge takes about 25 minutes, but is super informative. The traffic light on by Irving School on 11th Avenue has been down for the past six weeks. The Borough is aware of the problem and they are working on getting the parts to fix the light and get it re-installed. Last week, the Police Department held the first of a series of meetings entitled "Conversation with a Cop". Officer O'Mara was at the Community Center to meet with residents and he will be available again on April 26th, May 3rd and May 31st from 5:00 to 6:00 p.m. The Junior Cadet Academy will be held from July 11th to July 15th from 8:00 a.m. to 4:00 p.m. There are still spots available and anyone interested should contact Officer Omara at 732-572-3800, ext. 4262.

Assistant to Borough Administrator Von Thun - No Report.

Borough Attorney Schmierer- No Report.

Mayor Brill Mittler commented that she hoped everyone had a very Happy Easter, Passover and a meaningful Ramadan and that they got to spend time with their families. On May 1st, the 2022 Park Partner's Program will begin and residents are invited to submit their ideas that will be judged at a public exhibition. The grant program provides up to \$2,000 to five winning projects. Submissions are made in the following five categories: arts, culture and diversity, safety, universal access or health and wellness. The voting session will be held on a Sunday afternoon in June at the Highland Park Community Center. Applicants must complete an application, accessible on the borough website, and submitted to Communications Department, Harry Glazer. Submissions must be received by Tuesday, June 7th at 1:00 p.m. She commented that she has often stated how important she believes public art is in enhancing the day-to-day lives of all residents. We have seen creativity spring up in unique ways such as park benches, landscaping and the ever popular colorful murals that bedeck several of our buildings. Many residents have voiced excitement to see the new mural going up and taking shape on the side of the building 75 Raritan Avenue. In their working session, they will be discussing a proposal for another unique mural to be placed on one of the entryways into Highland Park. This mural project will demonstrate the connection between Highland Park and neighboring New Brunswick. All of these projects further enhance Highland Park's positive reputation as a home of free expression and creativity.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves. The total time for this session is 21 minutes; three minutes maximum per speaker. Comments are limited to items on the agenda. If you want to speak on an item that is not listed, there will be an opportunity to do so later in the meeting.

Melanie McDermott, 330 South 3rd Avenue, commented that she is co-chair of the Shade Tree Advisory Committee and that she wanted to address item 13c on the agenda. She and co-chair Rosie Baruh reviewed the ordinance and sent some suggested amendments to the Borough Attorney. She requested that the adoption of the ordinance be tabled this evening. If the ordinance is adopted tonight, she requested that the suggested changes be made as soon as possible. Borough Attorney Schmierer

advised that his office received the suggested changes from the Shade Tree Advisory Committee and he recommended that the Council consider adopting the ordinance tonight. Adopting the ordinance will move the committee back into the code book. An amending ordinance can be prepared, reviewed by the Public Works and Public Utilities Committee, and then brought to the Council for introduction at a future meeting.

Mary Forsberg, 317 Denison Street, commented about a New York Times article about marijuana shops in Toronto that she sent to the Governing Body. She is very concerned about the financial implications of pot and Highland Park. She also questioned whether the Borough had a quorum with only three Councilpersons present.

No one else appearing to be heard, Mayor Brill Mittler closed the public discussion.

WHEREAS, the second bidder is not registered under the Public Works Contractor Registration Act as required by law, nor is its named meter installation/plumbing subcontractor, and therefore, this bid is non-conforming; and

WHEREAS, the third bidder named a meter installation subcontractor who is not registered under the Public Works Contractor Registration Act as required by law, nor is its apparent plumbing subcontractor; and further, included "exceptions and clarifications" to certain material legal terms and conditions contained in the Borough's Information to Bidders, General Conditions and Supplemental Information to Bidders and General Conditions, creating a "conditional" bid, and for these reasons is a non-conforming bid; and

WHEREAS, the Borough Council has applied for DMHAS Youth Leadership funding through the Governor's Council on Alcoholism and Drug Abuse through the County of Middlesex.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves. Speakers are limited to 3 minutes and the discussion to end at 9:00 PM.

Mary Forsberg, 317 Denison Street, commented again about the article she sent to the Council regarding marijuana. She also commented about the Borough's redevelopment plan and how the RFP was prepared and who it was sent to. She also asked when the RFP's were due. It was noted that they are due May 6^{th} .

Dan Stern Cardinale, 221 Harper Street, commented about the ordinance for no smoking at the town tables and thinks it will make it a more family-friendly environment once they are up and running.

Mary Forsberg, 317 Denison Street, commented about the town tables and the fact that they do not exist. She thinks it is insulting to not include North 3rd Avenue as a place where smoking is prohibited.

Ruth Solomon, 704 South 1st Avenue, asked about the closures of streets for town tables and whether or not it will be permanent. Mayor Brill Mittler responded that they have been discussing this for several meetings and they have found the town tables at South 3rd and North 4th to be very popular. There is a trend with downtown communities to close off parts of streets and make them public plazas. They have been talking about this with the D.O.T.

Sophia McDermott Hughes, 330 South 3rd Avenue, commented about the town tables on 3rd and that she is in favor of shutting it down permanently. Last summer it was hugely popular and the tables were always filled.

Borough Attorney Schmierer read a letter submitted by Mark Liebeskind into the record regarding the draft parking study.

No one else appearing to be heard, Mayor Brill Mittler closed the public discussion.

Work Session:

Court Operations — Councilwoman Foster noted that courts throughout the State have been operating via Zoom. Highland Park's Judge has been holding sessions in the courtroom throughout Covid to handle the Borough's caseload. There are certain mandates that the Borough must follow to hold court sessions in person and to have all the security procedures in place. The State is looking at different ways in which to handle municipal court because of Covid. They have seen that the court system can work in a lot of different ways that is convenient for people who need to come to a court setting. She sent an email to all members of the Governing Body last week outlining the various steps that the courts are looking at. One of the steps could be the continuation of zoom court sessions that have proved very convenient. There are some cases that need to be heard in person and they are looking at how to do that going forward. We will also be exploring possibility of consolidating courts, which would be a huge cost savings for the Borough because it takes time, energy and people power to run a municipal court, along with the hiring of security and the devices that need to be in place. She will keep the Governing Body updated on what the Attorney General's Office will be doing to make courts accessible. Mayor Brill Mittler asked if would make sense to reopen the shared services discussion. Councilwoman Foster agreed that it would be a good idea especially now because the State is looking at zoom courts.

<u>Standing Committees</u> – Councilman Hersh commented about some free-floating committee assignments that have traveled with various Council people even though there have been changes in committee assignments. He mentioned that he was assigned the Safe Walking and Cycling Committee, though he is Chair of Arts and Recreation. There is some overlap and he wanted to have a continued conversation with the Administration Committee to address that. He found himself in the midst of a significant public safety issue that Councilwoman Foster should have been point on. He wanted to raise this issue so that it can be reviewed and adjusted accordingly before the next reorganization meeting.

New Murals – Mayor Brill Mittler noted that we have been talking a lot and doing a lot in terms of public art and murals are becoming more popular. She was approached by a Borough resident whose husband recently passed away and they have had some very strong connections to the City of New Brunswick. She as a well-known mural artist who is interested in putting together a mural for Highland Park that would represent the connection between Highland Park and New Brunswick. She showed some of the work on her screen. She asked Councilman Hersh to get the Arts Commission involved. There is a lot of opportunity moving forward to put Highland Park on the map. Councilwoman Foster noted that they need to have a conversation about the Zone 6 Center. They have been trying to get some help to get something reflective of the community on the center that shows our diversity and who we are.

There being no further business, on motion made by Councilwoman Foster, seconded by Councilman Hersh, and carried by affirmative voice vote of all Councilpersons present, the meeting adjourned at 8:17 p.m.
