A Regular Meeting of the Highland Park Mayor and Council was held on Tuesday, May 2, 2023, and was called to order by Mayor Foster at 7:00 PM. Annual Notice of this meeting was provided to The Home News Tribune, the Star Ledger and the Highland Park Planet on January 4, 2023. and was posted on the Borough website at www.hpboro.com and on the bulletin board at Borough Hall, 221 South Fifth Avenue, Highland Park, NJ on January 4, 2023, and has remained continuously posted as required by law.

Honors, Awards and Presentations:

Councilman George introduced the new Library Director Michael Bobish. Mr. Bobish spoke a about his background and plans to continue to move the Highland Park Library forward.

Approval of Minutes:

On motion made by Council President Hersh, seconded by Councilman George the minutes of the Regular meeting held August 2, 2022, Regular and Executive Session held on September 6, 2022, Regular Session held on September 20, 2022, Regular Session held on October 19, 2022 and Regular and Executive Session held on November 1, 2022, were approved, as distributed, by the following roll call vote, to wit:

Council Reports:

Councilman George reported there was a long, steady, heavy rain over the weekend and unfortunately there were a few new leaks in the Library roof. Public Works and the roofing contractor will be on the roof tomorrow to see what problems have occurred and design a fix. The Library Board of Trustees is pleased to have presented Michael Bobish, currently the assistant director of the library in East Brunswick. The Library construction project will be gearing up soon, the agreement with Molba Carpentry was approved at the April 18th meeting by Council and Staff is already planning expansion of remote services. Chief Abrams reports that there were no reports of danger or risk to persons or property in town from the drenching all weekend rainstorm. The Chief of Police formally swore in Officer Jonathan Laraj as a Highland Park Police Officer yesterday and we welcome him to our community. The Police Department will have its second Open Gym with Police Officers for grades 5 through 8 at the Bartle School Gym this week on Thursday, May 4th from 6:30 to 8:30. He reminded everyone about the change of the flow of traffic at Irving School is in the works. Hopefully the change will go in to place for a few weeks before the end of this school year so that residents and parents can get used to the change this year and start the 2023-2024 school year with the plan in place. Another reminder, enforcement of the "click it or ticket" program is this month. Seat belts do save lives and this annual program helps to reinforce safety and mindfulness when driving. Operation Take-Back took in 81 pounds of unwanted or expired prescription medications over the weekend of April 22nd and 23rd. Last month the Borough Council approved the agreement to implement the ARRIVE program with the communities of New Brunswick, Woodbridge, and Edison in partnership with Rutgers University Behavioral Health Care. The program is scheduled to kick off on this Monday, May 8th. As we said last meeting, this program will finally allow the Police Department to provide a health care responder on emergency calls which involve a person with emotional or behavioral challenges. The program also provides more training for all responders to be able to better respond to the needs of persons when intervention and understanding can defuse situations with trained personnel. Highland Park Officer Brian O'Mara is the primary officer on this detail and he heads our Community Policing Department, he has extensive experience and is a certified CIT instructor. Our first shift providing an ARRIVE officer is May 17th. The Borough has been the recipient of a grant from the Estate of Ida Kushner for upgrades and updating to police and fire. We're still working out the details on the pending final resolution, the Borough is a grateful recipient of a number of grants to certain qualified non-profit agencies which operate under the Borough's umbrella. The Volunteer Fire Department is working with administration to finalize details for replacement of a

Fire Department pumper engine. Volunteer Fire Department Chief Gershwin reports that we have three new volunteer applications which are being processed and hopefully we will be adding additional strength to the Department roster shortly.

Councilman Hale reported this Sunday, May 7th is the Annual 5K run at the Spring Street Fair. It begins at 9 am and the Street Fair will start around 11:30 am. He also mentioned that you can find out more information at mainstreethp.org. He gave a reminder that the Farmers Market is up and running every Friday afternoon. He noted a reminder to check with Main Street and also the Garden State Good Food Bucks Program at goodfoodbux.com on how you can maximize SNAP benefits and EBT benefits through the Farmers Market, patrons can double their SNAP benefits through this program. He stated that tonight we're going to be talking about the Main Street Budget. These types of programs along with the Economic Development are what our business improvement district and what Main Street does. He mentioned that The Elecon Greek Market will be a new tenant on Raritan Avenue, near 2nd Avenue where the old International Food Store was. They are going to offer Greek and non-Greek items, along with an option of outdoor seating. We are welcoming another new shop on Raritan just before 6th Avenue called Blendz. It's a smoothie and charcuterie establishment. He made a plea for everyone to visit the shops and restaurants in Highland Park, especially during the week. Although business is up on weekends it's down Monday through Thursday. He mentioned that at the next meeting we're going to be introducing and having a public hearing on the Redevelopment plan for the supermarket lot. With this plan in place the landlord and the supermarkets are going to have a framework that they can work with the town on how to make sure and lock in that a supermarket is the first and best use for that property. He said he feels confident that we will get a Supermarket.

Councilwoman Kim-Chohan reported that nj.com published an article entitled, "These Towns Have the Highest Property Taxes" in each of New Jersey's 21 counties. She noted the numbers are from 2022 and highly doubts for 2023 Highland Park will be on the list due to the town-wide re-evaluation. She mentioned that they will be adopting the 2023 Budget from April 20th tonight. She noted a Rent Control update, she stated that they filled 3 positions but will need 3 more filled, a tenant alternate, an owner occupied and an owner occupied alternate. She said that she is the Council Liaison to the Rent Control, however, the first point of contact for tenants or landlords should be our Business Administrator, Teri Jover. May is Asian American and Pacific Islanders AAPI Heritage month. It highlights the diversity and achievements of the AAPI community. May was chosen to commemorate the first group of Japanese people who immigrated to the U.S. in May of 1843, as well as to mark the anniversary of the completion of the Transcontinental railroad in May of 1869. The Federal Asian Pacific American Council announced this year's theme is advancing leaders through collaboration across organization and embracing diversity. She said that she looks forward to seeing you at the Street Fair.

Councilman Postelnik reported Grocery Store Help, and reiterated the ongoing food shopping assistance available through the Department of Community Services: regularly scheduled weekday trips to a variety of grocery stores, trips may also be requested at other times, including some nights and weekends, online food shopping support is available to anyone who needs it. For further information please call (732) 819-0052 or stop by the community center. The transportation schedule is also available on the HP website. There will be a presentation on Fraud and Scam Prevention by the Highland Park Police Department Detectives, Middlesex County Prosecutor's Office, and US Postal Service Inspectors this Tuesday, May 16th at 10:30am. At the Community Center, there will be a Mother's Day Luncheon, Tuesday May 16th at 12:00 pm at the Community Center. Lunch will be provided by local favorite Pithari and musical entertainment by Jerry Castaldo. Middlesex County is hosting a number of celebrations. The celebration for Highland Park residents is on Wednesday, May 24th from 11am-1pm at the Piscataway Senior Center and is open to all Highland Park residents who are 90 years of age and up, all seniors can bring one guest and lunch will be provided. This event is free and you can contact the Middlesex County Office of Aging or our Community Services Department for more info. The Memorial Day Parade is Monday, May 29th, beginning in New Brunswick at 10:30am, crossing the bridge at around 11:30am, and proceeds up Raritan Ave. to the Doughboy Monument. A ceremony will take place at the conclusion of the parade at the Doughboy Monument. There is a Community Health Fair Tuesday, May 30th from 11:00am - 2:00pm at the Community Center, screenings that will be offered include: Blood Pressure, Pulse, BMI, Bone Density, Blood Sugar, and Skin Cancer. Fasting is not required. The Yarn Heart Art Installation on Albany Street Bridge is Saturday, May 6. The HPAC, in collaboration with art students from New Brunswick High School, will be making yarn hearts and installing them on the fence along the Albany Street Bridge. Highland Park Community Chorus Spring Concert is on Friday, May 5th and Saturday, May 6th at 8:00pm at the Reformed Church of Highland Park on 19 So. Second Ave. The concert features Mozart's requiem and Mykola Lysenko's Prayer for Ukraine, tickets can be purchased on the Community Chorus's website and at the concert

Council President Hersh reported that he had the NJSA Statue books with him if anyone needs them. He is really looking forward to seeing everyone at the Street Fair. The Earth Day Fair will also be

located at the Street Fair, on Sunday, May 7th between 11am and 3pm. There will be a wide variety of information booths and programs. It is sponsored by the Sustainable Highland Park. The Earth Day Fair will be held on North 3rd Avenue between Raritan and Denison. It will include performances by the Sheamus Trio, The Amandala and the Magnolia Street String Band, for more information you can email highlandparksustainable@gmail.com or reach out to any of the Council members. He reminded everyone that the 5K run is that day as well. He stated that he chairs the Public Works Committee and the Tree Planting Program is underway. This is funded by the DEP's Community Forestry Program. More than 50 trees are being planted in a concentrated zone on the south side. Nearly 30 trees are being planted in front of homes that have requested them. The second phase of planting will be on Woodbridge Avenue, in partnership the NPP Program. The trees will be watered regularly, which was a concern of the Shade Tree Advisory Committee. The 2nd Annual Queer Candy LGBTQ block part and the Pride Music Festival will take place on Saturday, June 11th in front of Pinos.

Mayor's Report

Mayor Foster reported that our next Council meeting, Tuesday, May 16th will be hybrid, the Council members will be here. There are microphones now installed in the ceiling, so those of you at home should be able to hear the Council meeting clearer. Mayor Foster thanked Business Administrator Jover, Emma Von Thun and Monica Jackson who worked hard to make this happen. She noted it will also be on Zoom and continue to be on YouTube, posted on Nixel and on our Borough website. She said as Councilwoman Kim-Chohan mentioned May is Asian Pacific Heritage month. Great contributions were made to our Country, a Taiwanese American co-founded Yoo-hoo and YouTube. They have influenced our fashion and our food. We posted the celebration yesterday on the website. Highland Park celebrates and embraces each other with our diversity. We will have more celebrations including flag raisings. We just celebrated the 75th year of history of Israel as a State. We had many speakers at the event. Joining other Mayors, an Assemblyman and Senator I had the privilege of speaking to a Kindergarten class about what the law means, what freedom is about, how we protect freedom and how these laws were created.

Abby Stern Cardinale, Harper Street, indicated that she was happy there will be hybrid meetings.

Marijuana Smoker said a cannabis store was opened down the street from him and he would like the Highland Park Democrats and the Highland Park Police Department to donate into a fund specifically for him so he could buy some. He asked why would we be the last town to get weed. We are in a way violating the 14th amendment treating everyone equally.
