Council Reports.

Councilwoman Kim-Chohan indicated that the Borough would be introducing the budget this evening, and mentioned that the Rent Control Board is scheduled to meeting on Thursday, April 25th @ 530pm via zoom.

Councilman Hale reported that in addition to the introduction of our overall budget, we are also introducing the budget for Main Street Highland Park. A number of years ago, we realized that Main Street had not had its funding increased in quite some time and made the decision that we would like to try and incorporate smaller but more regular increases. This year the overall budget we are proposing is about 5% in the BID tax which as anyone who has gone out to buy a gallon of milk is really just keeping up with inflation. We have also decided to allocate some additional Borough revenues to Main Street and we have some matching programs and funding coming to Main Street in conjunction with the NPP program. The increases are designed and targeted to increasing the amount of support that Main Street can give to support existing downtown businesses, including more funding for signage and facade grants, small business grants, coupon mailers, and gift card programs. In addition, we are working with Main Street to work on ways that the Borough can pick up some of the things MSHP has been doing to help while we didn't have a grocery store and how the Recreation Department can help out more with things like the 5K. The goal of all of these actions are to make it easier for Main Street to focus on business support, retention of existing businesses and also attract new businesses. The NPP is a state grant that we received to help our residents and businesses up on Woodbridge Ave. In the last two years we have provided technical and marketing assistance to a number of Woodbridge business, brought flower plantings, the snowflakes up to Woodbridge Ave, a number of facade grants and other improvements. We are currently waiting for our final approval for our year 3 budget but this year we are going to be expanding the NPP in a number of ways. For example, we have budgeted for doing at least one car show up on Woodbridge Avenue to draw more people to the area. Based on conversations with other towns they are fun events for local residents. We have funding for porch grants for houses in the area in need of help in fixing up their porch, and we have a company called Beyond Main, which helps create improved online presence for local businesses. As soon as we get approval from the County to move forward on these and we are able to find our new economic development assistant we will move ahead so stay tuned. As you will hear tonight we have some exciting news about Tract A and the plan for Ubry's and P&K Auto to swap places in the near future. This is a plan that was worked out with Joe and Teri and all the participants and we are very excited to move the ball on Tract A. We know that people are waiting for our public meeting on Tract C and we are confident that it is coming soon. Our goal as the Mayor has indicated many times is to have an open meeting in the high school to show the plans for Tract C and to get as many comments and reactions from the public as possible. So stay tuned for that as

Councilwoman Canavera reported the Board of heath: wants you to be aware that due to the milder winter weather Mosquito season starts earlier so protect yourself and pets. The Commission for Universal Access

met with the special education parent advisory group to work together for inclusion for all residents. Look for them to be sharing a table at the 5K street fair and earth day event. The Community Food Pantry is open on the second and fourth Thursday from 9 am to 10:45 am and again at 6 pm to 7 pm. Saturday following Thursday from 9:30 am to 10 am. The Highland Park Gives a Hoot Food Pantry is every Tuesday at the Zone 6 Center from 10 am to 11 am. Both programs have seen an increase in families needing services. The Human Relations Commission will have their next meeting tomorrow via zoom. The information is on the Borough's website. You are also find leaves for the Gratitude Tree at local business and Borough offices to add your leave to the tree. The Mental Health Commission wants you to know about it is Stress Awareness Month. Everyone has stress and learning to cope with our stress and finding healthy ways to deal with these situations can go a long way in living a healthy and positive life. Some ways include: Use guided meditation. Practice deep breathing and maintain physical exercise and good nutrition. Lastly The 988 Lifeline provides 24/7, free and confidential support for people in distress, and prevention and crisis resources for you or your loved ones. Please call if you or a loved one needs help.

Councilman George gave recognition to Reverend Seth for Church's housing Corporation great feature article on NPR being broadcast nationally tonight with regard to their affordable housing program which is operated with largely without Government funding. Most of the furniture is in except for the larger items such as the circulation desk, work at the library and tonight we will hopefully award to Frank Cyrus for the roofing project that's a re-roofing of the entire membrane system and repairs and updates to the HVAC system which sometimes gives rise to the leaks. The work remains on schedule and we still anticipate a reopening sometime in June. The online services still continues. There is a resolution on the consent agenda tonight authorizing the acceptance of a donation of a trailer and three police vehicles from the PBA's non-profit organization as part of the implementation of the Kushner grant. The Highland Park Police Department is also very active with local organizations this spring and in the month of May they will be conducting a pack a patrol car even for the Edison Animal Shelter from May 1st to May 31st, you can drop off donations for the animal shelter, there will a flyer posted with a QR Code with an Amazon wish list of items needed for the shelter. The Police Department is also a partner for the Community Food Distribution program, partners are the Middlesex County Prosecutor's office, Goya foods, the Highland Park Food Pantry and the NJ LGBTQ Law Enforcement liaison. They will be distributing non-perishable and canned goods on April 25th from 9AM-1PM. In addition, the LGBTQ Liaison provided training for the Borough, some Police Dept. supervisor's and line officers participated. There is also a resolution on tonight's agenda to accept a donation of the new engine from the Volunteer Fire Department, which is non-profit and implementation of the Kushner grant. We are still awaiting approval from the State of New Jersey but should be on the road shortly.

Councilman Postelnik reminded everyone that the Department of Community Services offers grocery Transportation and online food shopping assistance while we are still without a grocery store. If you need assistance in the meantime please reach out to the S Community Center. Programming highlights of the Community Center, today we held the Spring lunch we had over a 100 people and entertainment was provided by HB own drama club and the next lunch event will be on May 13th. Tomorrow Wednesday April 17th very suspicious day at 1 PM at the Community Center there's the Matter of Balance program which is a program for older adults that is designed to reduce the fear of falling which can cause people to restrict their activities. He mentioned the Counseling program, there is a Middlesex County's 90th 90s birthday celebration it's not birthdays from people in the 90s is people who are in their 90's and any Highland Park resident is invited to celebrate this Middlesex County Birthday Bash on Friday May 3 at the Piscataway Senior Center from 11AM-1PM. Some Recreation programming highlights: the Recreation Department will be facilitating this year's kids races at the annual HP 5K on Sunday May 5th so please come out and support the kids. There's currently 16 adult and youth sport art, exercise and theater programs it's a small town but we are delivering a lot and I am very thankful for all the hard work they do at the Community Center. Arts Commission update tomorrow Wednesday April 17th there will be another Book Art Workshop by the Arts Commission from 6:30 p.m. to 9 PM at the Community Center, all materials will be provided but you may bring collage elements to populate the book.

Council President Hersh reported May 5th is a big date coming up around here and I'm going to add to that May 5th is also Earth Day well Earth Day is every day but typically Earth day is April 22nd everywhere else but Highland Park we celebrate it daily and we're celebrating at our Street Fair, the whole Community is coming together at the annual Highland Park 5K race and Spring Street Fair and Earth Day Fair on May 5th so in addition to everything that you heard from Councilman Hale and Councilman Postelnik the Spring Street Fair activities up and down Raritan Avenue, Sustainable Highland Park has assembled also a terrific Earth Day program including music, food, environmental activities and education all conveniently located during the Street Fair on North Third Avenue. The full Earth Day performance list at SusstainableHighlandpark.org. In conjunction with Earth Day you know with a guided tour of The Meadows Trail on Saturday April 20th between 11AM and 1PM, there's no rain date because it's nature and no registration is necessary. A little background on The Meadows Trail and thank you for Craige for this is the largest Borough owned Natural Area, it's 18 acres include forested areas, wetlands, open streams and important flood plan areas along the Raritan river and this will be a leisurely comfortable stroll but please bring comfortable shoes and water and obviously areas can be particularly muddy too so please be prepared for that. We are going to be meeting at the trail entrance at the base of South 5th Avenue at the DPW garage at 444 Valentine Street and all ages are welcome. In addition to seeing things pop up in addition to new signs and stores that Super Fresh, Fresh Mart and Giddy's and all that we're also seeing new trees popping up as well and we're setting an ambitious tree planting scheduled this spring as part of the Borough's biannual tree planting program, 72 new trees have been added to our tree canopy keeping up with new plantings as many

trees aging out it is really important. How we care for our new trees is going to be really important so obviously we have a watering contract that we're authorizing tonight and under the close supervision of the Shade Tree Advisory Committee, the Administration and Mayor Foster we're going to make sure that these trees stay vibrant and resilient we can really grow into the shade trees. Tomorrow April 17th from 700 to 800 pm you can find out from experts on the Shade Tree Advisory Committee to learn more and I am going to go to www.hpboro.com and just click on the calendar and you'll find a link to this terrific program where you can learn more about our green spaces and how to better support trees, air, and water quality and support noise reduction and shade. Bulk pickup is about to be underway, bulk pickup, bulk garbage pickup is by appointment only, pickups are can be scheduled on Wednesdays during April now May June September and October To make an appointment please call public works at 732 247-9379 and each household may request up to two collections per year. Also right after the town wide garage sale on Tuesday, September 17th and Thursday September 19th there will be automatic bulk pickups that you do not need to register for. Materials should be placed curbside no sooner than one hour before Sundown of the day prior to pick-up. Materials not properly secured or bundled and unacceptable items will not be collected. Public Works is busy this spring obviously and are going to be out there you might have noticed also springing up are some of our old friends the Pot holes and you know it's that time of year when the roads begin to thaw and the reveals the pot holes manifest themselves in our roadways so our crews are going to be out tomorrow weather depending but it should be a nice day tomorrow uh to fill a lot of those potholes however if you they don't get filled automatic magically so if you see potholes, you can also report it at www.hpboro.com. Highland Park Housing Authority had its reorganization meeting last week congratulations to Ruby Hope on returning as chair and Ms. Martinez who was selected as vice chair. He made a quick acknowledgement of the solar eclipse, it was a really great to kind of feel that bond with the community and thanked the Highland Park PTO for supplying the kids protective eyewear so we could all enjoy the eclipse safely and securely.

Mayor's Report.

Mayor Foster started off by echoing something that Councilman George said last Friday we had training by LGBTQ+ training here and thanked the Police Chief Rick Abrams for helping us to coordinate that with the County task force to get us that training. We had all our employees and others that came in and I believe that we all got a really good education and we learned a lot. She mentioned that as Mayor she would like to see more of these types of trainings or seminars put together where we bring in different communities and have conversations and I it's not so much a conversation as education or re-education what we thought we knew about certain communities is to have these conversations. We're being informed we're given proper educational information and how we work with and within these communities so more to follow. We're hoping to do the Asian Community next and we'll keep you updated. We're talking a lot about Main Street and about Economic Development and development of our town and our town getting highlighted in New Jersey food magazine which is awesome and I'm really happy for that but I also want to share with you that last week Fresh Mart the new market that we have in town where Quick Chek used to be had a little problem with their signage and they wrote to me and said they were having this problem we need help we don't know what to do we want to be good neighbors in our in town we want to be received well and we want to support the town and you know our sign that we have is a little bit bigger than what they normally conformed to and quickly I turn it over to the Administrator and Code Official and in no time they were able to solve this issue with the signage. If you drive by you can see that they have a big beautiful sign that fits in although the property sets back quite a lot you can still see the sign and I was happy that these are some of the things that all of us collectively do to help business succeed here in town because we want them to come, we want them to stay and we wanted to have a smooth transition into Highland Park.

Public Participation.

Mayor Foster opened the floor for public participation. Attorney Shah announced the rules regarding public participation.

Craige Ambroch, a 30 year resident of Highland Park and very involved in the Meadows Forest. We take great pride in what we do in the forest and we also greatly appreciate the liaison that are able to come from the Council and give us assistance and not only assistance sometimes they actually want to get their hands dirty and dig in the dirt and do all kinds of things and one of our recently he was kind enough to do many things in addition to just being the support that we need for our organization and Phil George wood shop participated the signage he carved a beautiful sign location of this anyway so the so the wanted to do something in public say we really appreciate Phil and everything he's done for us in addition to very generous donations to us and we decided we want to embarrass him a little bit and give him know just a little something to recognize how much we appreciated you being with us. Councilman George was presented with a sweatshirt and expressed his thanks for the recognition.

Kieran Crowley, 218 Harrison Avenue asked if the Borough had gotten a response to the closure of South 3rd Avenue. The action to be taken tonight on Tract A and asked if tonight's vote was in tandem of the Redevelopment entities review and approval. He said in relation to Tract A, has the screening committee had a chance to review this agreement for Tract A and is there any detail that can be provided on the initial review of stakeholders.

Lois Lebbing, North 2nd Avenue, asked about Ordinance 24-2084 says something about 1.15 million something about the Borough versus 1.15 million from the redeveloper person and further down on 4-24-124 for the Main Street Highland Park budget she did not understand back in 2005 the Administrator explained a contribution to Main Street for undertaking the Borough's economic development functions which should be returned to the Borough and then we talk about salary and transferring the functions to Main Street representing a huge savings since Main Street can accomplish this for less and she does not see this happening.

There being no one further, it was moved by Councilman George and seconded by Councilwoman Canavera to close public participation, and carried by affirmative voice vote of all Councilpersons present, public participation was closed.

Teri Jover, Administrator responded regarding South 3rd, indicating there have been promising meetings although we do not have our permit yet. It seems to boil down to lighting at the intersection and there is an order in with PSE&G to upgrade the lights at South 3rd intersection to LED to address the NJDOT's concerns.

Mr. Baumann, Esq., addressed the Redevelopment entity inquiry. He indicated that the Redevelopment entity comes right out of the statute and the municipality can choose to be the Redevelopment Entity or they can choose to delegate that authority to a Redevelopment Agency. Some years ago the Borough decided to bring it in house and take control of the Redevelopment Entity and they chose early on to allocate their work stream to a separate meeting when they are acting as the Redevelopment Entity or handling redevelopment work that was just the ease of organizing work not necessarily changing who they are.

Councilman Hale said the idea behind the advisory or screening committee was if you were interested in developing and the developer wanted to take the temperature of people on the Planning Board and Zoning Board and MSHP to get an idea and informal advice they would request to meet with the Rehabilitation and Redevelopment screening committee. It is really just an attempt to try and provide development and developers a kind of sounding board.

Mayor Foster said with regards to CDBG about five years ago the formula for the community block development Grant was changed. There was a time when you could use it in all in certain areas of town that has been we've gotten a huge cut from the federal government, the grant is much more restrictive and it's only being used now in certain areas of town and it's areas in need of upgrades, so that's pretty much on the Woodbridge Avenue Corridor. For the past four years that's where the grant has currently been used the federal government has not expanded their reach and extending the grant to any other area so that's why it has not been used in the entire town of Highland Park, the entire downtown of Highland Park it's only being used up on Woodbridge Avenue.

Clerk reported on Ordinance No. 24-2083 Ordinance Approving the Application for a Long-Term Tax Exemption and Authorizing the Execution of a Financial Agreement with DL Urban Renewal (Grocery Store) has been duly advertised for consideration of passage on final reading by title and affidavits of publication are on file.

Mayor Foster opened public hearing on Ordinance No. 24-2083.

Kieran Crowley, 218 Harrison Avenue asked what kind of formal budget analysis has been done to make sure that the PILOT in lieu of taxes is something that the Borough can absorb. He said he believes \$50,000 is roughly the amount of tax we are giving up, does this effect taxes in the future. He said there is a section that speaks of benefits of project versus costs but only mentions the benefits does not mention costs.

Lois Lebbing, North 2nd Avenue, said we can see that they are spending millions of dollars redoing and asked if there would be new public restrooms. She said she read a statement 35 full-time employees and finds that very doubtful since most retail is pushing for part-timers.

There being no one further, on motion by Councilman Postelnik and seconded by Councilwoman Canavera, and carried by affirmative voice vote of all Councilpersons present the public hearing on Ordinance 24-2083 was closed.

Ms. Jover, Borough Administrator indicated that the \$50,000 essentially works out to about .09% of the total amount to be raised by taxes which is about \$11.00 per year for the average residential assessment. She said that the cost of having a large vacant store and not having a grocery store and what that can do to property values in the long run, what that means to economic development. She said that she strongly believes that this outweighs and if anything will help us in the long run.

Mr. Baumann, Esq., said that simply that \$11 a year to the average homeowner would that be a visible amount to maintain the grocery store which you know we were told a year ago and I think everyone agrees it's a critical community amenity.

Mayor Foster said that she did not know how many employees they plan on hiring. She said that they have gutted the entire facility and would assume that they are going to put in new restrooms and she said that she would check on the number of employees they are looking to hire and whether they will be full-time or part-time and will find out about the restrooms.

WHEREAS, Resolution No. 2-23-71, in accordance with the provisions of the Redevelopment Law, also authorized LRK, Inc. ("**LRK**") to conduct a preliminary investigation to determine whether all or a portion of the Study Area should be designated as a non-condemnation area in need of redevelopment; and

WHEREAS, the Planning Board received a report setting forth the basis for the investigation prepared by the Planning Consultant, entitled, "Preliminary Investigation of a Non-Condemnation Area in Need of Redevelopment, Downtown Area – Tract C Expansion" dated November 22, 2023, concerning the determination of the Study Area, as an area in need of redevelopment (the "Report"); and

WHEREAS, the Redevelopment Law requires the Planning Board to conduct a public hearing prior to a determination whether the Study Area should be designated as a non-condemnation area in need of redevelopment, at which hearing the Planning Board shall hear all persons who are interested in or would be affected by a determination that the property is an area in need of redevelopment; and

WHEREAS, on December 14, 2023, the Planning Board reviewed the Report, heard testimony, conducted a public hearing during which members of the general public were given an opportunity to present their own evidence and/or to cross-examine representatives from LRK, and to address questions to the Planning Board and its representatives, concerning the potential designation of the Study Area as an area in need of redevelopment; and

WHEREAS, after the conclusion of the public hearing described above, the Planning Board voted to adopt and accept the recommendation contained in the Report, and to recommend that the Study Area be declared a non-condemnation area in need of redevelopment, in accordance with the Redevelopment Law, and for the reasons set forth in the Report; and

WHEREAS, the Borough Council agrees with the conclusion of the Planning Board that the Study Area satisfies the criterion for redevelopment area designation set forth in the Redevelopment Law and finds that such conclusion is supported by substantial evidence; and
