BOROUGH OF HIGHLAND PARK Ordinance No. 18-1962

AN ORDINANCE TO AMEND AN ORDINANCE ENTITLED, "AN ORDINANCE TO PROVIDE FOR AND DETERMINE THE RATE OF COMPENSATION OF EACH OFFICER AND EMPLOYEE OF THE BOROUGH OF HIGHLAND PARK AND THE METHOD OF PAYMENT OF SUCH COMPENSATION"

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF HIGHLAND PARK, AS FOLLOWS:

- Section 1 of the Highland Park Salary Ordinance is amended and supplemented to read as follows:
 - Personnel Policies and Procedures Handbook of the Borough of Highland Park, as may be amended by Resolution of the Mayor and Council, outlines those personnel policies and procedures for employees and supervisors, including but not limited to:
 - A. Salaries herein set forth, shall be paid twice monthly on the fifteenth day of each month and on the last day of each month. In the event either the fifteenth day or the last day of the month is a weekend or holiday, then payment shall be made on the last work day preceding such date. Nothing hereinafter set forth shall prevent payment for services of a special nature beyond the regular or routine business of the official or employed, or as otherwise specified by resolution of Council.
 - B. Paid Holidays for all non-uniform Borough employees shall be as outlined in the Personnel Policy and Procedures Handbook, or the appropriate collective bargaining agreement. If a holiday falls on a Sunday, it shall be observed on the following Monday. If a holiday falls on Saturday, it shall be observed on the preceding Friday.
 - C. The hereinafter established rate of compensation is intended to remunerate such officials and employees for their regular hours of work without intending to compensate in any way for overtime wages that may become due to them because of services, which they should be called upon to render. Eligibility for overtime is as specified in the Borough Personnel Policy and Procedures Handbook for non-union administrative employees, and in the appropriate collective bargaining agreement for union employees.
 - D. The Borough of Highland Park reserves the right to pay a salary to a new or old employee at any figure within the established range for such new and/or old employee's duties.
 - E. The adoption of this ordinance shall not operate so as to decrease the present rate of compensation to any official or employee.
 - F. The classified service shall consist of the following positions. The range scale refers to compensation range limits, which shall be paid as set forth herein:

ORDINANCE OF THE MUNICIPAL COUNCIL OF THE BOROUGH OF HIGHLAND PARK, COUNTY OF MIDDLESEX, NEW JERSEY, ADOPTING AN AMENDMENT TO THE HIGHLAND PARK DOWNTOWN REDEVELOPMENT PLAN RELATING TO PROPERTY COMMONLY KNOWN AS 130 AND 134 RARITAN AVE., PURSUANT TO THE LOCAL REDEVELOPMENT AND HOUSING LAW, N.J.S.A. 40A:12A-1 et seq.

WHEREAS, the Borough of Highland Park (the "Borough") is a public body corporate and politic of the State of New Jersey; and

WHEREAS, the Local Redevelopment and Housing Law, *N.J.S.A.* 40A:12A-1, *et seq.*, as amended from time to time (the "Redevelopment Law"), provides a process for municipalities to participate in the redevelopment and improvement of areas in need of redevelopment; and

WHEREAS, by resolution dated June 21, 2005, the Municipal Council of the Borough (the "Borough Council"), designated certain property along the central downtown corridor of Raritan Avenue, including without limitation, real property within the Borough commonly known as 130 and 134 Raritan Avenue and identified as Block 13, Lots 9 and 6 on the Official Tax Map of the Borough (the "Property"), as an "area need in need of redevelopment" (the "Redevelopment Area") in accordance with the requirements of the Redevelopment Law; and

WHEREAS, on September 13, 2005, in order to facilitate the development of the Redevelopment Area, including the Property, and effectuate the redevelopment thereof, the Borough Council, by Ordinance No. 1667, adopted the "<u>Highland Park Downtown Redevelopment Plan</u>" (as subsequently amended, the "Redevelopment Plan") pursuant to the authority granted under the Redevelopment Law; and

WHEREAS, by Resolution No	adopted on June 19, 2018, the Borough
referred certain amendments to the Redevelopment	Plan relating to the Property (the "Proposed
Amendment") to the Planning Board for its review an	d recommendation; and
WHEREAS, the Planning Board, on constituted public meeting, reviewed the Proposed approved on, 2018 (the "Planning I recommended the approval of the Proposed Amenda	Amendments, and by Resolution Board Resolution"), the Planning Board
WHEREAS, the Borough hereby finds that the on file with the Borough Clerk (the "Redevelopment the Borough, being, among other things, substantial	Plan Amendment"), is in the best interests of

WHEREAS, the Borough Council now desires to adopt the Redevelopment Plan Amendment and to direct that the applicable provisions of the Borough's Zoning Ordinance and Map be amended and superseded to reflect the provisions of the Redevelopment Plan Amendment, as and to the extent set forth therein.

Borough; and

NOW, THEREFORE, BE IT ORDAINED by the Municipal Council of the Borough of Highland Park, in the County of Middlesex, New Jersey, as follows:

1. The aforementioned recitals are incorporated herein as though fully set forth at length.

- 2. The recommendations of the Planning Board are hereby accepted, and the Redevelopment Plan Amendment, attached hereto as <u>Exhibit A</u>, is hereby adopted pursuant to the terms of the Redevelopment Law.
- 3. The zoning district map included in the zoning ordinance of the Borough is hereby amended to reference and delineate the Property governed by the Redevelopment Plan and Redevelopment Plan Amendment. All of the provisions of the Redevelopment Plan, as amended by the Redevelopment Plan Amendment, shall supersede the applicable development regulations of the Borough's municipal code, as and where indicated.
- 4. If any part of this Ordinance shall be deemed invalid, such parts shall be severed and the invalidity thereby shall not affect the remaining parts of this Ordinance.

RESOLUTION TO REUNITE CHILDREN AND PARENTS SEPARATED BY US AUTHORITIES UNDER THE TRUMP ADMINISTRATION'S "ZERO TOLERANCE" POLICY

RESOLUTION: Council as a Whole

WHEREAS on April 6, 2018, Attorney General Jeff Sessions directed federal prosecutors "to adopt immediately a zero-tolerance policy for all offenses" related to the misdemeanor of improper entry into the United States, and that this "zero-tolerance policy shall supersede any existing policies"; and

WHEREAS under the Trump administration's "zero tolerance policy, federal authorities separated children from their parents, relatives, or other adults who accompanied them in crossing the border, whether apprehended during an illegal crossing or, in a number of reported cases, legally presenting themselves for asylum; and

WHEREAS federal authorities made the decision to take children from their parents without a plan to reunite families, resulting in numerous cases of parents and children having no contact since being forcefully separated; and

WHEREAS the American Academy of Pediatrics has concluded that the Trump administration's "zero-tolerance" policy has caused "irreparable harm" to the children; and

WHEREAS in April and May 2018, an average of 45 children were taken from their parents per day. According to the Department of Health and Human Services, the policy led to the separation of over at least 2,300 children from their parents; and

WHEREAS it will be difficult to reunite children separated from their parents since parents are sent to federal jails and face criminal prosecution through the US Department of Homeland Security, while children are classified as an unaccompanied alien child" and transferred to the US Department of Health and Human Services. Once a child is separated from its parents, under the Trump administration "zero-tolerance" policy," the federal authorities no longer track them as a family unit and there is no system in place to reunite families; and

WHEREAS the Mayor and Council of the Borough of Highland Park applaud New Jersey Governor Phil Murphy for signing an executive order on 6/19/18, that prohibits any New Jersey resources from being used to assist in the Trump administration's "zero-tolerance" policy of detaining immigrant parents and separating them from their children; and

WHEREAS following President Trump's June 20, 2018 suspension of the "zero-tolerance" policy, it remains unclear whether the children that were already separated from their parents will be immediately reunited with their families; and

WHEREAS phone rates at immigrant detention centers have been as much as \$8 per minute for detained individuals who are either contacting their children that have been separated from them and placed in detention facilities or to contacting federal agencies to learn where their children are being held; and

WHEREAS the Mayor and Borough Council applaud New Jersey's 6th Congressional District Congressman Frank Pallone, Jr. for introducing the Compassionate Calling and Immigrant Family Reunification Act of 2018 on June 26, 2018, which would ensure that detained parents may make calls to their children that were separated from them or to federal agencies to learn of their children's whereabouts free of charge;

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Highland Park:

- Implore the Trump administration to develop a plan to reunite the families torn apart by the "zero-tolerance" policy immediately.
