# AN ORDINANCE TO AMEND AND SUPPLEMENT THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF HIGHLAND PARK, <u>CHAPTER 328, "SEWER AND WATER"</u>

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF HIGHLAND PARK, AS FOLLOWS:

 Paragraphs a. and b. of Section 328-23 Water Consumption Rates shall be amended to read as follows:

#### 328-23 Water Consumption Rates

A. Rates. The rate charged for all water used by each consumer shall be as follows:

Amount	Rate
(cubic feet)	(Per 1,000 cubic feet)
0 to 799	\$35.55 flat charge
800 to 999	\$46.09 flat charge
1,000 to 9,999	\$57.57 per 1,000 cubic feet
10,000 and up	\$61.60 per 1,000 cubic feet

- 2. Paragraphs a.1., a.2 and a.3 of Section 328-38 **Sanitary Sewer Rentals** shall be amended to read as follows:
  - A. Sewer rental shall be paid quarterly for the use of the sanitary sewers connected to any premises or lot in the Borough of Highland Park, in accordance with the following rates and classifications:
    - 1. Residential Users. Residential users shall include all single family and multi-family domestic dwellings. For each one thousand (1,000) cubic feet of water consumed therein during the billing period the rate shall be as listed below, consisting of the amounts necessary to cover the Middlesex County Utilities Authority (MCUA) operation and maintenance costs, MCUA debt service costs and the costs of maintenance, repair, replacement and operation of the sanitary sewer system of the Borough of Highland Park.
    - 2. Commercial Users. Commercial users shall include all non-domestic users discharging less than twenty-five thousand (25,000) gallons per day of equivalent waste. For each one thousand (1,000) cubic feet of water consumed during the billing period, the rate shall be as listed below, consisting of the amounts necessary to cover the Middlesex County Utilities Authority (MCUA) operation and maintenance costs, MCUA debt service costs and the cost of maintenance, repair, replacement and operation of the sanitary system of the Borough of Highland Park.
    - 3. Industrial Users. Industrial users shall include all non-domestic users discharging the equivalent of twenty-five thousand (25,000) gallons or more of waste water per day. Such users shall be required to sample at least monthly for the characteristics of the discharge (B.O.D. and S.S.). For each one thousand (1,000) cubic feet of water consumed during the billing period, the rate shall be as listed below, consisting of the amounts necessary to cover the Middlesex County Utilities Authority (MCUA) operation and maintenance costs, MCUA debt service costs and the costs of maintenance, repair, replacement and operation of the sanitary sewer system of the Borough of Highland Park.

If the B.O.D. as measured exceeds 200mg per liter there shall be an excess charge of \$0.035 for each pound of B.O.D. in excess of 200mg per liter as determined from the sampling. If the S.S. as measured exceeds 240mg per liter there shall be an excess charge of \$0.025 for each pound of S.S. in excess of 240mg per liter as determined from the sampling.

# AN ORDINANCE PROVIDING FOR A SURCHARGE FOR METERED WATER USAGE CALENDAR YEAR 2017

**WHEREAS,** the rates charged for water usage during the Calendar Year 2017 prove to be insufficient for the cost of the delivery of water service to residents of the Borough of Highland Park who consume water through the Public Water Distribution System; and

**WHEREAS**, in order to address the deficit which occurred during the Calendar Year 2017 for water usage, the Borough Council wishes to establish a one-year surcharge for water consumption that occurred by those Borough residents utilizing the Public Water Distribution System.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Highland Park as follows:

1. It is hereby established for the Calendar Year 2018 the following surcharges for water consumption during the Calendar Year 2017:

Usage Amount (cubic feet)
0 to 3,196
\$63.80 flat charge
3,197-3,996
\$71.58 flat charge
\$19.45 per 1,000 cubic feet
40,000 and up
\$21.40 per 1,000 cubic feet

- 2. The surcharge provided for hereinabove shall be billed quarterly together with the water consumption for 2018 based upon the water consumption rates set forth in Section 328-23 of the "Code of the Borough of Highland Park, 2010".
- 3. If the collection of the aforementioned surcharges during 2018 offset the deficit that was incurred during the year 2017 for water consumption prior to the last quarterly billing, the Borough shall have the authority to cancel or adjust downward the final quarterly billing of the surcharge.
