A Regular Meeting of the Highland Park Mayor and Council was held in Borough Hall, 221 South 5th Avenue, on Tuesday, August 14, 2018 and was called to order by Mayor Brill Mittler at 7:09 PM. Mayor Brill Mittler read the Open Public Meetings Statement.

Mayor Brill Mittler welcomed Matthew Hale as the newest Council Member. He will be the chair of the Health and Human Services Committee of Council.

On motion made by Councilman Fine, seconded by Councilwoman Kim-Chohan, the minutes of the Regular and Conference Meetings held on March 20, 2018, and April 3, 2018, the Budget Workshop Meetings held on March 13, 2018 and March 27, 2018, and the Special Meetings held April 10, 2018, April 24, 2018 and July 17, 2018, were approved as distributed by the following roll call vote, to wit:

Mayor Brill Mittler asked the Council members to present their reports.

Councilwoman Foster-Dublin noted that the National Night Out event was a huge success. She thanked the Police Department the other Public Safety agencies and all the groups and organizations that participated. The Teen Center grand opening will be September 12, 2018 at 3:00 PM and it will be known as the "Zone 6 Youth Center". The building is located on the corner of South 6th Avenue and Benner Street.

Councilman Fine - No report.

Councilwoman Kim-Chohan reported that the Arts Commission held their 2nd annual Chalk Arts Festival at the National Night Out event. The event was successful and she thanked all of the sponsors. The proceeds raised from the festival benefits the Middlesex County Adult Substance Abuse Program. The Arts Commission is also working on their Window Art Walk and a Digital Art Walk to go along with it. They are also going to be participating in Arts in the Park. Open Studios this year will take place on October 14th and they are looking to do a Social Justice Performance Concert with the theme, "many voices, one town" to try and bring the different communities together and the date is set for November 3rd. There are vacancies on the Arts Commission and Allison Baldwin and Maggie Dominic are filling out their volunteer applications so that they can be appointed. They have been attending the meetings as guests and helping out. The Recreation Department summer camp program has been ongoing and is in the final week. All of the participants have had a great time and you should be on the lookout for a newsletter that can also be found at the highlandparknjrecreation/Facebook page. Currently, they are taking registrations for youth fall soccer and flag football. The youth and teen programs and the adult programs will begin fall registration next week. Check the website and the Recreation Department Facebook page for upcoming programs. She reminded residents to yield to pedestrians around town. She witnessed a cyclist hit on River Road and Cedar Lane. Slow down and enjoy your summer.

Councilwoman Welkovits reported that tonight the Council is passing a resolution to apply for a second Safe Routes to School grant. The Safe Walking and Cycling Committee has been collecting data for the past few years. She gave special thanks to Denise Nickel and Jan Verstraete for helping to document this work. If they are successful with this Phase II grant, it would afford Highland Park to continue to improve our walkways and crossings, mostly for pedestrians, throughout the entire Borough. The next meeting for SWACC is Wednesday, September 12th at 7:00 p.m. in the senior center. There is a lot of stuff going on through the Main Street organization. The information can be seen at www.mainstreethp.org. Thursday nights throughout the month of August they have Highland Park After Dark from 5:00 p.m. to 9:00 p.m. Certain stores are offering special offers and discounts. On Friday evenings, from 7:00 p.m. to 10:00 p.m., they have Music on the Corners, North 4th Avenue and Raritan Avenue. Also on Fridays is the famous Farmer's Market from 11:00 a.m. to 5:30 p.m. On Saturday evenings, they have the Outdoor Movie Theater at the public parking lot next to the Main Street building. On August 18th, they will show Isle of Dogs and on September 1st, Castle in the Sky. Save the date for the Arts in the Park event on September 16th. If you are an artist or a vendor, please contact the Main Street organization to participate. The Borough has not slowed down this summer on redevelopment. Tonight, they are approving on final reading two separate redevelopment amendment projects; one at 31 River Road and one at 130-134 Raritan Avenue. On River Road, they worked with the Screening Committee, the Council Redevelopment Entity, the Planning Board, the property owner, and the neighbors to achieve the plan that is in front of them. They held several community meetings to work towards a common goal. On 130-134, they are amending the plan that was originally approved about 10 years ago. On both of these projects, we aimed to assure design characteristics for the neighborhood, to provide some room for the Planning Board to approve a forthcoming site plan which best meets our vision and goals, and to provide reasonable accommodations for fair share housing obligation. Neither of these plans are finalized at this point and they will be holding additional community meetings to go over some of the comments and concerns that the neighbors had. For 31 River Road, that will include whatever developer they bring to the table and for 130-134, they want to hear more from the residents about their comments and concerns.

Councilman Hale thanked all of his colleagues on the Council and the Mayor for welcoming him to the Council and for their help in navigating the early waters. He has been trying to meet with all of the people on the various commissions that are in his portfolio, Board of Health, Food Pantry, Housing Authority, HP Gives a Hoot, the Human Relations Commission, the Immigration Task Force and the Mayor's Wellness Task Force. There are some great volunteers out there and he is looking forward to working with them. On the immigration task force, there has been an executive order request that the task force came up with for the Council to pass. There is also a resolution that was passed around about immigration and refugee issues a while ago. He had a meeting earlier with the Mayor and the Borough Attorney that was quite productive on trying to weave those two documents into a really strong stance about Highland Park on immigration and refugee issues. He thinks they will be able to move fairly quickly on that going forward.

Councilman George reported that DPW is planning ahead for the Town wide Yard Sale on October 6th and 7th. There is always a bulk trash pickup after the Sale, but in past years there has been a problem getting bulk trash picked up while also trying to meet other deadlines. This year, since the week following the Sale is a short week because of Columbus Day, we are cancelling Recycling pickups for that week. Trash pickup will continue as normal – North Side, Business and Triangle pickup on Wednesday due to the Holiday, and South Side on Friday. This will allow maximum effort for bulk trash pickup to be accomplished in the same week. The creation of the Solar Field project is moving closer, the RFP for site remediation under the original limited cleanup plan is on the agenda for solicitation of bids. The original proposal has been revitalized through the assistance of the Murphy Administration and our Assemblywoman Nancy Pinkin. The Environmental Commission, along with Sustainable Highland Park, is looking into EV – electric vehicle – planning. We have received a request to pass a resolution supporting the State's EV initiatives including conversion of fleet vehicles to EV where appropriate, and the Borough has been meeting with stakeholders and exploring a plan to possibly electrify one or two Borough vehicles. The Meadows Trail crew is working on an observation platform in the Meadows, funded by a private donation. I visited the site on Sunday and you would not think you are even in Highland Park. It is peaceful and also an excellent place for birding. On Sunday, Meadows Trail volunteer Olivia led a group from the Reformed Church's Creation Care Structure and Earth Art group through the Meadows. The group is interested in creating art from found items in the Meadows recognizing the sacredness of nature and the impermanence of our existence, but also encouraging collaboration, cooperation and connection. SHP has proposed and spent a lot of time crafting an ordinance which would limit the use of single use plastic bags and eventually ban such bags. ordinance is under review, and has been referred to Economic Development for further consideration at this time. Several public hearings and meetings with all stakeholders are planned. SHP notes that a number of Borough businesses already do not use single use plastic bags, and have discontinued automatic distribution of plastic straws. STAC will be presenting its Emerald Ash Borer remediation plan at the next conference meeting. Middlesex County is considering whether to join in with us for its Donaldson Park remediation plan since the park obviously lies in the Borough - so far, Highland Park is the only municipality proposing to join with the County in this effort. We are hoping to be able to recycle the trees which have to be removed in place, rather than pay for removal and the very high disposal and tipping fees.

Borough Administrator Jover reported that the tax bills were sent out in the mail and that the deadline to pay taxes has been extended until August 30th.

Borough Attorney Schmierer - No report.

Mayor Brill Mittler reported that there is lots of good news for Highland Park senior artists. Middlesex County announced the winners of their 2018 Senior Art Competition on August 3rd, which was open to all residents who were at 60 years of age by that date. She is very proud to say that amongst the two categories, the first being professional winners, with 9 categories all together. Highland Park had 6 winners and 1 person with honorable mention. First place was given for drawing to Judith Rosenstein for her piece "Thou Shalt Not", and 2nd place in the same category went to Jon Marron, "Highland Park's Up and Over Around and Through". For the mixed media, Highland Park resident Bill Giaccalone got 2nd place. For oils, 1st place went to Shelley Phillips, who actually lives on the Edison side of the Highland Park border, but spends all of her time in Highland Park and has had exhibits at the library. For print, Highland Park's resident Marcia Shiffman got 1st place for "Dancer Six" and in sculpture 1st place went to Ellen Rebarber for "Blues in the Night" and honorable mention for mixed media went to Diane Reh for her piece "Do it Yourself". For the non-professional winners, there were 9 categories and Highland Park placed 1st in sculpture and the winning person was Josef Kogan for his "Adam and Eve Roots of Mankind" piece. Congratulations to all of Highland Park's senior artists who participated in this competition. You make the Borough proud.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

Robin Loewenstein, 116 South 4th Avenue, commented that she is the President of the Highland Park First Aid Squad. She is here tonight because she is personally insulted and outraged by something that happened on Friday, July 20th. Mayor Brill Mittler put out a letter and a Nixel to the residents of the town that was paramount to slander. The letter was to inform the residents of the new hours of the Highland Park First Aid Squad would be of service. She quoted "frankly, we got to this point after a series of safety and administrative concerns were discovered that I and the Borough Council felt could put our residents' safety at risk and required immediate action". If there were serious safety concerns, she asked why they were still allowed to answer calls at night. If there were serious safety concerns, why where they told that you weren't really planning to make the switch to RWJ so soon? The Highland Park First Aid Squad has not and never will be unsafe. The Mayor wrote "I am happy to inform you that an open, honest, and productive meeting was held last week between the leaders of the Highland Park First Aid, the Borough's Public Safety Committee and Borough Administrator". They had a very positive meeting, but their procedures on the ambulance and their patient care have had no changes whatsoever. They

willingly supplied the Council with all the information requested and none of it related to the safety of the residents. There has never been any information requested that the squad withheld. The only example the Mayor repeats is a meeting that a previous squad leader did not attend. If the current leadership is accountable for that, then I believe the Mayor should be accountable for the actions of previous Mayors, but, of course, she is not. The Mayor frequently says that she does not think of herself as a politician. After two months of asking about their funding, you said that month that it would be discussed at the meeting between the squad and the Council. Money was not part of that meeting and when they asked about it they were told that there is no money available to discuss. They are asking for the third month in a row about the plan for the oxygen that they normally provide the Police Officers based on their funding being cut. One of the discussions that they did have at a recent meeting with the Public Safety Committee was about the emergency operating plan for the Borough of Highland Park. The law requires that it be updated every year. This last copy that they received is from 2009. Thankfully, Councilwoman Foster-Dublin has indicated that plans will eventually be made to go back to tabletop drills and regular meetings of the Public Safety Committee with all the emergency departments. She noticed that nobody shut down Emergency Management or Public Safety. She demanded a public apology for her inaccurate statement about safety concerns with regard to the Highland Park First Aid Squad. This should be retracted via every source used to disseminate the original message and she is hoping that she will do the right thing. Mayor Brill Mittler thanked Robin for coming to express her concerns, but she wished she would have come to her to personally express those concerns before tonight. She in no way intended to mar their reputation and she is sorry if she did that. However, as you and I know and as the Public Safety Committee knows, there were some serious safety concerns. Those concerns were addressed in several of your meetings with the Public Safety Committee and she believes there is a plan for moving forward. She is happy with the agreement that was reached at the last meeting with the Public Safety Committee. They kept her well informed of everything that was going on and she looks forward to working with them going forward. She is sorry if she offended her in any way.

Bill, 107 South Adelaide Avenue, commented that he has a problem with people parking in his driveway and/or partially blocking his driveway. He would like some help in correcting this problem. Mayor Brill Mittler asked him to get that information to Lt. Abrams.

Karen, 242 South 6th Avenue, commented that she knows of two people who were so afraid for the ambulance because they would have to pay. She waited to call until the Highland Park First Aid Squad was on duty. She called again about her bill and she still has to pay. Lastly, she commented that everyone is so nice at the senior center and they always help.

Ammar Latif, 203 Jackson Avenue, commented that he is new to Highland Park and is part of the new community, The Crossings. It is a very nice town and they like it. He and his wife both work and they have 2 children. Mayor Brill Mittler noted that she is coming to meet with residents at that development on the 28th. Mr. Latif commented receiving a letter in the mail about increase in taxes. He has an average house, \$600,000 in value, 2400 sf, and he got an increase of \$850, making his taxes go above \$20,000. He sent a letter to the Mayor and the Council Members. This has an adverse effect on him personally because it affects his cash flow and it affects his property value. People looking at buying houses will question why they are paying \$20,000. These are outrageous taxes and he is surprised that there are no initiatives addressing tax increase. He contacted the Board of Education and Middlesex County about the tax increase. The Board of Education told him to expect the same tax increase next year. He asked what the Council is doing to make taxes more sustainable. He asked if the town set up fund to address the changes in the tax system that was delivered by the new administration, i.e. Charitable Funds. He asked what they are doing about revaluation of the town. When he called the County, Highland Park was one of the top 5 towns need a revaluation. Mayor Brill Mittler noted that every year goals are established. The number one goal is tax stabilization. Councilman Fine has been working with the Shared Services Commission. The Board of Education is a total separate body. The Borough shares custodial services with the Board of Education and they are talking with other municipalities about shared services. Things in government don't move quickly. Highland Park has no ratables, big corporations, to share in the tax burden. This burden falls on the residents. Their number two goal is downtown development/smart growth. More ratables with little or less impact on infrastructure. Councilwoman Welkovits added that the Borough has approved two redevelopment projects on the Avenue. One project is the Popov project on the corner of North 2nd Avenue and Raritan, with retail on the bottom and apartments on the 2nd floor. The other project is across the street. Councilman Fine commented that the charitable fund has been on their agenda. Trying to work with the State government who are coming out with new rules and regulations, but they are not out yet. The Mayor has created a subcommittee of himself and Councilman Hale to come back with a plan in October for shared services. Some of the areas they are looking into is Health Inspections and Animal Control. The State of New Jersey owes Highland Park \$7 million dollars in energy tax receipts. Tax stabilization is their number one priority. Mayor Brill Mittler noted that Highland Park is on the list for doing a revaluation in 2019. Borough Administrator Jover added that the Borough has to have updated tax maps to do the revaluation. Cost is approximately \$80,000 - \$90,000. Trying to get into County program, using GIS. Need cost estimates for a full revaluation and how to budget and pay for it. Need to have inspection of every home in town. Tax Assessor would like to see this happen.

Dee Donnelly, 242 South 6th Avenue, commented that on July 13th, she called 911 after 9:00 p.m. The squad responded and couldn't have been nicer. She was sick for over 9 hours, but waited to call. She brought up issue of bicyclists riding on the sidewalks. She has almost been hit a number of times. Mayor Brill Mittler asked Lt. Abrams to address this issue. Councilwoman Foster-Dublin announced the hours that the first aid squad is operating under. They are operating from 6:00 p.m. in the evening until 6:00 a.m. in the morning, Monday through Friday. On Saturday and Sunday, they are available full time.

Gabrielle Wilders, 24 Walter Avenue, she thanked the Planning Board and the Screening Committee for taking the time to meet with the neighbors and listen to their concerns. Her most recent concern based on the last Planning Board meeting was they decided to uncouple the parking. concern about that is it is great for people who move who have no car, but it is an incentive for people with a car to not pay for a parking space and park on the street. They were told that the traffic study would be conducted by the developer, which is strange, but apparently is a standard. Even without the new development, traffic is bad in that corridor, not just for cars, but for pedestrians. She would like to see a traffic/pedestrian walking study done regardless of redevelopment at 31 River Road. Borough Administrator Jover noted that it is very typical for the developer to present that study, but the Planning Board can hire a professional to evaluate their numbers. Councilman George noted that the applicant pays for the traffic study, which has to be done according to standards. It is reviewed by the municipality's experts as well and it has to be presented at a meeting. Councilwoman Foster-Dublin noted that the Public Safety Committee, along with the Police Department, have been looking at what they can do along with the NJDOT. They are looking at putting more traffic calming devices in that area. They are looking at an idea called, Block the Box, where all traffic would stop at one time and pedestrians would cross at one time. She and the Chief are looking at different mechanisms of how they can stop traffic and calm traffic at different times, but they have to work with the NJDOT to get that done. Councilman George added that one of the problems that they have had with River Road for years is that it is a County road. Mayor Brill Mittler noted that they have been talking for quite some time about a sidewalk extension like they did in Piscataway. Right now they want pedestrian and bicycle traffic to go along River Road through the park. Ms. Wilders commented that increasing traffic flow and pedestrian flow is a concern. She asked them to keep in mind when the developer comes, that smaller is better. They would like to see a building that is less than 4 stories. That is a small area for that big of a building. She appreciates all the time people have taken. She suggested that there be a redesign of the Borough's website. Mayor Brill Mittler noted that the website is a pet peeve of hers and they will be dedicating funding to the redesign in the 2019 budget. Ms. Wilders commented that communication has been a problem. Residents need to be notified in a timely manner. Borough Administrator Jover noted that they had hoped to do the website this year. They are reorganizing the information on the website to make things easier to find. Ms. Wilders asked what the next step is for 31 River Road. Borough Administrator Jover noted that they need a developer to come forward and they will map out a process for notification to the residents.

No one else appearing to be heard, the Mayor closed the public discussion.

The Clerk reported advertising an ordinance entitled, ORDINANCE OF THE MUNICIPAL COUNCIL OF THE BOROUGH OF HIGHLAND PARK, COUNTY OF MIDDLESEX, NEW JERSEY, ADOPTING AN AMENDMENT TO THE HIGHLAND PARK DOWNTOWN REDEVELOPMENT PLAN RELATING TO PROPERTY COMMONLY KNOWN AS 130 AND 134 RARITAN AVE., PURSUANT TO THE LOCAL REDEVELOPMENT AND HOUSING LAW, N.J.S.A. 40A:12A-1 et seq., for consideration of passage on final reading by title and that affidavits of publication thereto are on file. She also reported that the ordinance had been posted and made available for public inspection as required by law.

On motion made by Councilwoman Welkovits, seconded by Councilman George and carried by unanimous affirmative voice vote, the above entitled ordinance was taken up on final reading by title.

Mayor Brill Mittler declared the public hearing on the ordinance open to all officials and persons present and called upon all those wishing to speak for or against the ordinance to do so.

Christy Lutz, 119 Park Place, commented that she is a neighbor of the proposed redevelopment area. She is concerned about what is going to happen and about the access road that goes down to the service center. The access road will be the main point of entry. There are a lot of young children on the street. Cars speed up and down the access road. Parking is another issue as there are homes without driveways. She is concerned about the overflow parking. Borough Administrator Jover explained that the amendment is to allow for a modified additional story, offsite parking and affordable housing. Her understanding is that the prior application had included that access road. That is envisioned in the concept plan, but there is no application in front of the Planning Board right now. This is an amendment to the Downtown Redevelopment Plan. Mayor Brill Mittler noted that the original plan was from 10 years ago. Borough Administrator Jover noted that the amendments approved tonight are provisions for an additional story set back from the road, 3 affordable housing units, offsite parking, and the access road will be limited to residences only. There will be retail on the 1st floor, with residences above. Employee parking for businesses will be offsite. Prior to a formal application, they will hold neighborhood meetings. Mayor Brill Mittler noted that they are voting on an amendment to the existing redevelopment plan. There is no development proposal yet.

No one else appearing to be heard and no objections having been received in writing, the Mayor closed the public hearing.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

Ruth Bickhardt, 307 Magnolia Street, commented about bulk pickup. People are moving, new people are moving in and they are leaving furniture on the sidewalks. When the Borough comes to collect the bulk trash, they seem not to be picking up all items. Councilman George noted that they schedule bulk pickups on certain days, generally Wednesdays. Part of the problem is that when people are moving out they don't necessarily move the same day bulk trash is collected. A lot of the material that is left is sometimes not removable to the disposal site. They have to pick up some of the items separately. Ms. Bickhardt commented that she does not think the average resident knows about the different pickups. Councilman George noted that there is an app, Recycle Coach, that has been available for 18 months. You can look up over 700 items to determine if they are recyclable. Information is also posted on the website. There is an item on the agenda to change to the Middlesex County Improvement Authority for some of their recycling at a better rate. Ms. Bickhardt commented about the broken sidewalks around town that she has complained about for years and has reported to the Borough. Councilwoman Welkovits noted that any sidewalk complaints can be reported until Code Enforcement. They are going out for another Safe Routes to School Grant which should bring in some more money to repair borough owned sidewalks. If sidewalks are in disrepair, Code Enforcement Officials can be sent out to do an inspection. Ms. Bickhardt asked about water line repairs. She has been a victim of this twice. She asked why a homeowner has to repair a water line when the breakage is on the street. Borough Administrator Jover noted that maybe the break had occurred on the lateral, which connects the water main to the house. If the break occurs on the lateral, it is the homeowner's responsibility, similarly for the sewer line. They often have to dig up part of the road to address the lateral component. Councilman George added that the Borough or the water utility supplies the mains that go down the street. As a homeowner, you subscribe to that service for a hookup from the water meter inside the house to the water main in the street.

Abby Stern Cardinale, Harper Street, commented that she would like to raise a question that she had for a while, but out of concern of being polite and not causing more anger from the first aid squad, so she has not done so, but she does think this is a valid question to get answers to. We have been hearing for months about issues with the first aid squad having to do with leadership, response times and safety concerns that contributed to the decision to change to using RWJ in Highland Park. Earlier tonight, the representative from the first aid squad stated that if there were safety concerns about the first aid squad then why would they be allowed to operate during the night and weekends. She is assuming that the safety concerns go beyond response times based on what has been heard at various meetings. She understands that there are financial concerns for residents of Highland Park and she does truly feel for

anyone with those concerns, but she feels that safety is the top consideration that should be taken into account. She asked if there are safety concerns about the first aid squad, why are they being allowed to operate during nights and weekends. As a resident, she would like to know what those safety concerns are, if you can elaborate, and provide insight into whether these safety concerns are still existing and what the issue was mentioned earlier. Mayor Brill Mittler noted that the Mayor and Borough Council met and addressed some of the issues they had concerns with and put in place some guidelines for them to be able to check up on certain of those issues. Once there was an agreement reached at the alluded to Public Safety Committee Meeting, when the first aid squad agreed to give them the information they needed and to make some corrections the items they felt were hazardous, then the Council agreed that they could operate during the evening hours and weekends, because they had enough people to cover it and because the Council was going to be able to get some feedback and the Council felt that things were put back in order. Ms. Stern Cardinale asked if things are going to be checked on a regular basis. Her concern is the safety of her family and other residents. Mayor Brill Mittler noted that the agreement was to meet on a quarterly basis to make sure the things they had asked for were being done and that everyone was happy with how things were proceeding. Ms. Stern Cardinale commented that she hoped that if there are still concerns, the push back they received doesn't stop them from considering safety is the top priority. She appreciates that safety is being taken into account and if that is still an issue, she thinks they need to consider daytime coverage. Mayor Brill Mittler commented that she would never have started all this commotion had they not been concerned with some of the safety issues. She clarified that they have not made any final agreement with RWJ. The Borough will be discussing in conference the next best steps and whether or not to move forward with an RFP.

No one else appearing to be heard, the Mayor closed the public discussion.
