A Regular Meeting of the Highland Park Mayor and Council was held in Borough Hall, 221 South 5th Avenue, on Tuesday, January 16, 2018 and was called to order by Council President George at 7:04 PM. Council President George read the Open Public Meetings Statement.

Present: Councilpersons Fine, Foster-Dublin, George, Hersh, Kim-Chohan, Welkovits; Borough Attorney Tauriello; Borough Administrator Jover; Borough Clerk Hullings.

Attorney raunello, bolough Aumillistrator Jover, bolough Clerk Hullings.

Absent: Mayor Brill Mittler; Councilwoman Foster-Dublin; Borough Attorney Schmierer.

Council President George asked the Council members to present their reports.

Councilwoman Kim reported that the Arts Commission is working on workshops for the next four months of 2018. They will offer the book arts workshop again. Last time it was filled to capacity and they had to turn residents away. They will offer an acting workshop, glass art workshop, comic book workshop for the little ones, and Japanese finger painting for the preschoolers. There may be a collaboration with the food pantry in the near future. She attended the windows of understanding exhibit reception in New Brunswick prior to tonight's meeting. There are six venues in Highland Park and twelve venues in New Brunswick that have art lining their windows with the theme "We See through Hate". This is similar to the window art crawl that they do in Highland Park in the summer. This is a collaboration with the Mason Gross School of Arts and the City of New Brunswick. There are ten artists involved in and around Highland Park, five non-profits and six stores in New Brunswick. Residents can check it out at home through a digital tour at www.artwalkhp.com. The seniors and members of the community enjoyed an afternoon of music today. The first senior luncheon for 2018 will be held on January 23rd and there will be a special Chinese culture presentation. Yesterday, in celebration of Martin Luther King day, prior to the Human Relations Commission event, she attended the Governor's Day of Action at the Veteran's Home in Edison, where she was able to share some laughs and conversation with the veterans. It was a very rewarding experience.

Councilwoman Welkovits thanked the community for providing many opportunities for her and her family to serve and participate on Martin Luther King Day. In these times, she can think of no more appropriate recipient of the MLK Humanitarian award than Harry Pangemanan. The Human Relations team, under Ashton Burrell, put together the most moving program last night. She thanked the Committee, Councilman Hersh, the incredible dancer, Jordan Jackson, poet and educator Alyea Pierce, Lucinda Holt of HPPOSOC and Pastor Seth Kaper-Dale and his introduction of Mr. Pangemanan. She thanked Mr. Pangemanan for his tremendous community work and his family for their support. She also thanked the team at Bartle School, Principal Benjamin, Ms. Crane, Ms. Kirk, Ms. McLean and the other teachers and staff on hand as they volunteered for a day of service to help clean-up, organize, prep and paint the Bartle School. Last fall, Highland Park's Safe Walking and Cycling Committee (SWACC) submitted an application for the New Jersey Department of Transportation's (NJDOT) Local Bicycle/Pedestrian Planning Assistance Program. Under this program, NJDOT has retained the services of several consultants with expertise in local bicycle and pedestrian planning. The services of these consultants are provided at no cost to municipalities that demonstrate a need and desire to undertake planning activities that will lead to capital improvements to benefit the non-motorized transportation modes. She is delighted to announce that Highland Park's application has been accepted into the program and WSP, one of the nation's leading engineering and professional services firms, has been named as Highland Park's consultant to create a comprehensive bicycle and pedestrian plan for the Borough. The goal of the plan is to promote walking and bicycling as a preferred mode of transportation for residents and visitors by enhancing the community. The plan will build upon the already extensive work being done by the Borough's Boards and Commissions to make Highland Park an even better place to work and live. The plan will be consistent with the Borough's Complete Streets Policy and may become the bicycling and pedestrian foundation of the master plan. When completed, the plan will provide a comprehensive approach to identify priority improvements for creating, enhancing and expanding walking and bicycling opportunities for people of all ages. She thanked Trish Sanchez and Sean Meehan for taking the lead on this important opportunity. She thanked Borough Administrator Teri Jover for helping to finalize and submit the application and for the future coordination of this project as they navigate through the many steps to come. She also announced that a bill, which she and the SWACC Committee have been actively advocating for, was signed into law by the Governor yesterday. The las requires driver education courses and the driver's license written exam to include pedestrian and bicycling safety information. No driver, cyclist or pedestrian wants to be in a collision. Yet, New Jersey is presently reaching an all-time high in cycling fatalities. Bicycle death rates greatly exceed total road fatalities nationally and statewide. Historically, bicycle fatalities steadily fell nearly 40 percent off the 1975 record by 2010, but rose nearly 32 percent by 2015. Up until yesterday, New Jersey had some of the weakest protections for pedestrians and bicyclists. Teaching new drivers these rules of the road will help everyone improve the safety of our roadways. As Chair of the Economic Development Committee, her interest also concerns the smart growth and develo0pment within the community. She encourages walking and cycling as valid alternatives to commuting for work and running local errands. Highland Park is the lead municipal partner to Rutgers KnightCycle bikehsare, scheduled to begin in the next year. More cyclists and pedestrians mean less cares and less road traffic, making roadways safer. She personally thanked State Senator Patrick Diegnan, for co-sponsoring the senate bill, getting it out of committee, unanimously, getting it to the senate floor, and bringing the bill the attention to deserved. She thanked the Senator for the long-term effects of safer streets and roadways for all, and for saving

Councilman Hersh reported that Highland Park resident Harry Pangemanan received the 2018 Dr. Martin Luther King Jr. Award from the Highland Park Human Relations Commission last night at the High School. The annual event recognizes an individual who has shown exemplary leadership and service to the community. Pangemanan, an immigrant from Indonesia, who escaped from the violence aimed at Chinese Christians in the 1990's was honored for his extensive work on behalf of Indonesian Immigrants and others in need of assistance. He thanked Ashton Burrell and the Human Relations

Commission for sponsoring this program. The Borough needs to seize every opportunity to protect our residents. We do that through service to our community. We do that through advocacy and activism. We do that through a commitment to the belief that there is no door that shuts out our neighbors and we do that by making sure we operate always through a lens of equity. We have no choice. As Harry says, it's not about one life, but about the entire community.

Councilman Hersh officially presented Mr. Pangemanan with the MLK plaque.

Councilman Hersh continued his report by noting that the Commission on Immigrant and Refugee Affairs will host its first meeting of 2018 on Tuesday, February 13, 2018 in the lower level conference room in Borough Hall. The Food Pantry is busy this month and you'll be happy to know that they have exhausted all of the reusable bags from Sustainable Highland Park's reusable bags program. They are going to reach out to Sustainable Highland Park to get a fresh supply. The Food Pantry clients are bringing these bags to food distributions, which is great, great news. Kudos to Food Pantry Commissioner Bruce Bush for his extensive time and dedication to getting the 2018 sign in sheets and other client records set for the new year. The Middlesex County Food Organization and Outreach Distribution Services (MCFOODS) and the Community Bank of New Jersey will resume food distribution starting tomorrow so they will start again to get more of a variety of fresh food for our clients. The Highland Park Housing Authority reorganized at its January 10th meeting, selecting Commissioners Steve Chudnick and Raysa Martinez to serve as Chair and Vice Chair. Both are immensely qualified as they undertake financing for capital improvements as well as general stewardship of Highland Park's public housing stock. He congratulated both of them and thanked all of the members of the Housing Authority for taking on this awesome responsibility. He asked residents to mark their calendars for the next Highland Park Human Relations Commission Book Club where they'll discuss a very important book, White Rage, by historian Carol Anderson. This text examines the obstacles that stand in the way of black progress in America. The event will take place on Thursday, March 29th at 7:00 PM at the Highland Park Senior/Youth Center.

Councilman Fine – No report.

Borough Administrator Jover – No report.

Borough Attorney Tauriello - No report.

Council President George reported that the Department of Public Works is ready for the snow tonight, which could be nothing or a lot. The crews have been out brining since this morning. With the weather moderating to some extent, PSE&G has been attending to more gas lines, so be patient if the street is blocked. The bag reduction program continues. Over 1,000 bags have been given out, paid for in part by Stop & Shop and the original grant funding. The Earth Day program has been set for Sunday, April 22nd at the Eugene Young Environmental Center, and the sign up information for any groups wishing to participate will be available on the Sustainable Highland Park and Borough Website shortly. Sustainable Highland Park is also doing some planning for goals for 2018 and long term goals. The next meeting is Wednesday, January 24th at 8:00 at the environmental center. A resolution opposing the NJDEP regulations for beekeeping is on tonight's agenda. This resolution was requested by the Environmental Commission because the proposed regulations effectively ban beekeeping by residential, small scale and urban beekeepers, and impose requirements for those beekeepers who were operating prior to 2015 as well. Meadows trail work has stopped for the winter. It will start back up in March. As always, volunteers are needed and appreciated, and the material for the work is grant funded. would not necessarily think that outdoor work in the woods and along the waterfront could occur in Highland Park, but having worked with these dedicated individuals, I can tell you the work is fun, a bit hard, and really gives a different slant on what we have going for us in town.

WHEREAS, the New Jersey Department of Agriculture has promulgated new beekeeping rules designated as PRN 2017-216 in the New Jersey Register which are now open to public comment, which comments must be submitted by January 19, 2018; and,

WHEREAS, the delegates to the 102nd State Agricultural Convention, assembled in Atlantic City, New Jersey, on February 8-9, 2017, adopted Resolution #21, which found that:

honeybees are vital components of New Jersey agriculture; and

honeybees forage over airsheds measured in square miles, not acres; and,

New Jersey's beekeepers provide their pollination services to other commodity producers, and produce honey and hive products without the necessity for control of their own land base, unlike all other types of commercial agriculture; and,

the Right to Farm Act is intended to protect Commercial Farms engaged in generally accepted agricultural management practices from over-restrictive local regulation nuisance lawsuits; and, since 2006, there has been a tremendous increase in public awareness of the extreme honeybee colony losses routinely suffered by beekeepers around the country, and of the threat that the loss of honeybees and other pollinators poses to our food supply and quality of life; and, increased public awareness has resulted in a corresponding increase in the numbers of beekeepers in New Jersey, who now number in the thousands; and,

many of the state's increasing number of beekeepers are non-commercial or do not operate on a scale or in a location that could make them eligible for exemptions from local regulation of beekeeping practices under the Right to Farm Act; and,

WHEREAS, the proposed regulations include Apiary Standards which prohibit new beekeeper hives on residential lots of less than one quarter (1/4/) acre which were not in existence as of July 31, 2015; and,

WHEREAS, the proposed regulations provide that beekeepers may seek a waiver to keep no more than two (2) hives on a residential lot of one quarter (1/4) acre to less than five (5) acres, which waiver requirements may be used to ban existing non-commercial beekeeping; and,

WHEREAS, the proposed regulations require hives to be located at least ten (10) feet from any property line, twenty-five (25) fee from any roadway, sidewalk or path, eighty-five (85) feet from any public place, and mandate a Flyway Barrier of six (6) feet or more and extending more at least ten (10) feet beyond the colony in all directions; and,

WHEREAS, these proposed regulations were developed in spirit and practice without reference or input from the State's beekeeper organizations and contrary to the findings of the State Agricultural Convention in Resolution # 21; and,

WHEREAS, the proposed regulations effectively prohibit beekeeping on all but commercial properties and needlessly add restrictive regulations which are contrary to good Apiary practice, injurious to native plants which require pollination, and ban residential and hobbyist beekeeping:

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Highland Park that the Borough of Highland Park opposes the adoption of the proposed regulations prescribing new rules for commercial and non-commercial beekeeping in New Jersey as contrary to good Apiary practice, without basis in current best beekeeping practices, and excessively restrictive to small and hobbyist beekeepers, and urges the New Jersey Department of Agriculture to recall the regulations and establish a joint review commission composed of commercial and non-commercial beekeepers, representatives of New Jersey beekeeping organizations, scientists and representatives of the New Jersey Department of Agriculture to propose appropriate regulations for beekeeping in New Jersey.
