A Regular Meeting of the Highland Park Mayor and Council was held in Borough Hall, 221 South 5th Avenue, on Tuesday, September 4, 2018 and was called to order by Mayor Brill Mittler at 7:08 PM. Mayor Brill Mittler read the Open Public Meetings Statement.

Mayor Brill Mittler did a ceremonial swearing-in of newest Council Member Matthew Hale.

Nicole Huff, Senior Outreach Coordinator presented the services she offers as the Borough's Outreach Coordinator at the Senior/Youth Center. Ms. Huff;s services included applying for benefits with the State, housings, food stamps, Medicare, Medicaid, supplemental social security, and the food pantry services. Her services are for all Highland Park resident, and she is available fulltime, Monday-Friday; make an appointment so she can give you her undivided attention. Ms. Huff can be reached at 732-819-0052 and is located 220 South 6th Avenue. Service all of Highland Park residents.

Mayor Brill Mittler asked the Council members to present their reports.

Councilman Hale reminded everyone that September is Hunger Action Month; the food pantry has been collaborating with the Middlesex County Food Bank about raising issues about hunger awareness. One in Seven Americans and almost 80,000 people in Middlesex County are food insecure. The food pantry has a calendar of events for September Hunger Awareness Month, #HungerActionMonth. The Mayor's Wellness Campaign is in need of volunteers, the Board of Health has a couple alternate openings as well if interested please complete the volunteer application and submit to the Clerk's Office.

Councilwoman Welkovits reported that Main Street Highland Park had a lot going on, Friday Farmer's Market active throughout Fall; Outdoor Movie Theater, Castle In The Sky has been rescheduled to Friday, September 14, 2018 @ 8 PM at the Municipal Parking Lot and thanked Brian Onkin for organizing and presenting the Outdoor Movie Program. This is the last chance to sign up to be a vendor or artist for the Arts in the Park event scheduled for Sunday, September 16, 2018, register at MainStreetHighlandPark@gmail.com. The town wide garage sale is scheduled for October 6-7, 2018, register at hpgaragesale@gmail.com to get your home listed. She said that the Borough has been very active with redevelopment this past year, and on the agenda tonight is 31 River Road and the vote is to send this to the Planning Board to have them take a look at re-designating this property as an area in need of redevelopment, there is a developer that is interested in a project. The Borough Council is introducing an Ordinance to require inspections and the issuance of certificates of continued occupancy for multi-dwelling and apartment buildings at the time of sale. The State usually inspects these multi-dwelling units, they are supposed to be done every five years, they have fallen behind, and we feel if we inspect them at the sale of one of these large complexes we can ensure that the properties are safe for the new residents.

Councilwoman Foster-Dublin reported that on September 12, 2018 @ 3PM would be the grand opening for the long awaited Zone 6 Youth Center on South 6th Avenue. There are young people painting their murals inside the center, they have many ideas to improve the center and a lot of good energy around the project and they are anxiously awaiting the center open. She invited all to attend the grand opening anytime between 3-6 pm on September 12, 2018. On August 31, 2018 at the HP Owl football game Officer Sean Bibby was honored by the New Brunswick/Highland Park VFW for his years of service in the US Navy. Highland Park Police Department is seeking a new police officer, if interested you must have completed the basic courses of police officer by the State of New Jersey as well as having basic training in place and accredited by the New Jersey Police Academy. Applications are available at the Police Department, 222 South 5th Avenue or call the police department for more information. The last day to apply Sunday, September 16, 2018. As the children are going back to school this week, be extra careful when driving throughout the town, be cautious of children and seniors crossing the street, also she asked that everyone please utilize the sidewalks, it is going to start getting dark earlier, people are wearing dark colored clothing walking in the streets and we do not want to see anyone get hit by a car. The Borough is seeking volunteers for our warming center, in the event there is horrific weather we will need volunteers to serve in the warming center at the Senior/Youth Center, applications are available on the Borough's web-site, hpboro.com. A number of e-mails have been received regarding the deer population problem, the Borough has been in touch with Fish, Game and Wildlife, and we are in the process of scheduling a town-wide meeting with them.

Councilman Fine said at the last Council meeting he mentioned that the Borough might be looking into establishing a charitable fund for property taxes, the new federal tax law prevents taxpayers from deducting more then \$10,000 of personal sales and property taxes, in May the New Jersey Legislature attempted a work around on this by passing legislation allowing taxpayers to contribute to certain state sponsored charitable funds and return get a credit against their state income taxes or local property tax. Specifically the legislation passed in May authorized local taxing jurisdiction to create charitable funds and grant property tax credits equal to 90% of voluntary contribution to such funds. In August the IRS issued proposed regulations that won't permit the work around, the IRS said it would consider payments of property taxes to local charitable funds to be of quid pro quo nature and for payments to be considered a charitable contribution the taxpayer cannot receive any benefit in return. At this time, the Borough's Finance Committee will not be pursuing a plan to set up a charitable fund for property taxes.

Councilwoman Welkovits mentioned that the Highland Park Window Art Walk is scheduled for Saturday, September 15, 2018 from 4-7 pm; the work is up now through September 30. The Highland Park Arts Committee sponsors this event.

Councilman Hale said with respect to Councilman Fine's report, the IRS regulation and ruling would prevent New Jersey from using the work around. He said that there would likely be multiple lawsuits that will challenge the IRS ruling about whether or not municipalities could do those work arounds.

Council President George said that with regard to the veterans, he would like to extend a remembrance for Senator McCain who passed away late last week, he was active an active advocate for veterans having been shot down in Vietnam. He noted that the garbage and recycling schedule is going to change for the week of October 9 because Monday is Columbus Day and the Saturday and Sunday before that are the town-wide yard sale, and in the past it has difficult doing the pick-ups, since recyclables do not biodegrade like garbage, recycling will be suspended for that week, trash pick-up will continue on a regular schedule, Tuesday Northside, Triangle and the Business District because Monday is a holiday, and Friday on the Southside, Wednesday and Thursday will be town-wide pick-up. The Environmental Commission is meeting tomorrow night at 8PM at the Environmental Center, they will discussing 2109 agenda as well as updates on existing projects. Shade Tree meets next Wednesday at 7 PM and will be presenting the Emerald Ash problem so we can get that to the County and get it moving. Sustainable Highland Park is meeting on September 26 @ 7:30 PM in the Environmental Center working on phase 2 of removal of plastic from the retail stream. The Native Plant reserve volunteers who work under Shade Tree have applied for a grant, which is on the consent agenda. The grant is sponsor through the College of New Jersey and Sustainable New Jersey and it grants you volunteers as opposed to money it puts boots on the ground and three of the projects they are recommending are improvements to the Meadow Trail, and Environmental Center area. There are many bond issues on the agenda tonight, this was talked about last meeting, with regard to the water meters and valves, hydrants are bonds that are related to the application for low or zero cost long term financing from the Infrastructure Bank. In order to move through Phase 2 we have to show that the Borough is able to finance these projects. At the Art Walk one group will be meeting at 4 pm at Garden Party and the other at Tiger Arts, you can walk to streets, meet the artist, and get the narrative and encouraged everyone to join. He congratulated Councilwoman Foster-Dublin on the opening of Zone 6; this has been a long time goal and looks forward to the opening on the 12th.

Borough Administrator Jover reminded everyone that Borough hall has resumed regular hours today, Monday, Wednesday, Thursday 8AM-4PM, Tuesday 8AM-6PM, and Friday 8AM-1PM. There is an open position for Assistant to the Borough Administrator and encouraged people to make application on the Borough's web site.

Borough Attorney Schmierer - No report.

Mayor Brill Mittler reported that Labor Day was first established in the 1800's in an effort to bring all of the unions together in a common cause and ensure the safety of their workers. We have came a long way over the centuries but must stay diligent and remember to take care of all of the workers that we have in Highland Park and all over the country and ensure they have safe working conditions. Everyone took a moment of silence to remember the late Senator McCann. We wished everyone who celebrates Rosh Hashanah, and following Yom Kippur a peaceful and meaningful holiday.

Mayor Brill Mittler opened the meeting for public discussion and called upon all those wishing to speak to identify themselves.

Herb Gross, Adelaide Gardens, asked everyone present and everyone watching television to join him in a moment of silence for the late Senator John McCann. Very recently, he attended a meeting and there were hundreds of veterans, he met veterans from all over the country to listen to the late Senator John McCann. At the meeting, there were many United States Senators from both sides of the aisle and a lot were United States Veterans and they came to listen to Senator McCann and what his platform was to be on veteran affairs. We have lost one of the greatest men in the Senate, well respected and when Senator McCann finished speaking he left the stage with three words: God Bless America and don't you every forget that ladies and gentlemen.
